HOUNDING LEGISLATION

It's hardly the dog days for state legislatures across the country -- it's actually around mid-term for many of them. But it is already becoming clear which new dog-related bills are most likely to become law. Although political sages say no bill is ever really dead, some proposals are clearly on life support or in a coma. Here's a wrap-up of legislative proposals pending in statehouses and in Congress that will have an impact on you, your pets and pets to come.

U.S. CONGRESS

House resolution 594: "The Pet Safety and Protection Act of 1997." There is still little progress on this proposal that is designed to help exterminate what some believe are the middlemen or "fences" who deal stolen pets (yes, right out of backyards) to medical research facilities for experimentation. The measure doesn't address the use of dogs and cats for animal research, but eliminates U.S. Department of Agriculture "Class B" dealers who are licensed by the department to sell "random source" animals to research facilities.

The proposal is strongly backed by the Los Angeles-based Last Chance for Animals (LCA), which has gained nationwide attention for its attempts to stop inhumane animal research. LCA contends that animals obtained by Class B dealers can come from practically any source and the system currently encourages pet theft. Under current law, dealers are required to document the source of the pet. But USDA officials stated that more than 52 percent of the reported sources by these licensees were fraudulent or nonexistent. Put simply, the USDA and research facilities can't say where these research "subjects" are coming from. The measure is still languishing in a House subcommittee; LCA is looking for a Senate sponsor to take up a companion bill in that chamber.

CALIFORNIA

Assembly bill 1879: This proposal, which is set for a committee hearing later this month, would roll back sections in state law that restrict licensure for preparing, processing, packing or importing meat products intended for pet food use.

Senate bill 621: The Judiciary Committee rejected this proposal that would have required dog breeders to obtain sales and use tax permits and submit to inspections. It also would expand coverage of the state's puppy warranty law -- that allows reimbursement from pet shops if the dog becomes ill -- to all breeders.

CONNECTICUT

House bill 5495: This wide-ranging proposal requires kennels in which more than a single litter of puppies are bred to have a state license. The measure would also require licensure for anyone importing dogs or cats into the state. In addition, it allows reimbursement by pet stores of up to \$200 in veterinarian fees if an animal purchased is sick. It also requires pet stores to post signs giving detailed information about the pets for sale. The proposal still seems to be in its formative stages but has sparked extraordinary debate in the statehouse with numerous organizations lining up for and against it. Some hope the bill will be toughened to help stamp out "puppy mills" and other say it will just encourage more "backyard breeders."

GEORGIA

House bill 1331: This proposal is still in a House committee and would remove Society for the Prevention of Cruelty to Animals, animal shelters and pet adoption groups from the state definition of "pet dealers." Unless this bill is approved, such groups will be subjected to the same laws as pet stores and breeders.

MISSISSIPPI

Senate bill 2222: Legislators have already nixed this lemon law that would have allowed for reimbursement of up to \$2,500 plus purchase price. It also would restrict pet stores from acquiring any dog or cat without an advance order from a customer.

Senate bill 2344: This bill laid out new requirements for animal control officers. They would have to take at least 40 hours of training in animal cruelty investigations, search and seizure and animal handling. It, too, was voted down.

TENNESSEE

House bill 3184 and Senate bill 3157: Both bills are sitting in committee and would establish a Class A misdemeanor offense for individuals who would "torture, maim or grossly overwork a non-stock animal," including pets. People failing to provide necessary care and shelter or confine "tether" or collar animals in a cruel manner would be in violation. Folks who were found to have custody of an abused animal but were found to be engaging in veterinary practice, providing medical care or "bona fide experimentation was being conducted for scientific research" would be exempt.

THREE-POINT PRESSURE

Dealing with a pooch that won't calm down? *Four Paws Five Directions* author Cheryl Schwartz recommends a three-point pressure procedure around your dog's head. Start with long strokes along the neck, gradually massage the ear flaps and then finish with the three-point hold. Where should you apply pressure? Apply very light pressure at just below the back of the head, in the indentations at the nape of the neck, midway between the spine and the base of the ear, as well as the point just in front of the bump on the top/midline of the head. This bump, known as the external occipital protuberance, is very prominent in some hounds. Hold for 10 to 15 seconds.

EXERCISE TIPS THAT CAN SAVE LIVES

If you exercise your pooch, make sure it's before meal time. Be careful not to feed your pooch before or immediately after a work out. It's also not a good idea to let your hound drink lots of water. Instead, let your pooch have a short drink before, during and after he or she is cooled down. This is particularly important if you have a deep chested dog such as a German Shepherd, Great Dane or St. Bernard. They are more prone to developing a twisted stomach, which can lead to a quick and painful death.
