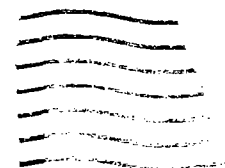

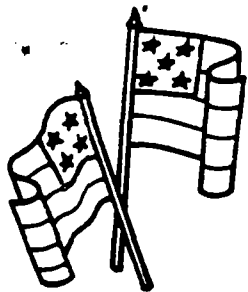

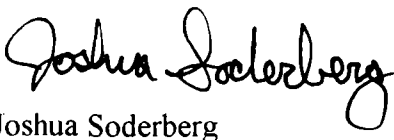
My government class is conducting a project in which we hope to hear from politicians from various levels of government. We are trying to gather materials that will help make our learning process educational, fun, and enjoyable.
