SUBJECT: YOUR RECEPTION FOR PRIME MINISTER GUTERRES OF PORTUGAL

The Office of Public Liaison coordinated with Ellen Ochs of your office to ensure that the Portuguese American community was informed of your hosting this reception and that representatives of this community were invited to attend.

In order to enhance the invitation list prepared by the State Department, the Office of Public Liaison reached out to Portuguese American organizations, civic leaders and local elected officials and representatives of the Portuguese American media. With the assistance of David Thomas of your office, Senate friends of the Portuguese American community and Congressional members who serve on the Portuguese American Caucus were invited as well as contacted to recommend constituents for invitation. There are 31 members of the Caucus, with co-chairs, Rep. Richard Pombo (R-CA) and Rep. Patrick Kennedy (D-RI).

Our outreach was focused on the areas of the country where Portuguese American communities are strong including Rhode Island, Connecticut, Massachusetts, New Jersey, New York, Florida and California (San Francisco and Los Angeles areas).

This reception is the second time during the Administration that Portuguese Americans have been acknowledged as a group. Portuguese Americans were invited to attend a reception hosted by the President in 1994 for then Prime Minister of Portugal Cavaco Silva. Portuguese American organizations and community leaders have been a part of our regular outreach over the past years.

The Portuguese American community is approximated at a little over one million people, close in size to the Greek American or Cuban American communities. Immigration from Portugal has been different from other European countries in that an unusually high proportion of all Portuguese immigrants arrived in this country after 1959. Therefore, the Portuguese American communities are still fairly strong, close knit and concentrated. The highest concentrations being Fall River and New Bedford, Massachusetts and Providence, Rhode Island. In addition, there is a high proportion of Portuguese Americans living in California.

As follow-up to this event, we are working with your office to ensure that local/regional media and the Portuguese American media receive a release, any appropriate remarks, and photographs.

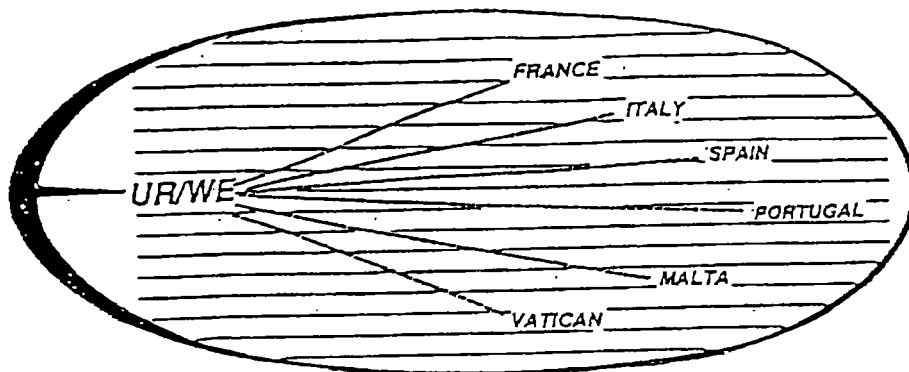

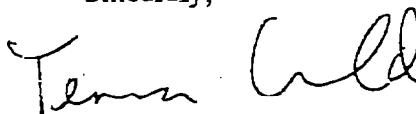

I. PURPOSE

To recognize the Portuguese-American community in conjunction with the visit of the Prime Minister of the Republic of Portugal.

II. BACKGROUND

The visit of the Prime Minister of Portugal provides a significant opportunity to outreach to Portuguese-Americans. This is the first time that the Portuguese-American community has been invited as a group to a White House reception. Over the past year and a half, leaders of the community have been invited to the White House for briefings on foreign affairs and domestic issues including the economy and health care reform.

The Portuguese-American community is approximately 1.15 million people, close in numbers to the Greek-American or Cuban-American communities. It is concentrated in areas of the country including California, Massachusetts, Rhode Island, New York, Pennsylvania and New Jersey.

Immigration from Portugal has been different from other European countries in that an unusually high proportion (39%) of all Portuguese immigrants between 1820 and 1980 arrived in this country after 1959. Therefore, the Portuguese-American communities are still fairly strong and concentrated. The highest concentrations being Fall River and New Bedford, Massachusetts and Providence, Rhode Island. In addition, the proportion of Portuguese-Americans living in California is far greater than that of any other ethnic group except the Armenians.

Those invited to attend include Portuguese-American business and community leaders, well-known individuals, religious leaders from both the Catholic and Jewish communities, as well as local community leaders from areas of the country where Portuguese-American communities are strong. Members of Congress from districts with significant Portuguese-American communities were invited to attend and bring key constituents. Due to the Congressional recess, many Members will not attend. However their guests will attend including constituents of Senators Moynihan, Bradley, Lautenberg, Lieberman, Dodd, Kennedy, John Kerry and Claiborne Pell, as well as Representatives Kennelly, Meehan, Frank and DeLauro.
