SUBJECT: Denver Hearing on National Forest Service Project

Inasmuch as the Commission will be in the West for its Black Hills meeting on August 30 and 31, Chairman Merriam has approved our taking advantage of this fact by holding a hearing on the National Forest Service Project in Denver on Saturday, August 28.

The NFS study relates to their revenue sharing or payment in lieu of taxes program on national forest lands, which are concentrated in the Western United States. Certain legislation now before the Congress would provide a single approach for determining Federal payments on a number of categories of Federal land, including the forest lands. Our study must take cognizance of all relevant Federal practices. The work schedule for this study anticipates that the Commission will be asked to act on recommendations next Spring. Hearing testimony from representatives of interested parties at this study midpoint will, we believe, be very beneficial to both ACIR members and the project staff.

The hearing is scheduled for 9:30 a.m. to 1:30 p.m. on Saturday, August 28, and will be held at the Stapleton Plaza Hotel near Stapleton Field in Denver. A list of persons invited to testify is attached.

ACIR members planning to attend the hearing will, with few exceptions, need to arrive in Denver by Friday night (August 27) and, in some cases, will prefer to stay in Denver for Saturday night (August 28), and to proceed on to Rapid City on Sunday (August 29). So as to make suitable hotel reservations in both locations, we will call you within a few days to ask all of the following questions:

- (1) Will you be attending the hearing and the ACIR meeting?
- (2) What family members will accompany you?
- (3) What type of room(s) do you desire?
- (4) For what dates do you desire a hotel reservation at the Stapleton Plaza Hotel in Denver?
- (5) For what dates do you desire reservations at the Howard Johnson's Motel in Rapid City?
