Dear Mr. Ford:

This confirms information given to a member of your staff on January 30, 1967, relative to the Joint Army-Navy-Air Force Publication (JANAP) 146 as related to Unidentified Flying Objects (UFOs).

The JANAP is not a UFO publication. It does deal with UFOs only as a catchall class of sightings that do not fall into a recognized category such as ships, submarines, aircraft, or guided missiles. This publication provides uniform instructions for the peacetime reporting of what is judged to be intelligence information vital to our National security. Its purpose is to emphasize the necessity for handling of such information within official channels only.

Sufficient quantities of the JANAP are not available to provide for unlimited distribution; therefore, we are not able to provide you with a copy. However, all Air Force bases maintain a copy in their reference libraries and we have no objection to personnel reading it at a library.

We hope this information will be helpful. If we can be of further assistance, please let us know.

Dear Honorable Sir

My name is Brook Beecher and I am an associate member of NICAP. As you will probably remember I wrote you last year via a ms page type written report that took an estimated 30 hours to cook up.

This is no correspondence letter nor one in criticism & I am only referring to the ADHOC committee by J. Mendel Rivers and conducted by the House Armed Services Committee last April 5, 1966.

Mr. Schweiker asked Major Quintanilla "how many UFO's are tracked on radar." The Project Bluebook chief answered "1.5 % Sir" when asked, he replied also that "we have no radar cases that are unexplained." How can Major Quintanilla turn around and call Capt Edward J. Ruppelt a liar. Capt Ruppelt who was project Bluebook chief from 1951-1953 confirmed many unexplainable incidents involving UFO's being tracked on radar, even over such areas as Long Beach, Calif and Washington DC. Nor is that the only one. After last April's hearing of which you called for, Dr. Joseph Allen Hynek chief scientific consultant to the Air Force project Bluebook spoke before 6000 people at NASA's Space Flight Center on Jan 6, 1967. He personally confirmed that NORAD and SAC radars have tracked UFO's and cited an example

that a Sac radar acquisition followed an erratic path of a UFO at 4,000 miles per hour. If you remain in doubt all of this is on file at N.I.C.A.P. in Washington, D.C.

The University of Colorado Study Group is I am glad being agnostic on the subject. I do not like the AF's handling of the situation as I advocated to you last May. Nor did I care for the 1 hour 20 minutes allowed time by the committee. The Air Force was the sole agency and therefore had the lone voice, why did they not allowed retired milita officers who had seen UFO's or had been associated with the project testify. I would geniously appreciate your answer on this. Also why is AF regulation 200-2 non available to the public. It seems to me that we who are concerned should get a more reasonable answer then what has been received previously.

I am no Saucer Bluff - nor do I stand on any conclusion or belief. I just Don't know - But I feel that I have reason to complain or at least ask what the circumstances involved are.

If you disagree, then please tell me why. I would appreciate any ~~letter~~ literature you could send me on UFO's that I hope to receive your return reply of which I'll wait anxiously for. Thank you

UFO Reported In Calumet County

CHILTON—Calumet County was visited by an unidentified flying object Tuesday about 9:05 p.m.

Norbert Zitzelberger, Hilbert, R. 2, a self-employed plumber, was driving to his home on Highway 114 when he saw a bright red glowing object in the sky. It was as wide as the highway, he said.

The object was moving from east to west. He described it as having blinking lights around it, dish-shaped and said the glow was like "a fluorescent or neon sign."

Zitzelberger arrived at his home and told his children about the object he had sighted.

The 16-year-old son and girls, aged 12 and 10, ran outdoors and saw the object coming back from the west. Meantime, their father was hurriedly loading his polaroid camera with film in order to take a picture.

He managed to get a picture before it disappeared to the northwest, although the object was far off by then.

"By the time I arrived home 10 minutes later, the children were almost petrified by the excitement of seeing the object," said Mrs. Zitzelberger today.

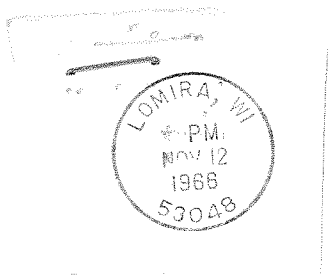

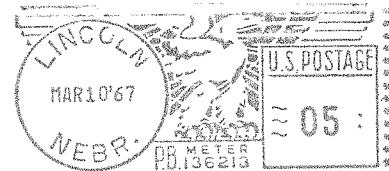
