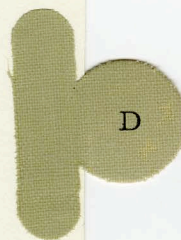

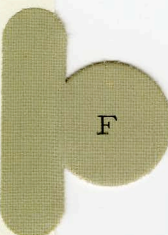

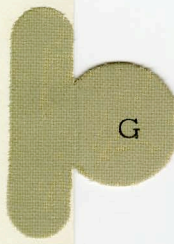

SUBJECT: Meeting on the Afternoon of July 6th

As you may know, the Smithsonian Institution has proposed legislation which would:

- Authorize establishment of Bicentennial Park;
- Authorize it (the Smithsonian) to negotiate with the Department of the Interior for joint use of federally-owned land at Fort Foote and Jones Point as sites for the museum park.

Mr. John Nicholas Brown, Chairman of the National Armed Forces Museum Advisory Board -- of which I am a member -- will be in town on July 6th and hopes to be able to meet with the 2-3 appropriate people here within the White House-OEOB complex to more thoroughly explain the proposal and to line up Administration and OMB support. It is a relatively simple matter, for no grand expenditures are involved.

I have spoken briefly to Bill Gifford about this and he can be available on the afternoon of the 6th. Therefore, I would like to suggest that the meeting be held in my office from 3:00 - 3:30 p.m. and that in addition to Bill Gifford and me, someone from your immediate staff attend. The attached correspondence may give you a better feel for the project ... which, you will note, already has the support of Hugh Scott.
