Let's follow up on the point that Malek made in his briefing the other day about the financing of rallies and Presidential events in the hinterlands. I want to make sure that we have it squared away as to what portion the 1701 or the field organization is going to pay vs. what we have in our budget. We should check back through Steve Bull as to what our budget figures are and make sure they are still adequate.

I believe that we have completely overestimated all of our expenditures since at the time the budget recommendations were prepared it was felt that we would do a great deal more campaigning than is now anticipated.
