Subject: PRIVATE BLANK CHECK

The decision not to proceed with some kind of public speech by the President MUST be revisited. The reluctance to challenge O'Neill's rejection is understood, but I am not sure that its implications are fully grasped. Whether the President makes this speech from the oval office, or the Senate chamber is irrelevant - the important thing is that it be heard by the American people. O'Neill's rejection is perfect hype to have Americans tune in no matter what time of day it is given. At the bottom line is the fact that the Democrats who want to vote with us on this issue NEED the political cover that this speech provides for them in their districts - but only if their constituents hear it. According to several of the Democrats who have been working with us on the issue, it is more than likely that if the President does NOT speak to the people on this, we will lose by a landslide because so many who have supported this will perceive that the President truly is not interested. The idea that we wd present this as a written message to the congress has been received with derision - even by our friends. Everyone engaged knows (and O'Neill obviously knows it best) that if the American people do not get to hear the message, the game is over. we cannot count on the sympathy factor playing to our advantage. A short while ago Dennis Thomas stuck his head into Buchanan's office and said "...the message will do just fine ... O'Neill's rejection is like kicking a cripple." Thomas' comment says it all - the President is a cripple - and will be widely seen as such domestically and internationally. The speech - in any forum which is televised, will make all the difference.
