# Navy Medical Officer Relieved of Job

NORFOLK, Sept. 14 (AP)—The Navy's top medical officer for three mid-Atlantic states has been relieved of his job and denied promotion to rear admiral after an investigation faulted his administration of two hospitals, the Navy said today.

At the recommendation of the secretary of the Navy and secretary of defense, President Reagan signed an order denying the promotion to Capt. Norman V. Cooley Jr., said Lt. j.g. Dennis Sawyer, a Navy spokesman in Washington.

It is the first time in recent memory that an Navy officer selected for admiral has been denied promotion by the president, Sawyer said.

Cooley, 56, a physician for more than 30 years and a naval officer for 23, had worn the two stars of a rear admiral since taking over the Mid-

Atlantic Regional Naval Medical Command in Portsmouth in July 1981. He was relieved of the job Sept. 2, Sawyer said.

Sawyer declined to discuss the case and said only that Cooley's administrative practice was "found to be less than fully satisfactory" following two investigations.

One probe involved Cooley's tour in Naples from 1977 to 1981 and the other the Portsmouth command.

Cooley had commanded a Navy hospital in Portsmouth and smaller clinics. The command was expanded this year to include Navy and Marine Corps medical facilities in Virginia and the Carolinas.

He was selected for promotion to rear admiral on July 1, 1981. Cooley was "frocked"—given the insignia and benefits but not the pay of his

new rank—until the promotion was made permanent.

Sawyer said Cooley was ordered "defrocked" after Reagan's order and told to return to the rank of captain. Cooley has asked to retire from the Navy Oct. 1. Cooley could not be reached for comment.

His promotion was to have become permanent by July 1, 1982, but it was delayed during the Naples investigation, said a Navy officer who declined to be identified.

That investigation concerned the death of a retired Navy man in the hospital's emergency room in November 1981. While Cooley was not held directly responsible, he was considered derelict in his role as hospital administrator and cited for doing a poor job looking into the death, a Norfolk newspaper said.

## Suit Against NIH Charges Harassment in AIDS Case

A Germantown couple, claiming they were harassed and humiliated at the National Institutes of Health, where the man was being treated for Acquired Immune Deficiency Syndrome, filed a \$2 million lawsuit yesterday in Montgomery County Circuit Court.

The plaintiffs, Ruth Ann Miller, an NIH employee, and William Lee, said in court papers that Miller's supervisors and fellow employees caused the couple "to experience physical, mental and emotional suffering and anguish as well as humiliation, embarrassment and damaged reputations."

The suit says Miller's supervisors,

all PhDs, told her in June to stop having lunch with Lee at work and not to bring him into the building without clearance.

Miller's supervisors also tried to get confidential information about Lee from his doctor, according to the suit. Lee was being treated in a clinic at the Bethesda-based NIH for AIDS, an institutes spokesman confirmed.

Spokesman Storm Whaley said he had not seen the suit and it "was not the kind of thing we would want to comment on."

Defendants included three employees in the research grant division. The suit asks for \$500,000 compensatory and \$500,000 punitive damages each for Miller and Lee.
