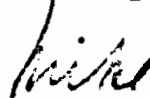

Dear Mr. Deaver,

We were particularly pleased to read in the New York Times, August 16, 1983 of a new working group on women's issues under your leadership. According to the Times, your group is considering larger tax credits for child care costs and increased tax deductions for individual retirement accounts for non-working women.

The Association of Junior Leagues has presented testimony on these and other aspects of S. 888, the Economic Equity Act; we believe that the Act contains many provisions which will help low-income women, and we hope that the administration will support this legislation. I am enclosing a copy of our testimony on the Economic Equity Act. Please see particularly pages 10 to 12 on the dependent care tax credit.

We understand that some components of this legislation represent potential tax losses, but in the case of the dependent care tax credit, we believe the tax loss will be repaid by enabling more women to work and making it possible for more elderly persons to remain in their homes.

We appreciate your interest and concern. If you have questions about our testimony or if we can be helpful, please let us know.

I will divide my letter into a formal and informal communication. First, let me preface my remarks by letting you know that during the last week I have attended the National Conference of State Legislatures and was elected as the ~~Republican co-chair of the Women's Network of NCSL~~. During this time I became aware that President Reagan has been invited to be the keynote speaker at the Center for American Women in Politics Conference in San Diego in early December. Over 990 women state legislators as well as women from national organizations and women from the private sector which underwrites this conference have been invited. ~~I write to encourage the President to accept this invitation.~~ By speaking before this group the President will be heard directly by hundreds of women, will bestow an honor on this gathering, and hopefully a powerful message would gain the support of the state legislators from across the political spectrum. Not to accept I believe will be viewed as an affront or even worse as evidence of the irrelevance of this gathering. Every effort is being made to make this conference non-partisan.

Second and less formally, I ~~offer some advice from a Republican woman who believes in working within the system.~~ Having sent telegrams, communicated ideas from the bottom up, attempted to gain access to prevent further erosion on the President's image on women's issues and received no response I, too, begin to question the leadership not only on this issue but even others. Specifically, my advice - before a speech is delivered the speaker should know his or her audience. For San Diego I believe it is of utmost importance that a group of women who know that audience suggest and offer issues, comments and review the speech. That group should be composed of women who KNOW the women legislators and the range of philosophies represented. ~~To have Betty Heitman send a simplistic letter of the number of women~~

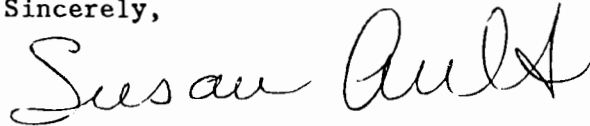

~~around.~~ To ignore the nature of the audience and the issues that
face that audience is to insure a disaster. (I might add that the
emissaries sent to conferences such as the NCSL might also keep that
in mind.)

Who am I to be saying all this. I am a lifelong Republican who
believes in the historical Republican principles, work in party
politics to raise money and to elect candidates. In 1981 the
National Republican Legislators Association presented me with an
award for one of ten outstanding Republican Legislators and a
citation from President Reagan. I care about this President and

As you will recall, the Department of Justice appeared in the trial court to defend the Federal determination to include these rivers in the National System. When the district court found several procedural deficiencies in the designation process and directed that the matter be returned to the Secretary of the Interior, the United States joined your organization and others in appealing that ruling. The subsequent motion to dismiss all appeals appears to be premised upon several legal and jurisprudential considerations which are set forth in the Memorandum to the United States filed in support of that motion.

The Court of Appeals has now denied the motion to dismiss, and the United States remains in the case as a full participant in the appeal. The Court's action also apparently removes any basis for speculation as to what action the State of California might take if the motion to dismiss the appeals had succeeded.

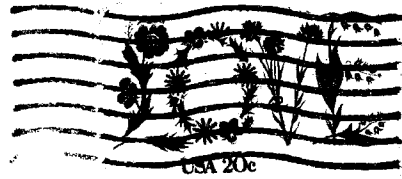
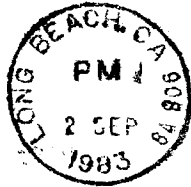
