It was a pleasure seeing you again and working with your staff during the Queen's visit to San Francisco last March. As you know, I was the Navy's local project officer for that portion of the visit. It was most enjoyable working with the Reagan Team again, after an absence of seven years !

I have been reassigned to Washington, and am serving as the Navy's Director of Community Relations, with direct responsibility for the scheduling of the Navy's Flight Demonstration Team (Blue Angels), all flyovers, ship launching and commissionings, and the Navy Bands. Biography - Commander Allen R. Sherwood, U.S. Navy

Commander Allen R. Sherwood, USN, was graduated from California State University, Chico, in 1965 and received his commission from Aviation Officer Candidate School, Pensacola, Florida in July, 1965.

Commander Sherwood served as the Assistant Officer-in-Charge of the Navy Landing Field, Kisarazu, Japan for his initial tour of duty. He next attended the Defense Information School, Ft. Benjamin Harrison, Indiana, followed by a tour as the Public Affairs Officer, Naval Air Station, Chase Field, Texas.

Commander Sherwood left active duty in 1970, and affiliated with the Ready Reserve. In his civilian career, he served as the Public Information Officer for the California Office of Emergency Services, and later was appointed by then-Governor Ronald Reagan as the Assistant Chief of Information Services for the State of California. In 1973 Commander Sherwood was appointed by Ronald Reagan to serve on his personal staff as Deputy Appointments Secretary, a position he held until 1975.

In 1975 Commander Sherwood returned to active duty in the Regular Navy and served as the Deputy Director of the Navy Office of Information, Los Angeles. His duties included liaison with the Hollywood motion picture industry and he served as a project officer and technical consultant on numerous motion pictures and feature films for television. In July, 1975, he served as the Apollo-Soyuz Spacecraft recovery Public Affairs Officer, embarked aboard USS NEW ORLEANS with CTF 130.

In 1977 CDR Sherwood was assigned as Assistant Public Affairs Officer for the U.S. Pacific Fleet, Pearl Harbor, HI, where he served until 1980. Following this tour, CDR Sherwood served as Area Coordinator for Public Affairs and Public Affairs Officer for Commander, Naval Base San Francisco. His duties included establishing and directing San Francisco Fleet Week programs for major elements of the Pacific Fleet, and serving as a Project Officer for the visit of President Reagan and the Queen of England to San Francisco.

CDR Sherwood reported in August, 1983 to the office of the Chief of Information, Washington, to serve as Director of Community Relations.

CDR Sherwood is a recipient of a Freedom's Foundation Award and a resolution of commendation from the California State Senate. His awards include the National Defense Medal, Armed Forces Reserve Medal, Expert Pistol and Rifle Medals, and the Navy Commendation Medal.

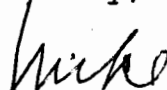

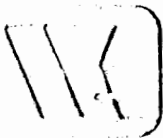

Dear Mr. Deaver:

I have been informed that you are presently exploring ways to negate the recent criticisms levied against the President by certain predominantly Democratic women's groups. I am an attorney and have recently formed a group of Republican business and professional women known as the "Los Angeles Professional Republican Women, Federated." This group presently has twenty-five members (most of whom are between twenty-five and forty-five years old) and is expanding rapidly. I am the president of the club.

I am writing because I have a specific suggestion to offer. The Democratic women's groups which are presently criticizing the President are, I believe, engaged in a campaign to undermine the President's support among women by depicting him as "anti-women." This campaign is predicated largely upon the President's opposition to the Equal Rights Amendment, whose passage they worked so diligently for. That "ERA," of course, failed to gain the necessary support among the states, notwithstanding their efforts. Consequently, I believe the opportunity has now presented itself for the President to convert this issue to his own political advantage by proffering a new version of a Constitutional amendment—one which would be consistent with Republican principles and yet would address the more legitimate concerns of the women's groups. By proposing his own "ERA"—one which would be acceptable to the vast majority of Americans, the President could, simultaneously, unite the nation on this divisive issue, replace the "anti-women" image created by the women's groups with that of a champion of women's rights, and capture for his own use the women's groups' favorite weapon in their efforts to undermine his support.

If you feel a Presidentially sponsored Constitutional amendment would be feasible, I would be happy to assist in any way I could in the drafting of same. In any event, I would appreciate your thoughts about the suggestion and would like to offer whatever assistance you feel I or my group could give in your endeavors with regard to women's issues.

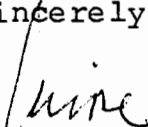

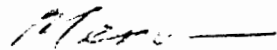

SUBJECT: Future Award of an Italian Decoration

Thank you for forwarding for review by our office the letters you received from Italian Ambassador Petrignani and Senator (and former Prime Minister) Fanfani, advising that, on Fanfani's recommendation, the President of the Italian Republic has decided to award you an Italian decoration at some future point when you are no longer a Federal employee.

Fanfani's statement that "American procedures" preclude your acceptance of this award while in office is, in general, correct. The Constitution prohibits Federal officials from accepting foreign gifts, titles and the like without Congressional consent; and Congress by statute has established a general rule against accepting foreign gifts or decorations, which are to be turned over to our Government. Though there are possible exceptions permitting individual acceptance that we could explore, I do not think it prudent or necessary to do so (particularly since it is clear the Italians do not expect you to accept the decoration now).

There is a separate question as to whether, as a Federal officer, you should or must reject what could (but does not have to) be characterized as a "present offer" of a future decoration. The constitutional provision, the statute and applicable regulations give little if any guidance on this point; and in checking with the State Department, we found little policy or precedent in this area. Apparently, however, foreign governments do at times advise our foreign service officers, shortly before their retirement, that an award or decoration will be conferred upon or after retirement; and we are advised by State that no one has viewed this notification as presenting any problem, or giving rise to any obligation that the "notice" or "offer" be rejected.

Given this practice (and the fact that the relevant statutory and regulatory reporting and other requirements are basically triggered by actual "acceptance" of a gift or decoration), I do not think you have to treat the Italian correspondence as a "present offer" of a decoration that you must either accept or

(almost certainly) reject at this time. Rather, I think you may justifiably view the letters simply as notification of a firm intent to make a formal offer of the decoration to you after you have left office, which you need not now formally accept or reject.

Accordingly, attached for your review and signature are letters to Petrignani and Fanfani that thank them for notifying you of the Italian action, but are silent on whether you will accept the decoration in the future. The letter to Fanfani is enclosed with the letter to Petrignani, for actual delivery to the Senator by the Ambassador (who had advised you he would be returning to Washington sometime after Labor Day).

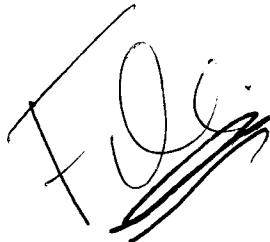
