1. Schedule: 4:00 interview is cancelled. Congressional meeting with 15 GOP members will be substituted. Briefing paper will be in to President shortly that will include points about Social Security. Duberstein

6. Davis-Bacon: Guidance is that some regulations are being revised to head off congressional efforts to repeal the entire Act. A background paper is ready; questions should be referred to DOL. Dole/

7. Minority Business Goals: OPD memo on subject has been circulated. Problem is that goals are set lower than last year. Fuller will coordinate resolution of issue; subject will also be discussed in Cabinet Council on Thursday. Fuller
