Interim Guidance UNTIL after notification to countries concerned:

In view of the fact that Congress will be in session, that key appropriations bills have not yet been enacted, and that a continuing resolution has been enacted but will expire in mid-November, it is clear that the first two weeks in November will be particularly demanding legislative weeks.

Accordingly, we are reviewing the itinerary for the President's November trip, and will be consulting with the governments concerned.

September 30, 1983

Guidance to be used AFTER notification of countries concerned

President Reagan has most reluctantly and with regret decided to postpone visits planned for this November to the Republic of the Philippines, Indonesia and Thailand.

On Friday, September 30, Deputy Chief of Staff and Assistant to the President Michael K. Deaver departed Washington to visit each of the countries to express the President's regret and to deliver personal messages from the President to the Heads of State of the three countries explaining the need for postponement.

The President made the decision to postpone this portion of his planned trip after a careful review of the planned 17-day itinerary and an assessment of legislative issues with which the President must deal.

The President still plans to visit Japan and the Republic of Korea in November.

September 30, 1983

Q: Was the postponement due to the situation in the Philippines?

A: The situation in the Philippines was taken into consideration. The Philippine Islands are our oldest ally in Asia. We have had a deep and close relationship with the Philippines this entire century, including close links between our two peoples. Therefore, the President wanted to visit the Philippines, and regrets postponement of the visit.

Q: Was the Philippine visit postponed for security reasons?

A: No. We were confident that adequate security could be maintained.

Q: When was the decision made to cancel? How?

A: The decision was made Thursday night, September 29, by the President in consultation with his staff and the Secretary of State.

Q: Was Mrs. Reagan's health or her advice a factor?

A: Her health was not. This decision was based on the factors already mentioned rather than for personal reasons. Mrs. Reagan was told by the President on Thursday night.

Q: Will the visit to these countries be rescheduled? When?
In connection with the April trip to China?

A: We will discuss rescheduling with the governments involved, since the President was visiting at their invitation. He certainly hopes to be able to visit the three countries at some time in the future. At present, there are no plans to expand the April trip.

Q; What impact will this postponement have on our relations with these countries?

A: Our relations with all three countries are excellent, and we expect them to remain so. We are disappointed that our original plans had to be changed, but this fact does not alter in any way our fundamental positive relationship with the ASEAN countries.
