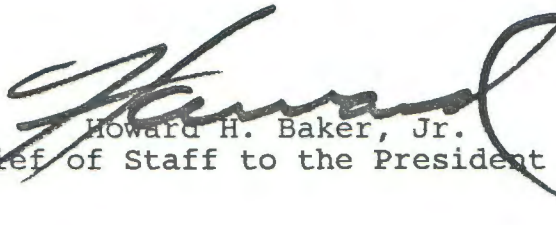

According to evidence in the case, Baldinger and Fleming were both licensed polygraph examiners and had maintained separate practices, but maintained an amicable business relationship for a time and shared office space beginning in 1982.

But later that year, they got into a dispute when Fleming acquired an account that Baldinger had been pursuing.

According to the evidence, Baldinger deceived Fleming in December 1982 into thinking that Baldinger had paid Fleming's annual fee for renewing Fleming's polygraph examiner's license.

Baldinger was also accused of sending letters to Fleming's customers saying Fleming was an unlicensed examiner who had numerous complaints against him. ■

Franklin physician's care left child brain-damaged, lawyer says

Prenatal care provided the mother by a Franklin family physician has left a now 5-year-old boy with the "mind of an 8-month-old baby," the mother's attorney told a federal jury yesterday.

Randall Kinnard's remarks came during the first day of trial of a medical malpractice suit before U.S. District Court Judge Thomas A. Higgins. The suit, filed in May 1986, charges that Dr. Huba Nagy was negligent in the treatment of Wei Ralph during the 1982-'83 pregnancy and caused the child's brain damage.

At the time of the alleged malpractice, Nagy was working in Waverly, Tenn., where Wei and her husband, T. Ralph, both of California, were then living. The Ralphs own money in Humphreys and Hickman.

"This child cannot walk, talk and is mentally retarded," Kinnard told the

five-man, one-woman jury.

"If Dr. Nagy had sent the mother to Vanderbilt University [Medical Center], the child would not have been hurt, and we would not be here."

James Tyree Ralph was delivered at Nautilus Memorial Hospital in Waverly in May 1983. The hospital is also named as a defendant in the suit.

Kinnard said that Nagy should have sent Wei Ralph, whom he says showed signs of having difficulties with her pregnancy the week before she gave birth, to Vanderbilt, a facility he said is better prepared to handle problematic deliveries.

Furthermore, he says, Nagy did not take action to counter Ralph's difficulties until a week after Kinnard said Nagy was first made aware of them.

Nagy denies he acted improperly.

His attorney, Ward DeWitt Jr., told the jury that Wei Ralph failed to inform Nagy about drainage and other problems she was experiencing. ■

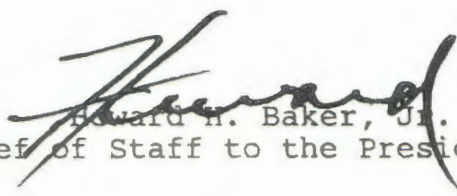

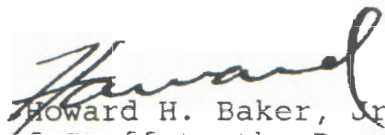

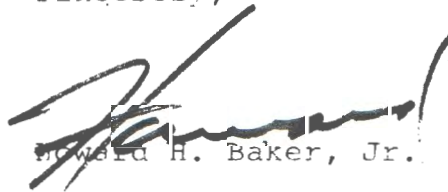
