Dear Mr. Gidwitz:

Thank you for your letter of September 3, in which you express misgivings about a prospective U.S.-Soviet treaty on intermediate-range nuclear forces (INF).

Let me assure you that our proposals for an INF agreement are fully consistent with our long-standing, cautious policy on arms control with the Soviets. Our INF policy has been developed as a result of extensive and intensive consultation and discussion both within this government and with the governments of our NATO allies. The Joint Chiefs of Staff, NATO military authorities, and representatives of the Office of the Secretary of Defense have fully participated in every stage of the process. NATO defense ministers have regularly endorsed the U.S. INF negotiating position. It is therefore no surprise that our allies fully support the agreement in principle recently reached by Secretary of State Shultz and Foreign Minister Shevardnadze to eliminate all U.S. and Soviet land-based INF missiles.

The President would not have made these proposals if they weakened our own security or that of our allies -- indeed they do just the opposite. Under the terms of the proposed INF agreement, the Soviets will have to sacrifice almost 1,600 nuclear warheads on INF missiles (SS-20, SS-4, SS-23 and SS-12) in return for some 350 single-warhead U.S. cruise and Pershing missiles.

After an INF agreement, NATO's deterrent, based on an approximate mix of conventional and nuclear weapons, will remain robust. The United States will still have a variety of nuclear systems in Europe, including both ground-based systems and weapons on aircraft which can reach deep into Soviet territory. The Supreme Allied Commander for Europe will have at his disposal additional warheads on submarine-launched ballistic missiles committed to the defense of Europe. Furthermore, at Montebello in 1983, the Alliance committed to modernize those nuclear systems which it will continue to deploy. Finally, the United States continues to station over 300,000 troops in Europe prepared to meet any Soviet aggression, and this in itself remains a major demonstration of the continued coupling of U.S. and European defenses.

This Administration shares your concerns about Soviet compliance with arms control agreements. For that reason, we will not proceed in arms control talks with the Soviet Union on the basis of trust. Rather, we have insisted on strict, effective verification procedures so we can ensure that the Soviet Union is complying with the terms of any agreement.

In our negotiations with the Soviets on INF, we have proposed procedures which will constitute the most extensive and stringent verification regime in the history of arms control. These procedures include inspections to confirm baseline levels of Soviet missiles and support facilities, inspections to verify destruction of these weapons and facilities, and mandatory challenge inspections of suspect sites. Because the Soviets have accepted President Reagan's proposal for global zero, we will have the added measure of verification provided by confirming that Soviet INF missile-producing facilities are destroyed. I am taking the liberty of enclosing an Administration publication providing further detail on our verification proposals.

The prospective INF agreement will be a major achievement for the Western Alliance and another important accomplishment of President Reagan's policies. It will establish new and important standards for verification of arms control agreements. Most importantly, the West will have demonstrated that it can stand firm by resisting Soviet intimidation. Through negotiating from strength, we can achieve equitable agreements which enhance collective security in the West.
