Dear Mr. Hahn:

Thank you for your letter of March 31 and for sending me a copy of the testimony of Los Angeles Chief of Police Daryl Gates. I found the testimony very interesting and, of course, am familiar with the good work of Chief Gates, particularly his personal support of the DARE Program.

The fight against illegal drug use and trafficking has been one of President Reagan's highest priorities. Nearly three dozen Federal agencies now participate in this effort -- resulting in major accomplishments on all fronts in this continuing battle. The President's budget for 1989 proposes a funding increase of \$450 million, a 13 percent increase over the 1988 enacted level of nearly \$3.5 billion. If the President's 1989 proposal is approved, spending on Federal drug programs will have more than tripled since 1981.

Through drug abuse education, treatment, research and deterrence programs, the Veterans Administration and the Departments of Education, Labor, Defense and Health and Human Services spearhead the President's crusade for a drug-free Nation. His budget proposes \$1.036 billion for drug abuse education, prevention, and treatment in 1989, an increase of \$112 million over the 1988 level. The Administration believes that the 1989 request would make a dramatic difference in the fight against drug abuse, if governments at the Federal, State and local levels work together and with the private sector. The majority of successful education, prevention and treatment programs are those where concerned citizens from all segments of society work together for a common goal -- that is, a drug-free America.

With regard to drug law enforcement, the Administration has made Federal program enhancement one of its top domestic priorities. Over the past seven years, the President has successfully sought additional resources for drug law enforcement in a number of agencies. The President's budget for 1989 proposes a funding increase of \$339 million, a 13 percent increase over the enacted 1988 level. Previous funding increases devoted to drug law enforcement have begun to produce results.

The Federal Government has demonstrated that it is serious about enforcement and about creating a drug-free America. Also, the Federal response is now more coordinated, negating the need for further dramatic spending increases. In March 1987, the President signed an Executive Order establishing the National Drug Policy Board (NDPB) as a Cabinet-level forum to coordinate all Federal anti-drug policy matters. The NDPB incorporated the National Drug Enforcement Policy Board which was established in 1984, and brought policy decisions on all anti-drug programs, whether on the supply or demand side, to the same policy forum. One of the Board's specific tasks is to provide policy guidance and resolve differences concerning interagency activities.

The drug problem in the United States today is much different from what we faced only a decade ago; illegal drug use has declined, seizures are up, and our law enforcement initiatives are increasingly effective. However, there is one aspect of enforcement and deterrence where we, as a Nation, are only beginning to get serious -- confronting users to hold them accountable for their actions.

Initiatives are currently underway in several States and cities to accomplish this goal; for example: in Los Angeles and New York, individuals are subject to forfeiture of the vehicles used to facilitate the purchase of drugs; in New Jersey and Missouri, individuals involved with illegal drugs will have their driver's license revoked or their acquisition of one postponed; in Miami, undercover officers, disguised as drug pushers, pose as drug dealers and then arrest the buyers; and elsewhere, various jurisdictions are imposing fines ranging from \$500-\$3,000 or mandatory community service on illegal drug users. These efforts, combined with our traditional law enforcement and prevention efforts, are changing attitudes among illegal drug buyers. Users are learning that they too are targets for prevention and that the risks of purchase and use are substantial.

The use of illegal drugs creates the market. Users keep the chain of supply in operation. The resulting crime, corruption, and violence put our law enforcement officers at considerable risk. The American people are beginning to understand that illegal drug use is dangerous and wrong, and that that is precisely why these drugs are illegal.

Merely increasing the Federal budget will not eliminate the drug problem, nor will improved law enforcement or prevention efforts. As the President has repeatedly said, the solution to the drug problem comes by "taking the customer away from the drugs." The

success of prevention and intervention is dependent on an overall attitude change -- on each of us rejecting illegal drug use in this country and doing whatever is necessary to make it impossible for individuals to continue using drugs.

Thank you for taking the time to express your concerns and, again, for sharing Chief Gates' suggestions. Please know that our commitment is unfaltering and that the legacy we hope to leave is nothing less than a drug-free America.

Dear Pat:

I apologize for the delay in responding to your letter of March 14. As you now know, our thinking is very much in line with your draft bill. The President's Executive Order of March 18 mirrors your Monitoring Council and statement of objectives. We anticipate that the working group established by the EO will provide much of the inter-market coordination that everyone agrees is necessary, and that it will be able to take action on a number of issues raised by the various studies.

The first full report to the President will be made no later than mid-May (60 days from the time of the Executive Order). We expect that definitive steps can be taken in the interim -- this effort is not intended to be another "study" or delaying action. Further, the initial report to the President may include recommendations for legislation to alter or augment current regulatory authority. Any such recommendations will be quickly evaluated in anticipation of possible legislation before the year is out.

I know that there is some restiveness in Congress and a desire for quick action. We're not attempting to preempt such actions, but rather taking measured and deliberate steps to achieve our shared goal of preventing a recurrence of last year's events while preserving the efficiency and competitiveness of our capital markets.

Dear Bill:

I appreciate your support for our efforts in forming the financial markets working group. I want to again assure you that our efforts are not an attempt to preempt Congress. Rather, we anticipate that the working group will provide much of the inter-market coordination that everyone agrees is necessary, and that it will be able to take action on a number of issues raised by the various studies.

The first full report to the President will be made no later than mid-May (60 days from the time of the Executive Order). We expect that definitive steps can be taken in the interim -- this effort is not intended to be another "study" or delaying action. Further, the initial report to the President may include recommendations for legislation to alter or augment current regulatory authority. Any such recommendations will be quickly evaluated in anticipation of legislation before the year is out.

As you know, I'm sensitive to Congressional prerogatives and understand your desire to proceed in a timely way. This is not an issue that is, or should be, in any way viewed as partisan or a tug-of-war between the respective branches. We share the goal of preventing a recurrence of last year's events while preserving the efficiency and competitiveness of our capital markets.

I look forward to continued cooperation with you on this issue.
