The Act of Congress of March 2, 1929, as amended May 15, 1930, authorizes pilgrimages to the cemeteries of Europe during the years 1930, 1931, 1932 and 1933 for the mothers and widows of deceased members of the American forces who were lost or buried at sea or whose remains are interred in Europe.

Your attention is particularly invited to the fact that this is the last opportunity you will have to make the pilgrimage under the provisions of the above mentioned Act. Unless you take advantage of this LAST chance to make a trip in 1933 you will receive no benefit from the Act. There is no provision of law which will permit the Government to make a money allowance to any mother or widow who does not choose to make the pilgrimage.

IT IS REQUESTED THAT YOU GIVE THE MATTER YOUR MOST CAREFUL CONSIDERATION BEFORE REACHING A DECISION, BEARING IN MIND THAT THIS IS THE LAST OPPORTUNITY YOU WILL HAVE TO MAKE THE TRIP AT GOVERNMENT EXPENSE.

In order to assure proper and satisfactory accommodations for the mothers and widows making the journey in 1933, reservations for steamship transportation must be made by this office several months in advance. It is requested that you answer the questions below by writing "Yes" or "No" or "Undecided" in the blank space following the question. When you have answered the question, sign your name and return this sheet in the enclosed addressed envelope which requires no postage. PLEASE DO NOT DELAY, as it is essential that the information be in this office promptly.





Receipt is acknowledged of your letter of February 4, 1932, advising that Mrs. Anderson regrets that she is unable to accept the invitation of the Government to make a pilgrimage this year.

The records of this office fail to show that a mother or widow from St. Cloud, Minnesota, by the name of Anderson has been invited to make a pilgrimage to Europe during the coming summer. However, there are a number of women from Minnesota by the name of Anderson who are eligible to make the trip, and it will be appreciated if you will furnish Mrs. Anderson's full name, together with the name, rank and organization of her son or husband in whose honor she has been invited to make the journey, so that the proper notation may be made.

Under the provisions of the Act of Congress of March 2, 1929, pilgrimages were authorized for 1930, 1931, 1932 and 1933, and each eligible mother or widow who has not previously made one of the pilgrimages will be invited to do so in 1933.

The Act of Congress of March 2, 1929, authorizes pilgrimages to the cemeteries of Europe for the mothers and widows of deceased members of the American forces. The purpose of the Act is an endeavor to bring a measure of peace and comfort to the hearts of the mothers and widows whose loved ones made the supreme sacrifice, and it appears from communications from women who have made the journey that this effort has not been in vain.

All necessary expenses of a pilgrimage to the grave of your son, the late Private William J. Anderson, will be borne by the Government and personnel to care for the comfort and needs of the women making the journey will be provided. Doctors and nurses are available and should you make a pilgrimage, you are assured the journey will not only be made at the expense of the United States but everything possible for your comfort and care will be provided. In other words, you will be the honored guest of the United States Government.

It is the earnest endeavor of this office to discover the wishes of each mother and widow with reference to the pilgrimage so that necessary arrangements may be made. It is hoped that you will decide to make the pilgrimage and will so state; however, if you feel you cannot accept the invitation, it is important that we know that. For the reasons stated, it will be appreciated if you will complete the questionnaire enclosed herewith and return it to this office in the enclosed envelope which requires no postage.

This letter is forwarded in a final effort to obtain your wishes, inasmuch as previous letters relative to the pilgrimage have remained unanswered.
