Thank you, and welcome to the White House.

Acknowledgments

I'm so pleased all of you could join Laura and me as we mark the 40th anniversary of the 1964 Civil Rights Act. Signed in this very room, this act of Congress outlawed racial discrimination in public accommodations, employment, and voter registration. No longer could weary travelers be denied a room in a hotel, or a table at a restaurant ... and no longer could any American be forced to drink from a separate water fountain, or stand at the back of the bus, just because of the color of their skin. All discrimination did not end that day, but from that day forward, America has been a better, fairer country.

Today, outside this room in the Grand Foyer, we have on display the first and last pages of the Civil Rights Act, and one of the pens President Lyndon Johnson used to sign it. But before he could sign that bill, the conscience of America had to be awakened. It was stirred by the actions of courageous men and women, who held sit-ins at the lunch counters ... who rode the buses on the Freedom Rides ... who endured and overcame the slurs and the fire hoses and the burning crosses ... and who marched on Washington with Martin Luther King Jr., when he challenged America to "rise up and live out the true meaning of its creed."

President Kennedy accepted that challenge. A few months before his death, he said our Nation was confronted "with a moral issue ... as old as the Scriptures, and ... as clear as the American Constitution." He called on Congress to pass a civil rights bill. Members from both parties worked tirelessly to make that bill a reality – in particular, senators Mike Mansfield, Everett Dirksen, and especially Hubert Humphrey. These men had their differences, but when it mattered most, they rose to the occasion, and our Nation honors them today.

And it was only fitting that a son of the South – the first southern President since Reconstruction, in fact – won passage of the law which

completed the "new birth of freedom" that the Civil War began. During the Senate debate on the bill, the longest debate in Senate history, President Johnson used all his powers of persuasion – and they were considerable. No one escaped the famous LBJ "treatment"; not senators, not their wives, not even their children. When Johnson called reluctant senators at home and a child answered, he would say: "Now tell your daddy that the President called, and he'd be very proud to have your daddy on his side."

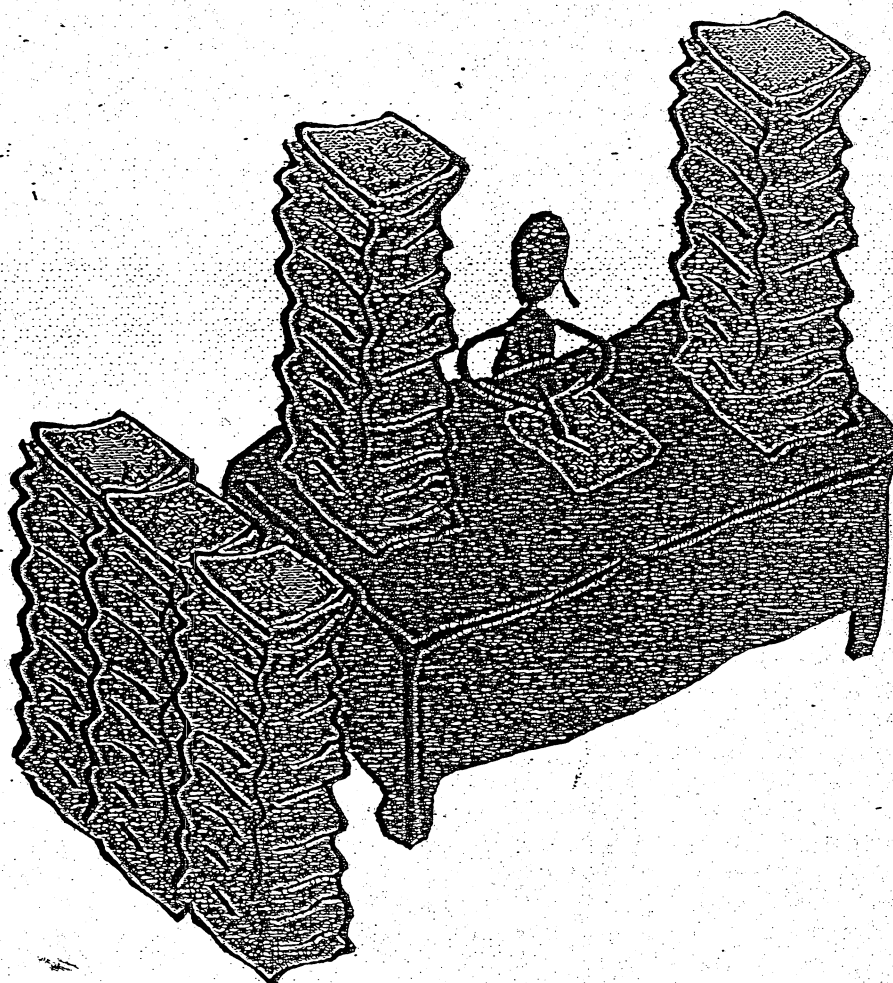
But it wasn't just the force of Johnson's personality that won the day; it was the force of his conviction. In his early years, he had seen the ugly effects of discrimination. And when he became President, Johnson was determined to pass the Civil Rights Act, despite the political risk. One southern senator who opposed the bill warned him, "It's going to cost you the election." The President replied, "If that's the price I've got to pay, I'll pay it gladly."

After the Civil Rights Act became law, the change was felt immediately, all across America. In 1964, Dale Long was a 12-year-old boy living in Birmingham, Alabama. One day, before the law was passed, Dale and his brother convinced their father to take them to a movie at a theater where blacks had to enter through an alley, and could only sit in the upstairs balcony. "I could see the look of humiliation on my Dad's face," he remembers. But a few months after the Civil Rights Act, the Longs returned to that theater. "We went to see a James Bond movie," Dale says. And this time, the Long family entered through the front door, and sat where they pleased.

Four decades later, the indignity of Dale Long's first experience at that movie theater seems incomprehensible to us. Because of the Civil Rights Act, America has become a far different and far better place, and on this day, we honor all those who made that possible. But some challenges remain. Many of our citizens still doubt the promise, even the justice, of our country. So let us continue our work to extend the hope of America to every part of our Nation, until that day when, in the words of Dr. King, "justice rolls down like waters, and righteousness like a mighty stream."

Thank you all, and may God bless America.

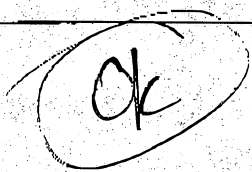
