2. In accordance with the established procedure, request NSPD-55 be authorized for release to the Commander, USEUCOM and Commander, USPACOM.

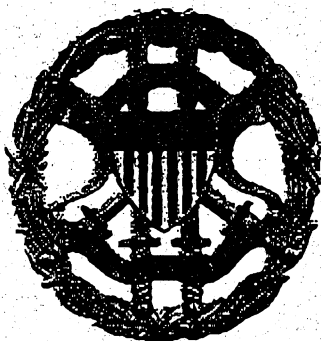

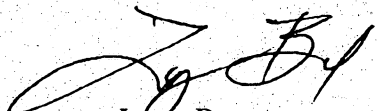

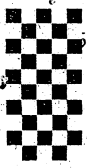
