DEMOCRATIC REPUBLIC OF THE CONGO: Military Agreement

June 30, 2003

Key Points

- We welcome the June 29, 2003 agreement among Congolese parties on the framework for an integrated national military.
- Agreement on the formation of a unified military removes the final obstacle to the establishment of an inclusive transitional government, as called for in the April 2 Inter-Congolese Dialogue Final Act.
- We congratulate the Congolese parties for taking this positive step towards the formation of a transitional government and a peaceful resolution of the conflict in the Congo.
- We urge the parties to the transitional agreement to establish, as quickly as possible, the new transitional government.
- We commend United Nations Special Envoy Moustapha Niasse (NEE ah see), United Nations Special Envoy Maruice Baril, and the South African government for their significant roles in promoting agreement on the military integration issue.
- In the spirit of this final compromise, we urge all Congolese armed groups to immediately cease ~~and~~ all armed conflict, particularly in the volatile eastern part of the Democratic Republic of the Congo.
- We welcome reports that the Congolese Rally for Democracy – Goma faction has begun to withdraw its forces from the North Kivu town of Lubero. We ~~urge~~ ^{urge} the group to fulfill its commitments to withdraw its troops from those towns specified under the Bujumbura cease-fire agreement signed earlier this month.

BACKGROUND

The Inter-Congolese final act was signed by all parties to the Inter-Congolese Dialogue in Sun City, South Africa, April 2.

This agreement, along with the transitional constitution, the military and security agreement, and the global and inclusive agreement on the transition, provide the framework for a transitional government in the DRC.

The International Committee (comprised of UNSC member states, South Africa, Canada, and several other countries) called for in the transitional agreement has been working closely with the Congolese Follow-Up Committee to reach agreement on the outstanding issue of military integration.

UN Special Envoy Niasse and the South African government organized meetings June 27-29, encouraging resolution of this issue.

On June 29 the Congolese parties agreed that the current DRC government will retain Chief of Staff of the Armed Forces and Chief of the Airforce, the RCD-G would appoint the Chief of the Land Forces, the MLC the Chief of the Navy, and the Government the head of military intelligence. There are no Chief of Staff deputies, but DRC government and MLC deputies for the Land Forces, an MLC deputy of the Airforce, and an RCD-G deputy of the Navy.
