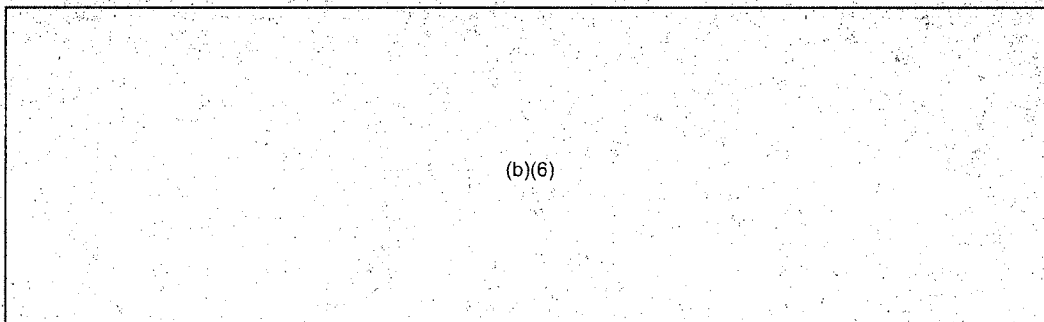

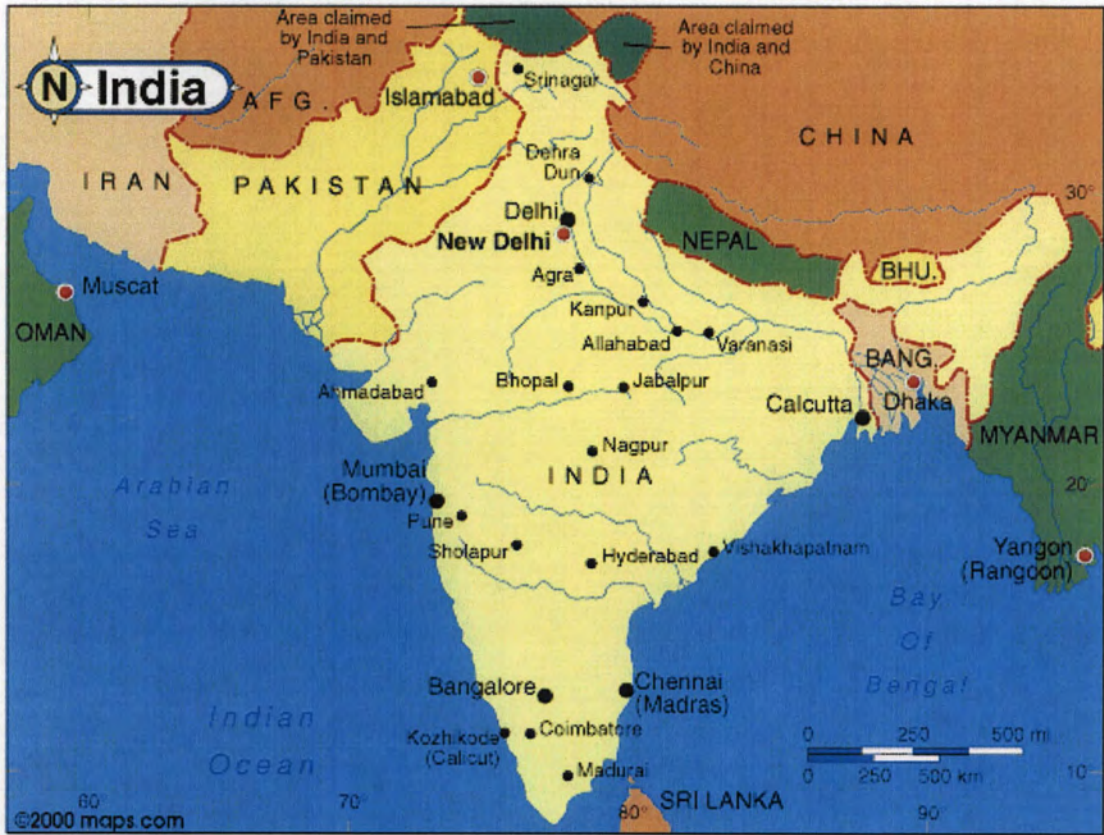

Traditional Indian Greeting

The traditional Indian greeting is the *namaste* (in the south *Namaskar*). To perform the *namaste*, hold the palms of your hands together (as if praying) below the chin, nod or bow slightly, and say *namaste* (nah-mas-tay). This greeting is useful for foreigners in any situation where a handshake might not be acceptable. It is a good alternative to a handshake when a Western businesswoman greets an Indian man.

BACKGROUND

With USAID India support *Gali Gali Sim Sim* is being introduced to India. Through a partnership with Sesame Workshop, USAID helped the program enter the local television market and develop high quality, country-appropriate educational content. The objective is to provide an educational program that will give a head start to Indian children ages 3-6 on basic skills to prepare them for school. This increases chances for success and retention in school, and builds productivity in a country with one of the largest populations of young children in the world. Using a broadcast medium, it will connect underserved in urban and rural settings with basic educational skills.

A “spin-off” of the beloved, American “Sesame Street” format and approach is carried out through the help of specially designed characters and Muppets that reflect India’s cultural and educational needs. Storylines encompass Indian topics, issues and cultural mores. *Gali Gali Sim Sim* will prompt children to be active learners by focusing on fundamentals such as literacy and numeracy, emphasizing critical thinking, and instilling a love of learning. It will present youngsters from diverse backgrounds with positive images and stories. It will emphasize the abilities of girls to promote their literacy and encourage their school attendance. There are no formal pre-school education programs under the Indian Ministry of Education. Literacy rates in India are 76 percent for males compared to 54 percent for females.

Public-private partners on this effort include: USAID, Sesame Workshop, Turner Broadcasting, ICICI Bank (a major Indian bank), and Miditech (an Indian production company).

FUNDING

USAID is funding \$500,000 for Sesame Street in India. The US is leveraging a small amount of US taxpayer resources to bring together this US/India partnership that will expand education opportunities to Indian children. The US partner is Turner Broadcasting. The US funds have been leveraged several times as other private sector partners from India and the US have joined the partnership.

BIOGRAPHIES OF GREETERS

Mr. Niret Alva, President, Miditech

Miditech has had a long and distinguished career as reporter, presenter, anchor and director. He began his stint in TV journalism as a reporter in 1988. In 1990, he joined the Eyewitness video news magazine. He started Miditech with his brother Nikhil Alva in 1992. The program that instantly put Miditech in the limelight was the award-winning "Living on the Edge," aired on Doordarshan (the Indian national television network). Other critically acclaimed series followed. He has also anchored and directed travel shows later shown in Australia and Europe.

Mr. Nikhil J. Alva, Chief Executive Officer, Miditech

Miditech established the production company in 1992. The vision was to produce hard-hitting programs on environmental and social issues, travel and culture in India and a series on fast emerging sectors such as Infotainment. One of the earliest successes as a producer was the show "Living on the Edge," India's first comprehensive environment series. He has won numerous media awards and pursues interests in natural history film-making. He is also directing a documentary on earthquakes for the National Geographic Channel that will be aired later this year.

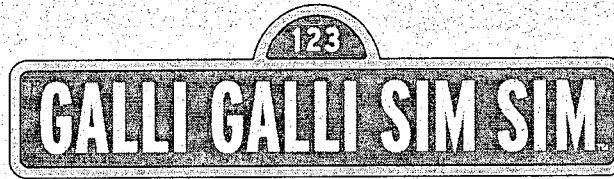

He has also worked as a casual announcer (Hindi) in Yuv-vani channel, the national radio channel, and has fifty audio serials to his credit.

Character: Kabir (Male)

Kabir is Dawa and Basha's child who is an energetic and outgoing 8 year old child. The Muppets look up to him as a big brother.

Kabir is an active, inventive child who is emotionally expressive.

Satyam and Shivam Khanna

Satyam and Shivam are twin brothers who are playing the role of Kabir. They are eight years old and study in Delhi Public School – Ghaziabad. Both love playing cricket, and Satyam is also very good at chess. They have appeared in advertisements, including Bon Bon Biscuits and Microsoft Images.

Chamki (Muppet)

Chamki is five years old and is the learner on the show. A 'feminine tomboy,' she has a lot of questions about things around her. She is irrepressible and flits from idea to idea with equal excitement. She slips easily into roles that require learning and discovery. She enjoys learning words from other languages and like practicing tongue twisters. Her best friend is Googly. She loves his company and is often seen trying to persuade him to get up and do things.

Aanchoo (Muppet)

Aanchoo is transported to a different space and time when she sneezes. There are two warning sneezes and she disappears on the third. Her travels make her the perfect culture vulture. She brings back mementos from her travels and has a beautiful collection of artifacts from different regions of India. Her experiences provide fodder for her tall tales. And though she exaggerates,

she doesn't lie intentionally. You will never catch Aanchoo saying 'I don't know.' Instead, she always comes up with outlandish guesses/explanations for every situation. She is confident, doesn't get disheartened and is never at a loss for words. She is bumbling and hyperactive and gets distracted easily. Her language and mannerisms are flamboyant.

Googly (Muppet)

A bit of a loner, Googly likes to read in solitude. He is extremely orderly and possessive about his things. He gets anxious when things are disorganized. He likes to collect things like boxes, stone and takes good care of his collections. He is the voice of reason in the Chamki-Googly relationship. Gentle, soft and a little shy, Googly hesitates in new situations, but once pushed into things, he ends up enjoying himself in his own unique way.

Boombah (Muppet)

Boombah is big and cuddly and has the adorable simplicity of a child. He loves to dance. He's a lion with a bear hug. He likes to work things out in his head before reacting. And that makes him a wonderful listener too. Boombah rarely gets angry. His tail can assume a life of its own, forming a question mark when he's confused. He is very fond of his mane and likes to preen it.

Early this year a seminar organised by Sesame India deliberated on children in India - especially focusing on their cultural plurality, communal mingling, linguistic variance, as well as the differences and interdependence between rural and urban lifestyles. The purpose of these deliberations was to offer a programme that would not only make children laugh but also content to reflect upon. Children get bored with the monotony of everyday routines and "there must be a fun way to learn" is an oft-heard plea. "Keeping vibrant the voices of children we are in the process of connecting meaningfully with children's learning," says Asha Singh, Director - Education and Research, Sesame India. "Each half-hour episode of the Sesame India series will be a fun-filled mix of various genres from live action and studio to animations and the Sesame Workshop's muppets. The series' distinctive appeal lies in its ability to speak to children through an approach that they most relate to, from a unique perspective - one that explores and understands the physical and social world from the point of view of a child. The content for the Sesame India Series, to be aired on Cartoon Network and POGO by mid 2006, is presently being developed by Miditech, the production partner.

"The success of Sesame International is that they explore the local to enlarge the global. Sesame evolves this reconfiguring of the universal template by dialogues with local experts who have extensive experience of working with children and knowing their minds through several windows. An essential element of the planning process for any international co-production of Sesame Street is the creation of a Statement of Educational Objectives. This document serves as the educational framework for the project and is the foundation upon which all material developed for the project is based.

Focus on content

The educational plans developed for various countries differ from each other with respect to their emphasis and organisation. Some focus more on cognitive and academic goals while others speak more specifically to the social-affective arena," says Singh.

A content seminar' was held in May this year to derive a "culturally relevant content inclusive of the plurality of the Indian terrain", says Singh. The discussions in the seminar raised many issues especially relevant to the Indian social context.

Certain specific features were identified as significant for creating a more civil and humane attitude infusing values for recognising variation, multiple skills and live styles among children in India. A team of writers, animators, and filmmakers with inputs from educationists are in the core of preparing this content. The Sesame India series would supplement a child's learning at school but not replace the system of formal learning. The content curriculum outlines the various concepts, issues and learning needs that need to be addressed for children aged between two and eight.

Broadly these can be clubbed together under five key areas: 1. Cognition: stimulating and enriching mental functions; 2. Emotion: caring, sharing and nurturing; 3. Physical well-being: body care and safety; 4. Social Relations: independence and interdependence; 5. Culture: harmonising diversity

Will the content be teacher friendly? "Yes very much so, says Singh. "As an educator I use even KBC as a model for what is good teaching and learning. Sesame India is all about children and there is a lot of layering in the programme for adults, parents and teachers."

BACKGROUND

Prayas is a USG-funded, comprehensive child-focused development organization helping educate, heal and care for child sex and labor trafficking victims and street children. The organization was established in 1988 as a joint initiative of the Delhi Police, Delhi School of Social Work and a local non governmental organization (NGO).

Starting with 25 children, Prayas now caters to the needs of 50,000 neglected children in the slum areas of Delhi, and states of Gujarat (goojurät') and Bihar (bēhär'), insurgency-affected Assam and the tsunami devastated Andamans. Prayas operates a network of social service organizations including three shelters for children, 110 education centers (traditional school alternatives), 15 vocational training sites, 12 community libraries and a mobile health van.

USAID partners with Prayas to combat trafficking in persons in communities, and implement learning techniques to "bridge" out-of-school children back to formal classroom settings. It implements efforts to complement the Government of India's "Education for All" initiative for universal primary education.

The New Delhi Shelter Home for Girls has a capacity of 60 girls, age 6-18, and is equipped with state-of-the-art facilities. Since 2002, this model home provided shelter to more than 180 girls. The girls are cared for in a nurturing environment and provided food, shelter, counseling, medical care, alternative education, vocational training, ranging from computer training to baking, and mainstreaming into traditional schools. Many girls are returned to their families in far off locales after proper counseling with their parents.

Prayas is considered a model program across the world with their comprehensive care, training and education programs and services.

FUNDING

By August 2007, USAID and State Department's Office of Combating Trafficking in Persons will have provided a total of more than \$850,000 in direct funding to Prayas over the last five fiscal years (FY03-FY07). The funding has helped provide shelter, medical care and counseling in a stable, supportive environment to help victims recover and rehabilitate. The funding has also helped rescue minors from brothels and helped mainstream vulnerable children through education and job skills training.

GREETERS

Mr. Amod Kanth, Founder of Prayas and Director General of Police, Itanagar, India

Mr. Kanth is the Director General of Police in Itanagar, Arunachal Pradesh, and has been in the Indian Police Service (IPS) for the last 31 years. Besides his police responsibilities, Amod is the General Secretary and founder of Prayas. Prayas is one of the premier NGOs working with victimized and neglected children, providing assistance to 50,000 children each year in Delhi, Bihar, Gujarat, Assam, and the Andaman and Nicobar islands. Amod has an outstanding record as a professional and proactive police officer in various fields of crime control, law and order, drugs and human trafficking, counter-terrorist operations, and has received Police Medals for Meritorious and Distinguished Service.

Mr. Rajib Haldar, Executive Director, Prayas Institute of Juvenile Justice

Mr. Haldar has served as Executive Director of the Prayas Institute of Juvenile Justice since 1996. He has a Masters in Social Work from Delhi University's School of Social Work, where he has also served as academic faculty and researcher. Rajib has worked on child rights issues at the regional and national level, has published a number of articles and papers on the subject, and is considered an authority on child rights, human trafficking, child labor and child protection. Along with his work in New Delhi, he is also actively engaged with the rehabilitation of children affected by the tsunami in the Andaman and Nicobar Islands.

Seema, Former New Delhi Shelter Home for Girls Resident, Age 19

Seema has been with Prayas for the last three years. She has taken beauty training and other academic courses during this period. Seema was abandoned by her parents at the time of her birth because she was a girl, and was brought up in an institution before being given up for adoption. Seema's adoptive parents severely abused her, making her do all the domestic chores and treating her like a servant. Seema was finally able to escape with the help of Childline (a national helpline for children in distress), and was referred to Prayas. Prayas pursued her case, ultimately getting 100,000 Indian rupees in compensation from her adoptive parents. Seema learned block printing and how to speak English, and is currently at Prayas to meet up with old friends and the staff. Seema would like to lead an independent life and has developed the courage and confidence to do so. She is working as a peer educator to educate communities on how to prevent trafficking and how to become a strong survivor.

Shilpa, New Delhi Shelter Home for Girls Resident, Age 7, Presenter of Bouquet

Shilpa has been with Prayas for the last seven months and is attending alternative education classes so that she can enter a formal school in the coming academic year (April 2006). Shilpa had a traumatized and difficult childhood, culminating in her father murdering her mother in front of her and her siblings. Her sisters are also at this Prayas facility, while her brothers are staying in the

Prayas boys home. Regular counseling sessions have helped Shilpa deal with her trauma. She would like to be a police officer when she grows up.

Aarti (b)(6) age 16

Aarti has been staying at Prayas Bal Greh (independent living home) for last six months. She has previously lived at Prayas Home for Girls, received alternative education and dress designing course for five and half years. She is a child of commercial sex worker who wished her daughter to stay away and lead a decent childhood. She was rescued by Anti-Trafficking Network (ATN) and referred to Prayas.

Presently, she is working in a boutique and has moved to the independent living home. She earns her living and maintains her life independently. She is deaf and dumb, cheerful and caring person. She expresses herself with ease despite the disability.

**Ms. Nandita Baruah, Regional Anti-Trafficking and Equity Advisor, USAID India -
MODERATOR**

Ms. Baruah has been working with organizations dedicated to combating trafficking in persons for the last 6 years. Aside from her current work at USAID, she has also served at the South Asian Association for Regional Cooperation, the UN Development Fund for Women, the UN Development Bank, and the UN International Federation for Cultural Development. She is currently serving as an advisor to the US Embassy New Delhi on women's development issues.

Ms. Aparna Singh, Manager of Shelter Home and Crisis Intervention Center, Prayas

Ms. Singh has been working with Prayas for the last two years as Manager of the Shelter Home and Crisis Intervention Centre. She has a Masters in Psychology and has completed her post-graduate diploma in Guidance and Counseling. She is responsible for individual, group and family counseling sessions with women and children who have had difficult backgrounds, including those who have been trafficked. She monitors the day-to-day activities of the home with the help of other staff.

Ms. Deepti Sharma, Counselor, Prayas

Ms. Sharma is a professionally trained counselor with a Masters in Psychology. She has been working with Prayas for two years and has a wealth of experience in counseling children who have suffered abuse and neglect or have been trafficking victims.

Anita (b)(6) Age 17

Anita has been with Prayas for eight months, and has spent the last four months at the Prayas trafficking victims rehabilitation center. She was the victim of commercial sex trafficking, but now hopes that the victimization that she had faced should not recur again or to happen to any other woman. Anita is associated with the Prayas Rescue Team and has been cooperating with investigators in the hope that her trafficker will be arrested. Anita has grown in confidence since coming to Prayas, and works in the Prayas economic rehabilitation center (run in partnership with

Amul, India's largest dairy product manufacturing company). She is learning to use computers at the Prayas Institute of People's Education, a project of the Indian Government's Ministry of Human Resource Development that is being managed by Prayas.

Karishma, Age 12

Karishma has been with Prayas for the last six months after running away from an abusive step-mother. The Children Assistance Booth run by Prayas at the New Delhi Railway Station rescued Karishma and brought her to the facility. Karishma enrolled in alternative education classes and is taking vocational training in arts and crafts. Trauma care counseling helped Karishma deal with her emotional needs and she is now able to look forward to a new life. She would like to be a doctor when she grows up.

Sartaj, Age 12

Sartaj was a rag picker for five years before coming to Prayas, meaning she and her family supported themselves by sorting through city garbage. She is now enrolled in a formal school and has excelled in her studies. Sartaj has received a scholarship and many certificates in extracurricular activities. She would like to be a doctor when she grows up.

Komal, Age 13

Komal has been with Prayas for the last eight months and is enrolled in alternative education classes and vocational classes in arts and crafts. Her parents separated when she was young, as her father was an alcoholic and abusive of the family. Last year, Komal's mother died after a long illness. Trauma care and counseling helped her deal with negative feelings and emotional insecurity. Komal would like to be a teacher when she grows up.

Tabassum, Age 17

Tabassum has been with Prayas for the last four years. She was abandoned by her father after her mother died. On the streets, Tabassum was physically and sexually abused during her developing years. A local person referred her to Prayas, where she has learned many vocational skills, including screen printing, and is currently attending a beauty training course conducted by an outside institute. Tabassum will be taking her 10th grade examinations soon through the National Open School. Even though badly traumatized, Tabassum has great ambition and high aspirations. She is a cheerful girl but at times becomes very disturbed due to her past. She does not want any child to live an abusive life on the streets.

Talking Points for Discussion at Prayas – New Dehli, India

- Education is vital to children. We want every boy and every girl to be educated. In too many places, girls' education is not a priority, and uneducated girls are vulnerable to being exploited. But education gives girls power. At Prayas, girls receive basic education including reading and math. Girls learn skills they can use to support themselves and their families when they get older. And girls learn to love and value themselves.
- Each year, more than 600,000 people are victims of international human trafficking. Eighty percent of the victims are female. Fifty percent are children. And millions more men, women, and children are trafficked within their own countries.
- Human trafficking degrades every person who is a part of it, most especially women and girls who are sold as sex slaves. The United States is working with many countries, including India, to put a stop to this barbaric practice.
- Prayas is a development organization that helps educate, heal, and care for child victims of sex and labor trafficking, as well as children who live on the street – the children most at risk of becoming victims of trafficking. Prayas is funded by the people of the United States, and it works in partnership with the Indian government, national and state organizations, and international organizations.
- This shelter in New Dehli has provided food, medicine, education, counseling, and a place to stay for 180 girls since 2002. Many have returned home to their families. The Prayas model has helped 50,000 girls around the world.
- I look forward to speaking with some of the girls who live at Prayas and with the caring adults who have given these girls a more hopeful future.

TRAFFICKING IN PERSONS – INDIA

INDIA

As like-minded governments around the world join to abolish modern-day slavery in the 21st century, we encourage the Indian government to show leadership in acting against this human rights crime through more vigorous efforts to liberate the millions of Indians in bonded and forced labor and enslaved in the commercial sex trade. **The world's largest democracy should not also be known for being home to the world's largest number of slaves in the 21st century.**

BACKGROUND

India appears to have the largest population of TIP victims in the world, given the magnitude of numbers listed below:

- Existing NGO estimates of India's forced and bonded labor victims range from **10 to 40 million**.
- Existing NGO estimates of **sex trafficking victims in India** range from **200,000 to 1 million per year**.
- India is a **Tier 2 – Watch List** country in the 2005 Department of State (DOS) Trafficking In Persons (TIP) Report.
- The 2005 TIP Report states: “Numerous studies show that the vast **majority of females in the Indian commercial sex industry are currently victims of sexual servitude** or were originally trafficked into the sex trade.”
- Report further states; “India is also the home to **millions of victims of forced or bonded labor.**”

Trafficking challenges affecting women and girls in South Asia

South Asian women and girls are susceptible to trafficking for numerous reasons:

- Gender Imbalance/Feticide: Although feticide is illegal in India, it is widespread in certain areas especially those where male children are valued over girls. As a result, in some areas, a high percentage of female fetuses are aborted. This has led to a large gender gap in parts of India that has fueled demand for trafficked girls as brides and sex slaves. Girls are lured with the promise of a job and then sold as a bride in a state without enough young women.
- Gender Discrimination: Particularly among poorer families in India, Nepal, Pakistan, Afghanistan, and Bangladesh parents will keep girls out of school and encourage them to work or assist the family. Parents and community members pressure girls to take job opportunities in other cities or states and send money home. This combination of lack of education/literacy and

pressure to provide family income make girls vulnerable to traffickers (most victims are trafficked from rural to urban areas).

- Dowry: Although paying dowry is illegal in India, it is still widespread. The high cost that parents must pay to marry off their daughters has fueled a technique used widely by some traffickers. They will go into a village and tell parents they are in love with their daughters and are financially stable enough to forego any dowry. Under this scheme, the parents marry off their daughters and the “husbands” take them to a city and sell them into a brothel.

Regional TIP information

South Asia has the largest number of trafficking victims in the world.

- Trafficking of women and girls for sexual exploitation internally and across the region is a significant problem in India, Bangladesh, Pakistan, Nepal, Sri Lanka, and Afghanistan.
- In addition, millions of men, women and children are in debt bondage in India, Pakistan, Bangladesh, Pakistan, Nepal, and Afghanistan and exploited for generations to pay off a loan or debt.
- South Asia is also a source region for hundreds of thousands of women and men who are trafficked to the Middle East for domestic servitude or labor exploitation. The insurgencies and civil conflicts in Nepal and Sri Lanka have led to thousands of children being forcibly conscripted as child soldiers.

BACKGROUND

Disabled children in India are sometimes "hidden" by families, and poor parents often abandon them to street life. Services for such children are severely limited. It was the mission of Mother Teresa to care for those most marginalized and forgotten in society. This home, run by the Missionaries of Charity, is dedicated to youngsters with a range of disabilities – physical and emotional. Children with moderate disabilities are even attending schools for special children; for others, the sisters provide warm, compassionate, custodial care. In this safe environment, many children blossom to reach personal if very humble milestones: standing, walking, smiling, attending school, etc. For some, meeting basic needs is an achievement. The mission is small and the sisters live very modest, hard-working lives. No U.S. Government support is provided to the orphanage.

Missionaries of Charity

Mother Teresa came to India with the Sisters of Loreto, an Irish community of nuns with missions in India, where on May 24, 1931, she took her initial vows as a nun. From 1931 to 1948 Mother Teresa taught at St. Mary's High School in Calcutta, but the suffering and poverty she glimpsed outside the convent walls made such a deep impression on her that in 1948 she received permission from her superiors to leave the convent school and devote herself to working among the poorest of the poor in the slums of Calcutta.

On October 7, 1950, Mother Teresa started her own order, "The Missionaries of Charity" whose primary task was to love and care for those persons nobody was prepared to look after. In 1965 the Society became an International Religious Family by a decree of Pope Paul VI. Today the order comprises Active and Contemplative branches of Sisters and Brothers in many countries. They provide effective help to the poorest of the poor in a number of countries in Asia, Africa,

and Latin America, and they undertake relief work in the wake of natural catastrophes such as floods, epidemics, and famine, and for refugees. The order also has houses in North America, Europe and Australia, where they take care of destitute alcoholics, homeless, and AIDS sufferers.

In all, the Missionaries of Charity run 710 homes in 130 countries spanning 5 continents. Of these, 229 homes are located in India.

Jeevan Jyoti Home for Disabled Children

The Jeevan Jyoti ("Light of Life") Home for Disabled Children is run by the Missionaries of Charity, an order founded by Mother Teresa in 1950 that cares for the helpless. This Home is dedicated to caring for youngsters with a range of disabilities, both physical and emotional. The Home was established in 1988 on land that was donated by the Lieutenant Governor of Delhi and receives donations and support from the Catholic Church as well as private entities throughout the world.

There are 82 children who reside at the Home, many since birth. Some of the children have moderate disabilities and attend schools for special children outside the Home. Others, with more severe disabilities are provided warm, compassionate, custodial care by the Sisters. In this safe environment, many children blossom to reach personal if very humble milestones: standing, walking, smiling, attending school, etc. For some, meeting these basic needs is a major achievement. The mission is small with six sisters actively involved in caring for the children and they live very modest, hard-working lives.

FUNDING

There is no U.S. Government support to the orphanage.

NOTES

BIOGRAPHIES OF GREETERS

Sister Sabita (SA-BEE-TA), Regional Superior for Delhi Region, Missionaries of Charity

Sister Sabita joined the Missionaries of Charity in Calcutta (now, Kolkata) in 1972 at the age of 17. After completing three years of training she worked in South India (Madhurai) from 1975-1978, mainly caring for abandoned babies. From 1980-1981 she was assigned to Rome as a House Superior, after which she served as House Superior in the United States. She completed assignments in various cities including New York (Harlem) (1981-1982), Miami (1982-1985), Toronto (1985-1986), and again in New York (1986-1988). She was assigned as Regional Superior for the mid-west (Louisiana to Chicago) from 1988-1990. From 1991-1994 she served as the Regional Superior for Central America covering the countries of Panama, Costa Rica, Nicaragua, El Salvador, Guatemala and Honduras. In 1994 she transferred to the US, Washington DC, as a tutor for Sisters preparing for final vows. From 1996-1999, Sister Sabita served as the Regional Superior for the East Coast of Canada, including Toronto and Montreal.

From 1999-2001, Sister Sabita returned to India where she served till 2001 in the southern region. It was in 2001 that she was assigned as Regional Superior for Delhi. Her jurisdiction spans the states of Delhi, Haryana, Chandigarh, Punjab, Jammu and Kashmir. In all, she manages and supervises 15 shelter homes.

Sister Teresa Paul, Home Superior for the Jeevan Jyoti Home, Missionaries of Charity

Sister Teresa Paul joined the Missionaries of Charity in 1976 in Madras for her initial three-year training. From 1979-1980 she served in Calcutta (now Kolkata), caring for babies at the Children's Home. She served in the north-eastern state of Tripura from 1980 to 1983 and then went back to Kolkata for her final year of preparation and study. She transferred to the north-eastern state of Meghalaya where she served for two years from 1984-1986. From 1986-1990 Sister Teresa worked in Phirozpur, Punjab and from 1990-1992, in Jalandhar, also in Punjab. During this entire period, she primarily cared for babies and small children.

She was made House Superior in 1992 through an assignment to Jammu, three years after which she went to Kashmir where she served until 1998. Sister Teresa Paul came to Delhi for the first time in 1999 and worked for a year and then returned to Punjab for another three years, from 2000-2003. From 2004-2005, Sister Teresa supervised another home in Delhi, and was assigned to the Light of Life Home for Disabled Children in May of 2005 as House Superior.
