Despite the improved relations between Moscow and Washington and a treaty a year ago to reduce strategic warheads to below 2,000 on each side, Nunn said each country keeps about 4,000 warheads on alert. He said there has been no change because, "as long as Russia can launch nuclear ballistic missiles on short notice against the U.S., the U.S. must maintain a similar capability against Russia."

Powell, Sudanese Official Confer on War on Terrorism

Secretary of State Colin L. Powell met with Sudanese Foreign Minister Mustafa

Osman Ismail and discussed ways that Sudan could be removed from the U.S. list of state sponsors of terrorism.

With the exception of Syrian officials, it has been extremely rare for secretaries of state to meet with top diplomats from countries on the terrorism list. But the Bush administration has been pleased with steps Sudan has taken in the war on terrorism and in efforts to end a war with rebels.

Bill Would Forbid Schools From Requiring Medications

The House voted yesterday to prohibit schools from making children with behavioral problems take medication in order to

attend class.

Under the bill, passed 425 to 1, states receiving federal education money must make sure schools do not coerce parents into medicating their children.

"School personnel may have good intentions, but parents should never be required to decide between their child's education and keeping them off potentially harmful drugs," said Rep. Max Burns (R-Ga.), who sponsored the legislation.

In recent decades, more children have been diagnosed with attention deficit or hyperactivity disorders and prescribed drugs such as Ritalin or Adderall.

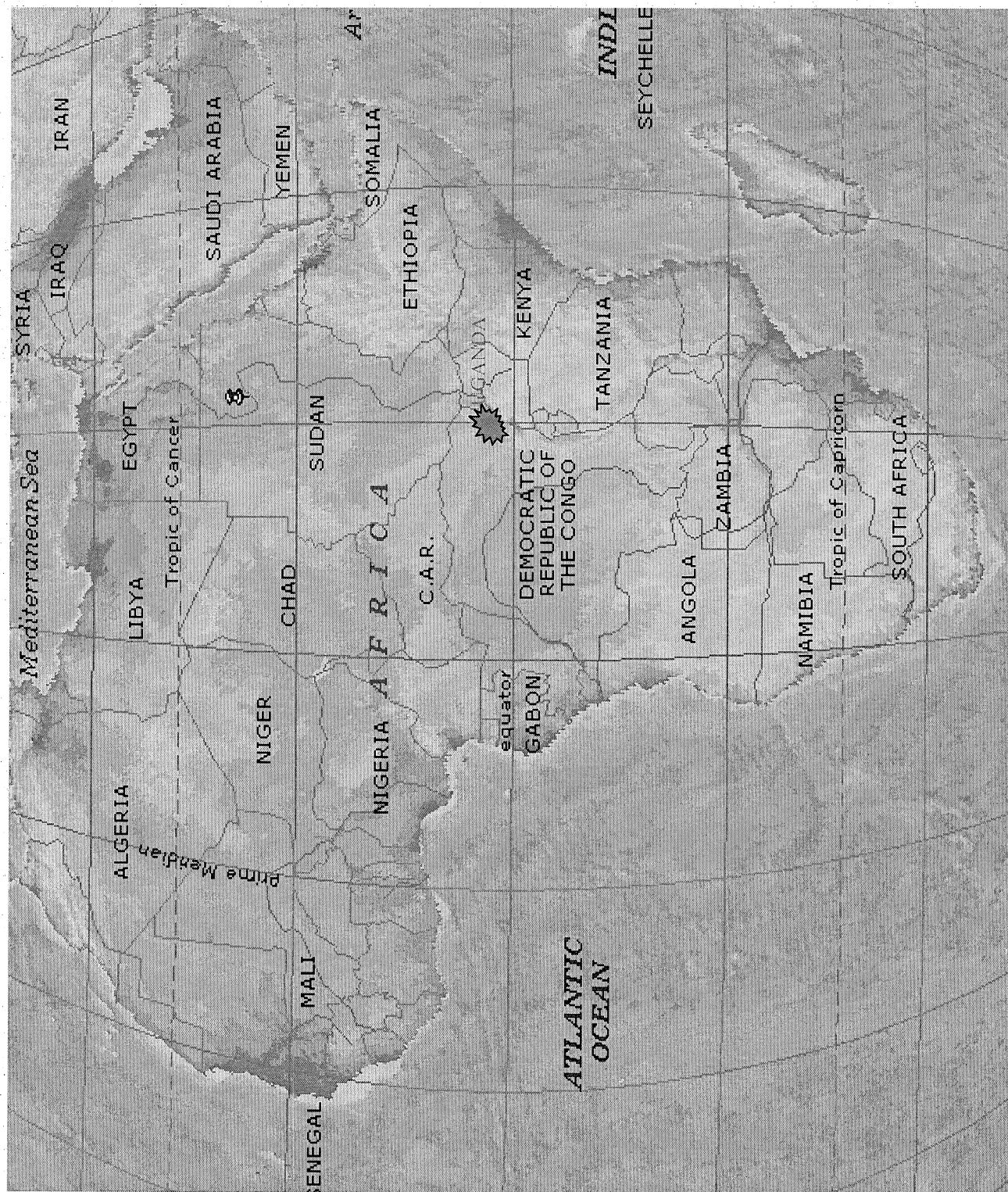

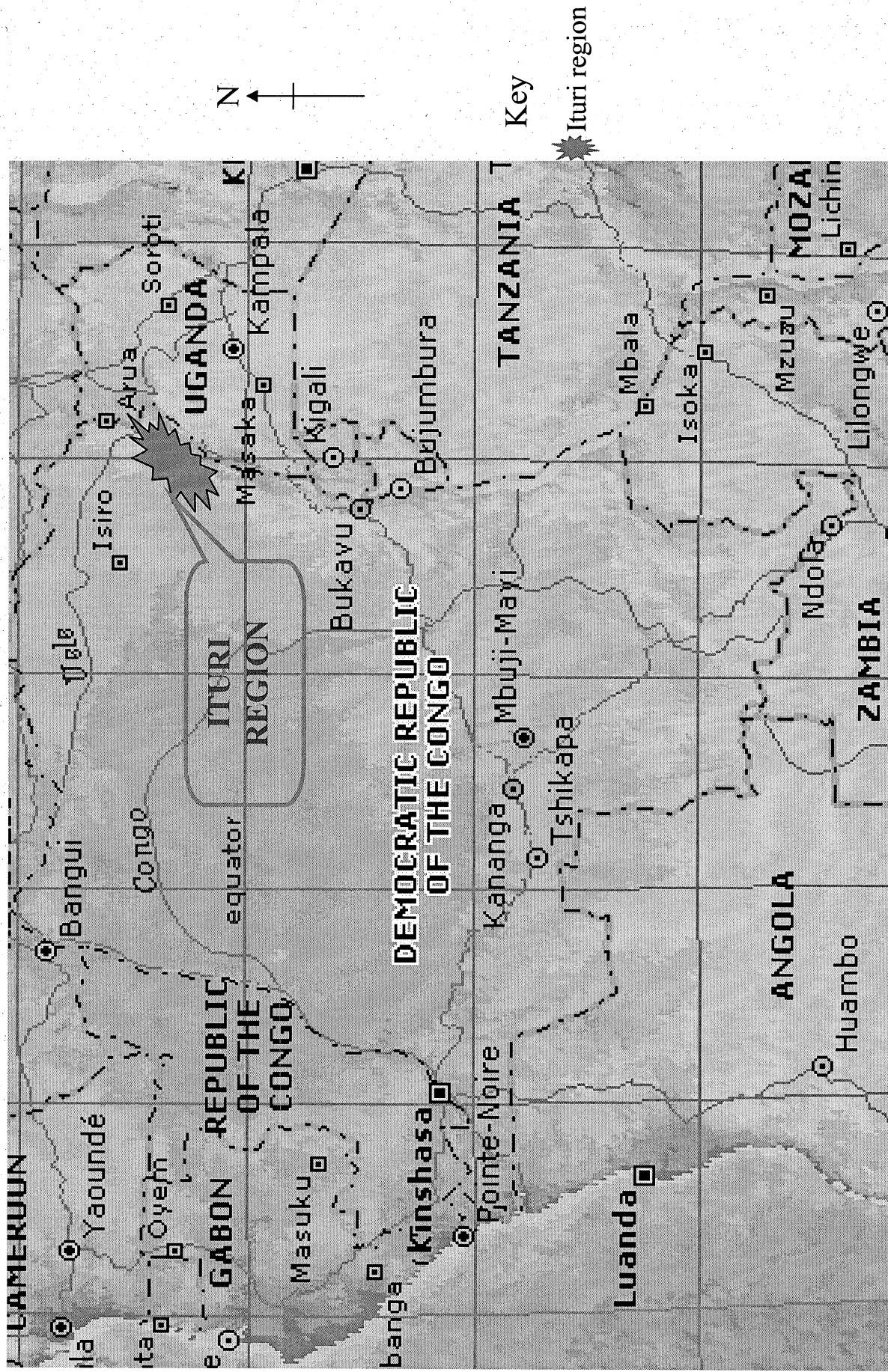

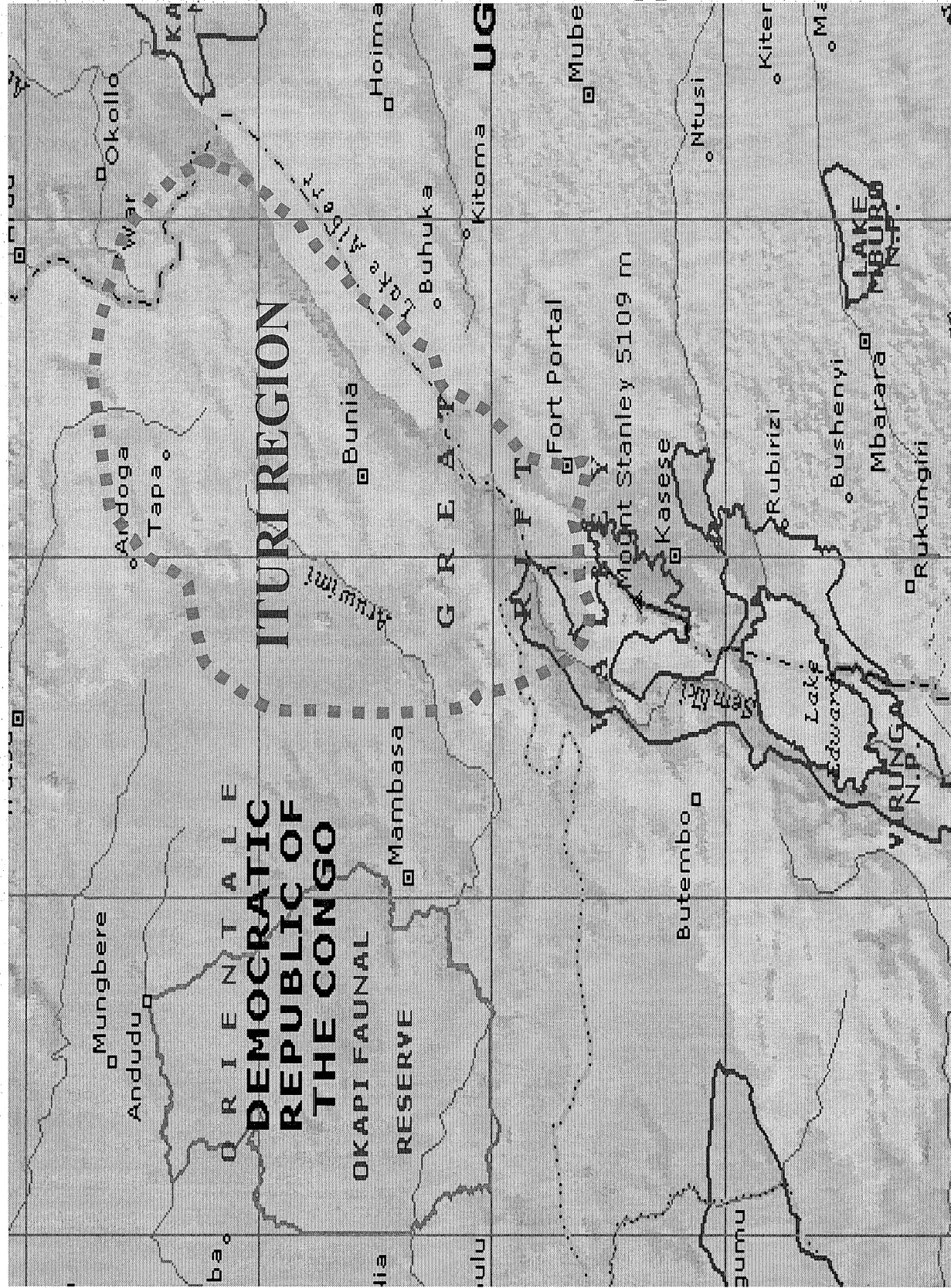


Ituri region

Today, I call for a new compact for global development, defined by new accountability for both rich and poor nations alike. Greater contributions from developed nations must be linked to greater responsibility from developing nations.

The goal is to provide people in developing nations the tools they need to seize the opportunities of the global economy. In return -- in return for this additional commitment, we expect nations to adopt the reforms and policies that make development effective and lasting.

Countries that live by these three broad standards -- ruling justly, investing in their people, and encouraging economic freedom -- will receive more aid from America. And, more importantly, over time, they will really no longer need it, because nations with sound laws and policies will attract more foreign investment.

This new compact for development can produce dramatic gains against poverty and suffering in the world.

"We must tie greater aid to political and legal and economic reforms. And by insisting on reform, we do the work of compassion. The United States will lead by example. I have proposed a 50-percent increase in our core development assistance over the next three budget years. Eventually, this will mean a \$5 billion annual increase over current levels.

These new funds will go into a new Millennium Challenge Account, devoted to projects in nations that govern justly, invest in their people, and encourage economic freedom."
