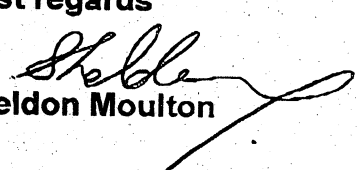
SUBJECT : ROUGH TRANSLATION OF THE DRC
AGREEMENT

Dear Dr. Frazier,

Rather, this represents an attempt to provide an understanding of the general principles and spirit upon which the agreement is based. Given the length of the original, and the time, we have translated the text of the agreement only and not the annexures thereto.
