VOTER REGISTRATION DEADLINE

Voter registration online or by mail ends October 6. In-person voter registration ends October 27.

IMPORTANT DATES:

Washington's 18-day voting period begins October 17. Ballots must be returned to a designated drop box or in person to your county elections department by 8 p.m. on Election Day. If returning by mail, ballots must be postmarked no later than Election Day.

Ballots will be mailed to voters by October 17. Make sure to carefully follow the instructions for completing your ballot. If you need a replacement ballot, contact your county elections department.
