

## Reading a Background Check Report

The first page of the report gives background on the SS#, where it was issued and where it has been used (for W-2 etc.) with addresses associated with it. This information can be cross referenced with any info the applicant gives on their work history if this is being used for employees. For those volunteering it can show if there may have been identity theft at some point in time.
