

## Travel to the Faroe Islands

(Updated on 26 August 2021)

Please note, that this website only provides information for travel to the Faroe Islands (Denmark). For information on travel to other countries, please consult the authorities there.

**When travelling to the Faroe Islands, you are entering the Kingdom of Denmark. This means that the rules for entering Denmark also apply to the Faroe Islands. Read the guidelines for entering Denmark/Faroe Islands [here](#).**

### Testing in connection with travel

It is recommended that travellers to the Faroe Islands test two days prior to departure to the Faroe Islands and two days after arrival to the Faroe Islands. PCR-tests are preferred if possible. Testing in the Faroe Islands is free of charge at the hospital test centre. People are strongly encouraged to be extra careful until the result from their second day test is available.

### Transit

If you have been in transit in an area, the colour category of your original country/region of departure applies when entering the Faroe Islands. Transit means that you have not been in contact with people in the country/region you are travelling through.

## Entry into Denmark

Various rules apply depending on how you arrive in Denmark. Requirements depend on whether you are travelling with a negative test, have been vaccinated or previously infected with COVID-19. The colour of your country of residence and where you are travelling from is also significant.

Even though the national COVID-19 restrictions were lifted in Denmark on the 10 September, the current entry restrictions will continue to apply.

The Danish travel restrictions classify all countries and regions into four colour categories: green, yellow, orange and red. These categories determine which rules apply to you when entering Denmark.

Currently, there is no test requirement before boarding an aircraft to Denmark. The test requirement before boarding can be re-introduced if countries or regions are categorised as red.

## Travel restrictions

You may be required to have a worthy purpose and to show proof of negative COVID-19 test upon arrival in Denmark.

## Test and isolation

Fully vaccinated people do not need to be tested before entry or upon arrival in Denmark\*. However, this does not apply if you have stayed in a red country or region within the last 10 days.

Persons arriving from yellow and orange countries or regions are required to get a test upon arrival if they are not fully vaccinated or previously infected. Persons arriving from red countries or regions are required to get a test upon arrival unless they are previously infected.
