## UPDATED LIST OF COUNTRIES UNDER THE GREEN, YELLOW, AND RED CATEGORIES

Relative to IATF-MEID Resolution Nos. 144-A and 144-B dated 14 October 2021, please be advised of the updated list of countries under the "Green", "Yellow", and "Red" categories and corresponding health and quarantine requirements, effective from 16 to 31 October 2021:

### TESTING AND QUARANTINE REQUIREMENTS

#### 1. For fully vaccinated passengers

##### A. For Foreign Nationals

- Negative RT-PCR test taken within seventy-two (72) hours prior to departure from country of origin; **AND**
- No facility-based quarantine required in arrival but are encouraged to undergo 14-day self-monitoring for symptoms.

##### B. For Filipinos

- Facility-based quarantine until release of negative RT-PCR test;  
**OR**
- No facility-based quarantine but shall be required of:
  - i. Negative RT-PCR test taken within seventy-two (72) hours prior to departure from country of origin; and
  - ii. 14-day self-monitoring for symptoms.

#### 2. For unvaccinated, partially vaccinated or individuals whose vaccination status cannot be validated, and those vaccinated but failed to comply the test-before-travel requirements

##### A. For Foreign Nationals

- Pre-booked facility/quarantine accommodation for at least six (6) days

##### B. For Filipinos

- Facility-based quarantine until the release of negative RT-PCR test on the 5th day

#### 3. For unvaccinated, partially vaccinated minor children travelling with fully vaccinated parent/s or guardians

- Quarantine requirements shall correspond with the vaccination status
- A parent/guardian shall accompany the minor until completion of the facility-based quarantine

### II. YELLOW LIST COUNTRIES

*All other countries/territories/jurisdictions not otherwise enlisted hereinabove.*

#### TESTING AND QUARANTINE REQUIREMENTS

##### 1. For fully vaccinated passengers

###### A. For Foreign Nationals

- Pre-booked facility/quarantine accommodation for at least six (6) days

###### B. For Filipinos

- Facility-based quarantine until the release of negative RT-PCR test on the 5th day

##### 2. For unvaccinated, partially vaccinated or individuals whose vaccination status cannot be validated by Philippine authorities as coming from Yellow List

###### A. For Foreign Nationals

- Pre-booked facility/quarantine accommodation for at least eight (8) days

###### B. For Filipinos

- Facility-based quarantine until the release of negative RT-PCR test on the 7th day

### III. RED LIST COUNTRY

#### Romania

All passengers coming from or who have been to the "Red List" country within the last fourteen (14) days shall not be allowed entry, EXCEPT, returning Filipinos via government-initiated, non-government-initiated, and Bayanihan repatriation flights subject to health and quarantine protocols:

1. Returning Filipinos shall undergo fourteen (14)-day quarantine [10-day facility-based and home quarantine until completion] and be required an RT-PCR test on the seventh day, with the date of arrival being the first day; and
2. Those who **transited or who have a mere lay-over at the airport of "Red List" country** (lay-over only at the airport and with no-immigration admission at said country) shall not be deemed as coming from this country.

### IV. PROOF OF VACCINATION REQUIREMENTS

Further, for validation purposes of vaccination status, the following shall be presented:

#### Passengers' Categories

- Overseas Filipino Workers (OFWs), their spouse, parent/s and/or children traveling with them, vaccinated in *Philippines* or abroad
- Non-OFWs vaccinated in *Philippines* or *abroad*
- Foreigners vaccinated in the *Philippines*

#### Proof of Vaccination Status

ANY of the following:

- VaxCertPH digital vaccination certificate;
- Bureau of Quarantine (BOQ) / World Health Organization (WHO)- issued International Certificate of Vaccination or Prophylaxis (ICV);
- National/state digital certificate of the foreign government where they were vaccinated abroad and has accepted VaxCertPH under reciprocal arrangement.

- Foreigners vaccinated *abroad*

WHO-issued ICV;

**OR**

National/State digital certificate of the foreign government which has accepted VaxCertPH under a reciprocal arrangement

Existing guidelines for arriving Section 9(e) visa holders and crew member/s shall still be observed.

The foregoing is without prejudice to the exercise of the mandate of the Bureau of Immigration in Arrival and Departure formalities.
