



## **Royalty Free Script License** (version 2020.1)

---

A license to use the purchased script is hereby granted to the person or company to whom the attached invoice is issued (hereinafter referred to as "the licensee" or "you"), or your nominated licensee.

You have permission to use the purchased script as outlined in our license terms below. This license is non-exclusive and non-transferable and may not be re-sold, given or hired to any third party, except when the license holder is a developer who is developing a product for his or her client. The developer may then hold the license on behalf of his or her client. There may be only one client per license.

### **1. Permitted uses of our scripts**

#### **Spoken-word audio recordings and videos**

You can use our scripts to create any kind of spoken-word audio recording or video. You may use our scripts repeatedly to create as many recordings and videos as you like and you may sell, stream or distribute an unlimited quantity of these recordings in as many online or offline locations as you like. This includes, but is not limited to, YouTube, Apple Music, Amazon, Spotify, CD / DVD productions and software applications.

If you create any products that incorporate our scripts you may distribute or sell those products at any price you choose. You can sell your products in as many formats as you like, anywhere in the world. You may also generate advertising revenue on videos that you create with our scripts (YouTube videos for example).

In other words, once you have created a product with our scripts, you are free to earn an unlimited amount of money from it for the rest of time, without ever paying us another cent.



### **Live streaming and video conferencing**

You can use our scripts to narrate any kind of real-time video conferencing or live streaming, for example, YouTube Live, Facebook Live, Twitch, Zoom and Skype.

### **Live narration to classrooms or clients**

You can narrate our scripts to an audience of any size, from one-to-one sessions with individual clients, to group gatherings of any size.

## **2. Prohibited uses of our scripts**

### **Distributing the scripts in text format**

You cannot publish, distribute or sell any document, either digitally or in print form, that contains any portion of our script content.

### **Distributing derivative works**

You are permitted to alter the content of our scripts in any way you like, however, altering a script does not give you legal ownership of that script. You cannot publish, distribute or sell our scripts in text format, regardless of how much you alter our scripts.

### **Sub-Licensing scripts**

Each script is licensed to just one person or business. It is illegal to use the same script repeatedly to create recordings and videos for multiple persons or businesses, even if you modify our scripts.

You may purchase our royalty free scripts on behalf of other persons or businesses, provided that you purchase a script for each and every person or business for whom you create recordings or videos.

### **Royalty free recordings and videos**

You cannot use our scripts to create recordings or videos for distribution via any kind of royalty free library, stock library or production library.



### 3. Providing a Credit

You are not required to publish a credit, however it is traditional (and greatly appreciated) for you to credit The Guided Meditation Site as the source of your script. Here are some examples of how to publish a credit.

#### YouTube and Other Online Video Credit

You can add a credit in the video description. For example:

"Meditation script source: The Guided Meditation Site. <https://www.the-guided-meditation-site.com>"

#### Film / TV Production Credit

Simply place the following in the closing credits:

"Meditation script source: The Guided Meditation Site."

#### CD / DVD Credit

Simply publish a written credit on the CD/DVD insert and/or on the back cover.

"Meditation script source: The Guided Meditation Site."

#### Video Conference / Live stream Credit

A credit is not required for live, online broadcasts, however if you are feeling generous we would be grateful if you would mention in your broadcast that your script was sourced from The Guided Meditation Site.

### 4. Editing scripts

You can edit our scripts as much as you like, by removing, replacing or adding content of your own. You also have the right to create recordings and videos with modified versions of our scripts.

However, please note that purchasing or modifying our scripts does not impart any ownership of our scripts to you. You do not own our scripts, this license simply provides you



with permission to use our scripts. Any modified versions of our scripts remain subject to the terms of this license agreement.

## 5. Transporting scripts

If you need to send a script to another person, you are free to do so via any means at your disposal. For example, you may email them or transfer them via online file transfer services. Please take care: you may only send scripts to persons who are directly involved in the development of your products or projects. Please take all reasonable measures to prevent unauthorized copying and distribution of our scripts.

## 6. License fees

Once your initial payment is received you will not have to pay any ongoing fees of any type.

## 7. Duration of license

This license has no expiry date. Provided that your payment is received in full and excepting any instance in which you breach the terms of this license agreement, you can continue to use our scripts indefinitely.

## 8. Grant of license

This script license is granted to one person, or to one business entity. If the purchaser is purchasing a script on behalf of a third party (the nominated licensee), the purchaser hereby represents and warrants that:

- (i) the purchaser is authorized to act as an agent on behalf of the licensee and has full power and authority to bind the licensee to this agreement; and
- (ii) if the licensee subsequently disputes such power or authority, the purchaser shall be bound and liable for any failure of the licensee to comply with the terms of this license.



## 9. Intellectual Property and Copyright

The Guided Meditation Site is owned and operated by Spire Audio (the licensor). Any royalty free script purchased by you from this website is licensed to you by Spire Audio and its copyright is protected by Australian copyright law and international treaty provisions. Except for your limited right to use our scripts, Spire Audio shall have and shall retain the entire right, title and interest in and to all intellectual property rights arising from or relating to the scripts and all copies thereof. No ownership or copyright in any script shall pass to you by the issuance of this license.

## 10. Warranty and Limitation of Liability

Spire Audio warrants that (a) it has the necessary rights and authority to grant you the rights outlined in this license; and (b) your use of our scripts in accordance with the terms outlined in this license, excluding any modifications made by you, will not infringe on any copyright, moral right, trademark or other intellectual property rights. Spire Audio does not make any other warranties, express or implied, regarding the scripts, including, without limitation, any implied warranties of merchantability or fitness for a particular purpose. Spire Audio shall not be liable to you or any other person or entity for any punitive, special, indirect, consequential, incidental or other similar damages, costs or losses arising out of your use of the scripts, even if Spire Audio has been advised of the possibility of such damages, costs or losses. Nor shall Spire Audio be liable for any damages, costs or losses arising as a result of modifications made to the scripts by you or the context in which the scripts are used in your work. Spire Audio's liability shall in no event exceed the actual price paid for the license.

## 11. Indemnification

You shall indemnify, defend and hold the licensor harmless from any and all claims, losses, costs, damages and expenses resulting from or arising out of: (a) your breach of this agreement; (b) your unauthorised use of the scripts; (c) your activities after the licensor has notified you that such activities may result in the infringement of the intellectual property



rights of any third party; or (d) any claim that the script or the use thereof infringes upon, misappropriates or violates any patents, copyrights, trademarks, trade secret rights or other proprietary rights of a third party.

## 12. Unauthorised Use and Termination

Any use of our scripts in a manner not expressly authorised by these license terms (including, without limitation, use of the script by more than one (1) user without the purchase of additional licenses) constitutes copyright infringement, entitling Spire Audio to exercise all rights and remedies available to it under copyright laws throughout the world. Spire Audio shall have the right to terminate your right to use our scripts immediately upon your breach of these license terms. Upon termination, you shall cease using the scripts and shall delete or destroy all copies of the scripts and any media productions that you created using the scripts. Termination of your rights shall not limit Spire Audio from pursuing any other remedies available to it, including, but not limited to, injunctive relief, nor shall termination relieve you of your obligations to pay Spire Audio any applicable license fees. You shall be responsible for any damages resulting from any such copyright infringement, including any claims by a third party.

## 13. Privacy

We take our customers' privacy seriously. At no time will your personal details or e-mail address be passed onto any other company. We do not see, nor do we retain any financial data such as credit card numbers. These are gathered and processed securely by our e-commerce partners, such as PayPal.

## 14. Refund Policy

Please choose your scripts carefully. Like most other online shops that sell downloadable products, it is not possible for us to refund or exchange any script that has already been downloaded. Once the download has taken place, the purchase is final.
