Audit Key Background

- AAHomecare created the Audit Key—a free, web-based survey to quantify the impacts of audits and appeals to present compelling data to encourage change.
 - Suppliers use AAHomecare's online survey application, Audit Key (accessed at WWW.HMEAuditKey.org), to submit their data with audit and appeal experience.
 - Survey questions are designed to collect *cumulative* Audit and Appeal experience data beginning with activity in the 4th quarter of 2015.

Executive Summary


- This is the third quarter of data which includes audit and appeal information from 10/1/15 through 06/30/16




Medicare (FFS) Prepayment Audit Activity Analysis

Interesting to note the % of ADRS denied with 3rd quarter data is more aligned across supplier size.






DME MAC Prepay Audits:










Medicare (FFS) Post Payment SMRC Audit Activity Analysis
