Kansas District Court Creates Family Settlement Conference Program

The Sedgwick County District Court in Kansas recently started a judicial settlement conference program for family law cases. According to *The Wichita Eagle*, settlement conferences are held at the parties' request. The trial judge for the case may not facilitate the settlement conference. At the conference, the judge hears each side of the case and advises the parties on the likely outcome of a trial. The court also provides mediation services for family law cases.

Florida Foreclosure Mediation Programs Report Lackluster Results

A year after the Florida Supreme Court ordered all circuit courts in the state to establish foreclosure mediation programs, an interim report by the Court's Committee on ADR Rules and Policy revealed that the state's longest-running programs are struggling to bring homeowners to the mediation table. The report includes data collected from March-June 2010. Although 20 circuit courts currently have foreclosure mediation programs, only seven were in effect during that time period. The seven programs received a total of 13,417 case referrals, but were only able to contact borrowers in 5,919 (44%) cases. Of those cases where borrowers were contacted, mediations were conducted for 2,250 cases (38%). Settlement was reached in 34% of mediations. Since more than half of the state's programs were excluded from the report, the Committee concluded that it didn't have sufficient data to evaluate the program model. The Committee recommended "continuing the Program for a sufficient amount of time to capture enough statistics to create 'critical mass' in terms of statistical validity." The Committee also recommended that courts determine the effect the programs are having on their workloads.

New Research from RSI

Evaluation Finds Cook County Child Protection Mediation and Facilitation Program Helping Families

Mediation in Illinois' Cook County Circuit Court Child Protection Mediation and Facilitation Program provides the family of children in state custody with the first opportunity to voice their concerns, feel heard and discuss their children's future. This was one of the major findings of an evaluation RSI conducted of the program, which serves Chicago and its surrounding suburbs. The study looked at three areas: program performance, program process, and stakeholder assessment of mediation and understanding of its role and function within the child protection system.

The study, [Child Protection Mediation: An Evaluation of Services Provided by Cook County Juvenile Court](#) (2010), included data from 164 cases referred to mediation, as well as interviews of mediation participants, judges, attorneys and program staff. Participants, particularly family members, have very positive reactions to the program. However, very few are given the opportunity to experience it. Judges and hearing officers see the value in the program, but do not often make referrals to it. The majority of judges and attorneys interviewed believed mediation could occur early on, but almost always referred cases to the program after the disposition hearing (generally two years after the children were brought into the system). This is the paradox of the program. It works well, is well-regarded by almost everyone, and the participant families find it to be a rewarding experience, but it is underutilized.

The program, similar to other programs [across](#) the country, would require a homeowner to meet with a housing counselor prior to mediation. It also requires lenders to [participate before finalizing](#) a foreclosure. In the mediation, the homeowner and lender could seek '[commercially reasonable alternatives to foreclosure](#).'"
