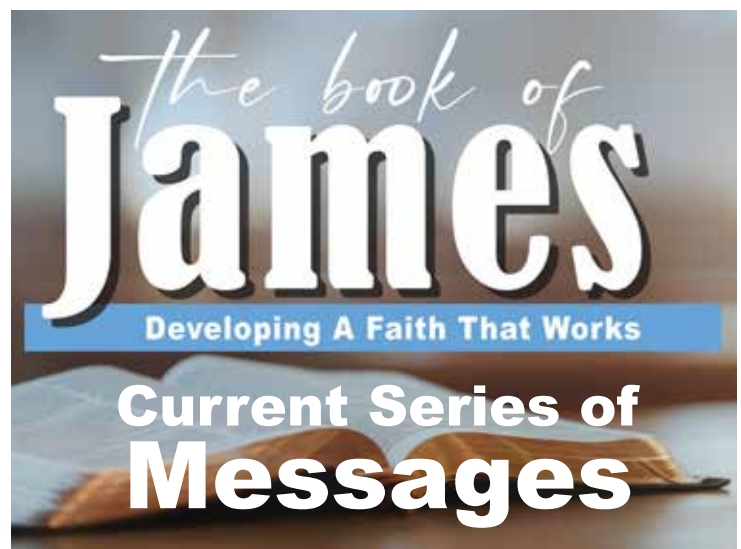
## A CALL TO PRAYER
