There will be a congregational meeting this Sunday, March 26, after the 10:30 a.m. service

We will be voting on the proposal to proceed to the construction phase of the new education building project to serve our congregation as well as generations to come.

On Tuesday, March 14, the church board reviewed the results of this capital campaign which raised more than \$230,000 in estimated giving towards the project. This brings our total funds for this replacement structure to over 1.5 million dollars. According to our builder's estimate, we still need roughly another \$250,000 for the project.

After prayerful consideration, the board unanimously recommended seeking congregational approval to step out in faith and begin the building process, which includes seeking approval to acquire financing as needed to meet what we expect to be the cost of the project.

This Design-Build proposal, presented by Joe Petty of Petty Construction Company, is a long-awaited and opportunity-filled step for our church.

There is still time to participate in the capital campaign, either by an estimate of future giving for the project or by a direct gift. And it is always time to be in prayer for the project and the blessing it can be for our church and our community as we continue to share the good news of Jesus Christ.

Excerpts from March 14, 2023 Church Board Minutes

Call to order at 6:02PM by Moderator Brad Losch. Elder Matt Saxe gave the opening devotion and prayer. Minutes from the February 14, 2023, meeting were approved by general consensus.

Pastor's Report: Ministers report was attached. Pastor Michael highlighted he is in Holy Week prep and the building project. He said they are still working on the fire alarm system. He stated the capital campaign pledges are at \$235,686 which puts us at a total of \$1,559,353 and roughly short \$250,000 for the \$1.8 million that is needed. He also stated that regular offerings were down this past week. He reminded everyone that BJ Leonard would be here this Sunday to discuss his upcoming mission trip to Kenya.

Treasurer: Michelle Hart submitted a report and presented information from the report– as of February 28, 2023. The transfer to the building fund in February was \$9,868.60. Total Funds Available for Construction/Renovation \$1,330,862.67.

Trustees: Dan Speckhart submitted a Trustee Report. Brad Losch highlighted that the Trustees decided to stay with our current insurance policy. He also added that on today's date Dan had renewed 7 of the 1-3 month CDs at an interest rate of 4.5-5%. Hamer Tate made a motion to approve the Trustee Report and Steve Tharp seconded. Passed unanimously.

Christian Education: Rodney Gordley submitted a report and added the youth are prepping for the Sunrise Service. The Sunrise Service will be at 6:30am in the gym with breakfast to follow. Then there will be a 10:00am service. Sunday School will be at 8:45am. Pastor Michael added they are looking to add a toddler room for late service instead of those children going to either the nursery or Children's Church.

Music: Kayla Boren submitted a report. In full prep for Holy Week services. She stated this year the bell choir will not perform at Easter but will perform for Memorial Day weekend.

Crossroads Center: Shari Clark submitted a report. Pastor Michael and Rebecca wanted to discuss a request by Pikeland School District. Pikeland is in preparation for an evacuation drill. It was also discussed that pickle ball is picking up quickly in the area and people are playing it in Crossroads. To do pickle ball lines, it will cost \$400 per court that is set up.

Building Team: We are currently short \$250,000 from the goal of \$1.8 million. The pros and cons of moving forward now were discussed with highlights being that there is momentum now, we have already come so far, the campaign pledges were really inspiring and surprising how quickly so many were willing to give, we will continue to get additional funds through the CDs we are collecting interest on and renewing every 1-3 months, and we can contribute sweat equity. Helen Earls made a motion to move forward with the plan and present it to the congregation for approval and that we may have to borrow up to \$250,000. Judy Ferguson seconded the motion. The motion passed unanimously. Pastor Michael reminded everyone there is open prayer time in the sanctuary on Wednesdays to continue praying over the project. It was decided that a Congregational Meeting would be held on March 26, 2023 after the late service.

Old Business: Wayne and Cindy Chamberlain were present to discuss upcoming mission projects. There is now a mission board in the church that Cindy put together. Brian Ruebush made the board. She has included seven mission, pictures of places she went in Poland and some information on Pioneer Bible Translators. Pastor Michael will be going on one of the upcoming missions to Poland with Disciple Heritage Foundation.

The Motion to Adjourn was made by Judy Ferguson and seconded by Leecia Carnes. The motion passed unanimously and the meeting adjourned at 7:09PM. Pastor Michael gave the closing prayer.
