The hybrid in-person and Zoom meeting began at 5:30 PM.

1. Check-In and Opening Prayer (Rev. Neil Willard)

Neil invited personal updates and opened the meeting with Evening Prayer (Book of Common Prayer, p. 109).

2. Review and Approval of Consensus Items (Rev. Neil Willard)

Minutes from the July 15, 2025 Vestry meeting, the Financial Summary from Jessica Evans (Finance Manager), and reports from the Congregational and Community Engagement Council, Facilities and Grounds Council, Finance Council, Membership Council, Outreach Council, Pastoral Care Council, Stewardship Council, Worship Council, Senior Warden, and Rector were unanimously approved.

3. Facilities and Grounds Council Report (Kip Krause)

- Arrangements are being made to obtain a comprehensive structural engineering assessment of Palmer's campus, with itemized cost estimates for all needed repairs (including foundation and roof work).
- The council aims to complete this assessment by February 2026.

4. Finance Council Report (Dick Viebig)

- Year-to-date, 66% of pledged funds have been received. If this rate continues, the budget should be balanced at year's end.
- 75% of regular funds have been moved to Texas Gulf Bank (FDIC insured); 25% remain in CDARS (also FDIC insured). These changes will generate \$16K annually in interest income.
- The rectory mortgage has been refinanced through Texas Gulf Bank at a lower interest rate, saving Palmer \$13K annually.
- Palmer currently maintains about 30 restricted accounts for various causes.
 - To date, 5 accounts have been consolidated and the vestry unanimously approved those consolidations:
 - Episcopal Church Women Fund + Women's Retreat Fund
 - Prison Ministry Fund + Palmers Assisting Re-entry Fund
 - Angel Tree Fund + Salvation Army Fund supporting Angel Tree
 - Palmer Place Fund + Ronald McDonald House Fund
 - Building Insurance Fund + Buildings & Grounds Fund
 - A motion was unanimously approved authorizing the Finance Council to continue reviewing accounts, contact associated donors, and—if donor permission is granted—consolidate additional funds where appropriate.

5. Stewardship Council Report (Ken Alexander)

- Stewardship Kick-Off Sunday will be held on September 21, 2025, alongside a Warden's Forum.
- Some expenses are currently funded outside the regular budget (e.g., garage parking, salary for the Director of Parish Life and Membership). These need to be incorporated into the budget over time, as donor support is temporary.

- For the 2026 fiscal year, the Finance Council projects \$1.9 million in expenses (an increase from the \$1.72 million pledged for 2025).
- Covenant Sunday will be observed on November 16, 2025.

6. Senior Warden's Report (Tom Van Arsdel)

- Warden's Forum scheduled for September 21, 2025.
- Vestry meeting minutes will be posted on the Palmer website within 21 days of each meeting.
- A motion was unanimously approved to hold the Annual Parish Meeting on February 1, 2026.
- Vestry candidate videos will be released in January 2026.
- A Meet the Vestry Candidates Forum will be held on January 18, 2026.
- Tentative date for the Vestry Retreat is February 21, 2026.
- The Nominating Committee will hold its first meeting in October 2025.
- A special vestry meeting will be held on October 14, 2025 to:
 - o Provide an update on the comprehensive Building and Grounds assessment
 - Begin planning for Palmer's 100th Anniversary Celebration in 2029

New Priest – Allen Junek! He is moving in tomorrow (8/8) and will take a little time to get settled. First Sunday will be Aug 24. On 8/31, Allen will visit at the education hour.

Music Updates:

Choir will begin processing again.

Margie is wondering about bringing back Summer Choir, when anyone could show up in the morning and sing in the choir.

Service Updates:

Aug 10 will be the first test of the frozen bread. (MD-seemed to go well, loaf is small for 190 people, but better to go to wafers than have too much bread if we had used 2 loaves. Smaller pieces of bread would help a lot. Mary and Allen will need to learn bread manipulation. Bread texture and taste was good after thawing)

We will go back to Rite I on Nov 30, start of Advent.

Dustin needs to know about the Psalm sound levels. Also, sometimes the service can be heard over the speakers in the narthex and sometimes not.

Gospel procession – save it for Christmas eve, late service and Easter Day at 11:00. Otherwise we will continue to read the gospel from the pulpit, censing the book there to reduce resistance to incense.

Taize Service – Recommend that David follow up with Beth Ann. Brief discussion was held about "voluntolding" groups like the youth or Canterbury. If Canterbury is not interested, we can look for interested parishioners to host the Taize service.

Neil requested that we hold the service for Blessing of the Animals one week later on October 12th as most clergy will be away on October 5th.

Music Updates -

Service Updates -

Issues on Sound System – #1 - Dustin believes there is not a great way to remedy the Psalmist being louder. The mics in the area are adjusted to balance the choir voices and the pipe organ.

Because of the placement of the choir in proximity to the pipes, adjusting the gain would make the audio peak as soon as the organ starts playing (for online audio).

We draw from a limited number of resources, many of our parishioners volunteer again and again for multiple ministries and may become weary. And some ministries draw on volunteers who are aging. We need to find an effective way to attract more people with emphasis on newcomers as we celebrate new growth in the parish community. COVID interrupted momentum and a lack of centralized leadership for several years for outreach left individual ministries operating independently. A major focus should be on creating Palmer's outreach identity in the community.

Current Outreach at Palmer: Discussion

- Serve Sunday should be a ministry category in itself and include the organizations served as we work to optimize our relationships with community institutions.
- Community of Hope should move to pastoral
- Current status of Yellowstone Academy is unclear. Would this be a meaningful opportunity for Palmer youths?
- We will change refugee resettlement to migration
- Identify other ministries: e.g. Emergency Aid Coalition (Palmer used to be represented on EAC board), Alternative Gift Giving, Salvation Army Christmas gift giving

Meeting Roles: Sue Howard will chair, Jenn Macia will be secretary

Adopt Procedures for Collaborative Planning: Discussion

- Become involved in planning monthly outreach partner conversations during the Sunday Adult Formation Hour
- Become involved with planning and participation in Ministry Fair.
- Increase the number of Serve Sundays to nourish relationships with community organizations we support.

4. Updates on regular priority items

- a. Fellowship Hall water leak found in ceiling near East stairway.
 - i. Not due to a roof leak, could be either condensation on <u>chill</u> water pipe or could be leak in pipe. MLN will inspect the pipe to determine source. We are still waiting for their review; however, it appears to be a pipe insulation issue, not a pipe leak issue. Inspection due within the next month or so.
- b. Choir Room Leak ceiling tile collapsed onto cabinets and materials, but piano not affected. Not a roof leak, but due to condensation from A/C and backup in main drain and auxiliary drain. ACTION: Gerry to clear out drain lines and schedule regular maintenance of same. Will also consult with MLN for alternative solutions.
- c. Rectory
 - i. Soft spot under the tiles in Rectory propose to defer action into 2026 budget (to be shared with Finance Comm when 2026 Budget process begins)
 - ii. Rectory foundation issues (?)
- d. St. Bedes Chapel –The chapel itself remains comfortable for large groups. We have a quote of \$11-\$12k to repair Air Handler, but the group feels that a full replacement of the air handler is a better approach, and we will seek a full quote before moving forward. Consider deferring to 2026 budget if the situation does not worsen further. Received a quote for full replacement of air handler (\$42k); issue remains how best move old equipment out and new equipment in.
- 5. Fresh Air Intake Fan Done!!
- Stained Glass window in front of the church appears to be unlit most of the time. Gerry to check timer settings for LED lighting; Michael will be sure to drive by after dark to check if the lights are working again. – Done: lighting is working and looks great.
- 7. Campus Maintenance Strategic Planning

The group discussed the need for a strategic, long-term approach to address facility maintenance issues, with Michael suggesting that a capital campaign may be necessary due to the scale and age of the problems. They agreed to work with Cavalry Construction to develop a comprehensive strategic plan for the campus, with a focus on clear communication about specific needs and expectations. The conversation ended with a recognition of the growing challenges and the importance of persistent, detailed planning. Action steps include:

- 1. Let's document what scope of work has been addressed by Cavalry to date
- 2. Gerry: Locate and share the previous capital expenditure spreadsheet from Tara showing 5 and 10year predictions
- 3. Gerry: Provide Cavalry with clear, technically detailed requirements for their assessment

Senior Warden Report

For the September 16, 2025 Vestry Meeting

1. Parish Councils

a. We have assigned Vestry members to the Vestry Councils. The only remaining council to be officially launched is the Pastoral Care council, which will be headed by the Rev. Allen Junek. Invitations to serve on that council will be going out in the next few weeks.

2. Parking

a. Over the summer, the Memorial Hermann Medical Plaza Garage has been used less than it was in April and May, which is expected given the lower attendance during summer months. We continue to collect data on the parking usage to evaluate our costs going forward.

3. Buildings and Grounds

- a. We have been working with Cavalry Construction to provide a satisfactory, complete assessment of the repair needs of the campus. We have made progress but are still not quite to a point where we have what we need. The buildings and grounds council is singularly focused on this task.
- b. Members of the council conducted their own walkaround with Gerry Sandoval to eyeball as much of the pressing repair needs as possible. We identified a few repairs and maintenance items that can move ahead in the near term.

4. Facility Sharing Agreements

- a. Review of all agreements (GISH, Archway and PDAP) are in review with the other parties to be current through summer 2025. Sue Howard has completed interviews with the principals of our tenants, and we have the groundwork for renegotiating and renewing those agreements.
- 5. Pam Harvey has accepted our invitation to serve as the Treasurer, and that nomination has been confirmed unanimously by the Vestry
- 6. Warden's Forum We conducted a Warden's Forum on July 20 following the 10 o'clock service
- 7. Jim Rosenbach was elected to the board of the Palmer Endowment, and will serve as Chair of that Board.
- 8. Serve Sunday August 24 was Serve Sunday and we received many accounts of high Palmer turnout, good community engagement, and enthusiasm for more opportunities to serve

9. Strategic Plan Updates

The following are updates on our Strategic Plan initiatives, reflecting actions taken since the Vestry's special meeting in April:

- a. Working Groups statuses are noted below
 - i. People Strategy
 - 1. Processes for Personnel related Objectives were reviewed, and most objectives are already in place, or will happen later this calendar year.
 - 2. Membership of Parish Councils have been largely formed. See update above regarding the Pastoral Care council.
 - 3. We will be populating the Vestry page with photos and short bios.

This work has been assigned to the Communications council.

- 4. We will brainstorm ways to thank our volunteers in a more engaging and meaningful way
- 5. Along with the church staff, we will plan and execute events that serve as a "side door" introduction to Palmer
- 6. Our new Associate Rector, Allen Junek, and Deacon, Mary Reddick, and now on staff

ii. Place Strategy

- 1. Campus Improvements and Maintenance (Master Plan)
 - a. The Facilities and Grounds Council is gathering estimates from Cavalry Construction – paid for by the Diocese of Texas – and are working to ensure those estimates meet the scope of work the Council envisions for the premises. See the Facilities and Grounds minutes and reports for ongoing updates.

2. Safety

 a. A small working group, including members of the staff, met with Jack Harvey to discuss his recommendations. Several follow-up items were identified and are currently in process. Jack presented on this topic at the 9 o'clock hour on June 22.

iii. Program Strategy

- Membership of Parish Councils has been reviewed, and new members have been identified and invited to join. These councils include Membership, Parish Life (aka Congressional / Community Engagement), Christian Formation and Outreach.
 - a. Strategic Plan initiatives with these groups are in process.
- 2. These are related to the People strategies

iv. Pay Strategy

- 1. The formal objectives of this strategy are to be launched with the Finance and Stewardship Councils
 - a. These objectives are a part of their regular discussion
- 2. Earned Revenue
- 3. Donated Revenue

Under the purview of the Stewardship Committee.

- a. Many of the tactics noted are already in the prevue of this committee.
- 4. Increase Operating Reserves
 - This Objective includes Year 2 tactics, so will not be addressed until Earned Revenue and Donated Revenue Objectives are established

The Rector's Report for the Sept. 2025 Vestry Meeting from the Rev'd Neil Alan Willard

- 1. On Sunday, August 10, we welcomed to Palmer the Rev'd Mary Reddick who has been appointed by the Bishop of the Episcopal Diocese of Texas to serve as a deacon in our congregation. She will be facilitating the Tuesday morning women's Bible study, the Tuesday afternoon women's Bible study, and the work of the Outreach Council. You'll often see her in worship not only at 10:00 AM but also at 8:00 AM.
- 2. On Sunday, August 24, we welcomed to Palmer the Rev'd Allen Junek as our new Associate Rector. The following Sunday, August 31, I facilitated a conversation with Allen in St. Bede's Chapel during the 9:00 AM education hour. The Sunday after that, September 7, he gave his first sermon here. Allen will be the "conductor" for our pastoral care ministries and facilitate the work of the newly formed Pastoral Care Council. He will also be teaching part of a series on Thursday nights this fall.
- 3. During the month of September, we will welcome to Palmer our new Associate Organist, who is Laura Smith. So please be sure to greet her warmly this month.
- 4. On Sunday, August 10, part of the Jerusalem Peacebuilders group (Jewish, Christian, and Muslim teenagers, mostly from Israel/Palestine) that came to Houston this summer attended worship at Palmer. That evening, as we have done in the past, the entire Jerusalem Peacebuilders group led an interfaith service at Palmer, offering personal reflections on their experiences at Camp Allen over the previous week, sharing songs that they wrote together about those experiences, and sitting at tables in the Parish Hall with Palmers and other guests during a festive meal after that interfaith service. This was the most challenging year ever to run this program.
- 5. On Sunday, September 14, with the permission of the Bishop of the Episcopal Diocese of Texas, we will have a guest preacher, Dr. Elias Farah, who is the new executive director of Jerusalem Peacebuilders and a practicing Maronite Christian.
- 6. There is also a new face in the Houston office of Jerusalem Peacebuilders, located near my study at Palmer, since the Rev'd Will Parker has moved on to full-time parish ministry. The new Houston educator/site-coordinator in that office is Blake Burns.
- 7. On Thursday, August 21, I officially completed the video and live trainings required by the Episcopal Diocese of Texas to extend my certification, required as a member of the clergy, in Safeguarding God's Children (Policies for the Protection of Children and Youth), Safeguarding God's People (Policies for Safe Ministry with Adults), and Safeguarding God's People in the Workplace (Policies Prohibiting Sexual Harassment).
- 8. On Tuesday, September 9, I attended an event at Rice University's Baker Institute for Public Policy. It was titled "Science Under Siege: A Conversation With Dr. Peter Hotez & Dr. Michael Mann." As most of you know, Dr. Hotez is a vaccine researcher and a physician-scientist. He was often on national media during the height of the COVID-19 global pandemic, and I recently heard him being interviewed on NPR

while on my daily commute. I've interacted with him previously on social media, and he knows we pray for him and his colleagues in the Texas Medical Center each Sunday in worship. After this event, I was just quickly going to introduce myself formally, shake his hand, and thank him for what he does. But he must of guessed who I was when he saw my clerical collar because he walked toward me, stretched out his arm to give me a hug, and thanked me for always being supportive of him. I also had an extensive conversation with a young Hindu from India who sat at my table, wanted to discuss how I understood the relationship between religion and science, and was very curious about how I deal with the personal pain that people bring to me when they talk to me about their lives. It was an interesting afternoon.

- 9. On Monday, August 25, I attended a breakfast for Christian clergy at Holocaust Museum Houston. Among those present who had also been invited were a priest from Trinity Episcopal Church in Midtown, Bishop Andy Doyle of the Episcopal Diocese of Texas, the outgoing Lutheran bishop (ELCA) and several Lutheran pastors (ELCA), and other local clergy from Houston. This was an opportunity to meet the new CEO of the museum, Gary Weisserman, who is a longtime Jewish educator and son-in-law of a Holocaust survivor. It was also an opportunity to provide feedback about awareness of the museum and how the museum could become a leading voice for human rights within the community of Houston.
- 10. As most of you know, conversations and presentations in St. Bede's Chapel during the 9:00 AM education hour on Sundays continued throughout the summer, making that a year-round offering. Also during the summer months, the Holy Cross Children's Room was open and available for households who wanted to use that space during the 9:00 AM education hour, but many households gathered on the playground each Sunday after the 10:00 AM Choral Eucharist. Other year-round offerings include "Liturgy Prep" for young children during the sermon and prayers at the 10:00 AM Choral Eucharist and "Reel Theology" on Zoom on the evening of the first Sunday of each month to discuss theological themes/questions in a movie.
- 11. Sunday, September 7, marked the beginning of a new program year at the church. During the 9:00 AM education hour, Christian faith and music skills were woven together for children through storytelling and games in Holy Cross Children's Room, a parenting group resumed their meetings upstairs in the Canterbury Room, and the Rev'd Beth Anne Nelson, Missioner to Rice University for the Episcopal Diocese of Texas, and Carrie Willard, Assistant Dean in Rice University's Office of Graduate and Postdoctoral Studies, had a conversation in St. Bede's Chapel about the diocesan ministry with Rice students and how to support them, both undergraduate and graduate students. After the 10:00 AM Choral Eucharist that morning, the largest newcomers class in recent memory met in the Parish Hall, and the youth group resumed their meetings in the Youth Room. "Reel Theology" met later that night.
- 12. The Men's Retreat will take place at Camp Allen from Friday, Oct. 3, to Sunday, Oct. 5.

- 13. The date for our annual "Blessing of the Animals" has been moved to Sunday, October 12, so that we will have enough clergy present to hold parallel services that morning during the 10:00 AM hour. One will be the regular service inside the church, while the other will be an outdoor service on the south lawn with all of the pets that people will be invited to bring with them. That worked very well last year.
- 14. This fall there will be two classes offered on Thursday nights for seven weeks from October 9 through November 20. This will include a gathering time from 6:00 to 6:30 PM in St. Bede's Chapel for those who want to talk to one another and have a snack. This gathering time takes into account the variable of traffic delays and the fact that people can park on Main Street after 6:00 PM. Then the classes will run from 6:30 to 7:30 PM. One will focus on artistic and creative themes, meeting in Holy Cross Children's Room.
