- 2. **Acts 25:10-11** "¹⁰ But Paul said, "I am standing before Caesar's judgment seat, where I ought to be tried. I have done no wrong to *the* Jews, as you also very well know. ¹¹ If, then, I am a wrongdoer and have committed anything worthy of death, I do not refuse to die; but if none of those things is *true* of which these men accuse me, no one can hand me over to them. I appeal to Caesar."
