The prohibition against homosexual practice in ancient Israel was part of the ceremonial law only for Israel, like eating certain foods and not blending different

fabrics. Also, the word *to'evah* (abomination) simply means "ritual defilement," and not moral sin.

#### **Biblical Response:**

- i. The word to'evah speaks of something that is morally detestable before God often.
  - a. **Lev. 18:22** "And you shall not lie with a male as one lies with a female; it is an abomination (*to'evah*)."
  - b. Lev. 20:13 "If there is a man who lies with a male as those who lie with a woman, both of them have committed an abomination (to'evah); they shall surely be put to death. Their bloodguiltiness is upon them."
- ii. Many 'gay Christian advocates' claim that the homosexuality explained as an 'abomination' here is related to cultic worship, temple prostitution, having to do with false religious ceremonies
  - a. That is absent from the context words used are male and the expression for sexual relations.
- iii. Nowhere in Scripture are Gentile nations judged for eating shellfish and pigs. Nor are any Gentile nations judged for wearing clothing of mixed fabric or neglecting to put up fences around the roofs of their home. Gentile nations were judged however on the Ten Commandments and acts relating to this, including sexual immorality, idolatry, murder, etc...Even Adam and Eve were judged on these standards
  - a. Cain judged for murdering his brother Abel, etc.
  - b. Notice, male-male sex is listed as to'evah.
    - i. One of the few sins that the death penalty is applied to along with sacrificing one's children to Molech, cursing one's father or mother, and committing adultery, bestiality, or incest (Lev. 20:1-16)—hardly a list of mere ceremonial infractions!
- iv. The reason why the Christian can eat whatever he likes is because God repealed that in the NT.

- v. **Lev. 18:24** God judged other nations for incest, having sex with a woman during menstrual period, sexual immorality (including homosexuality), bestiality, sacrificing children to Molech, and adultery.
- vi. In **Deut. 12:31** *to'evah* refers to child sacrifice; in **Deut. 7:26** to idolatry and in **Deut. 25:15-16** to dishonest wrights and measures...we see moral infractions...They all fit under the category of *to'evah*, something abhorrent, detestable (and note in **Deut. 25:16** that anyone who is guilty of unethical business practices is *to'evah*, someone abhorrent, detestable)."
- vii. **Pro. 6:16-19** seven things that are detestable (*to'evah*)
- viii. A certain portion of Leviticus has been rendered inoperative because Jesus Christ is forever occupying the role of High Priest for us (**Heb. 2:17**), and we are called be His priests.
  - ix. In **Matthew 22:39** telling us that the second greatest commandment is to love your neighbor as yourself, is quoting **Lev. 19:18**
  - x. The 'gay Christian' advocate would have to answer why, if homosexuality is only a ceremonial evil, why bestiality, pedophilia, pederasty would not be considered merely ceremonially unclean acts rather than moral evils.
  - xi. "...the word translated 'sodomite' (KJV) or 'male cult prostitute' (NASB) in **1 Kings 14:24; 15:12; 22:46;** and **2 Kings 23:7** is the word *qadesh* and refers to something, or someone, who is consecrated, set apart for special (dedicated) service."
    - a. Moses knew about the word *gadesh*, (**Deut. 23:17**)

The 'gay Christian' Objection:

**Biblical Response:** 

- i. Jesus never spoke explicitly about homosexuality being wrong
- ii. Jesus did not mention everything, but He did specifically *encourage* one man and one woman in marriage, 2 genders in male and female, and condemned adultery and sexual immorality (Matt. 15:19; Mark 7:21-22 *porneia*).

The 'gay Christian' objection:

- Matt. 19:12 – Jesus talks about three origins of *euchuchos* (Eunuchs) – This is actually a claim for gender diversity in more than a binary

## **Biblical Response:**

- Jesus just finished defending biblical marriage and the gender binary; now He explains that some people don't reproduce by a variety of means
- ii. Jesus here is clearly referred to people who have chosen not to marry and of course, remaining celibate. This would be a extreme stretch to say that this is affirming homosexuality.
  - a. The New Testament Greek lexicon compiled by Bauer, Arndt, Gingrich, and Danker, universally recognized as the number one New Testament Greek dictionary, states this under the entry for *eunuchos*:
    - i. A castrated male person. Mt. 19:12b
    - ii. A human male who, without a physical operation, is by nature incapable of begetting children, *impotent male* (Wsd 3:14; Mt. 19:12a)
    - iii. A human male who abstain fr. Marriage, without being impotent, a celibate Mt 19:12c..."

- III. Most Common Objections to the Biblical View of Marriage in Favor of Same-Sex Mirage (mirage idea of someone becoming so dehydrated in the desert that they fantasize about seeing a water source in the distance, only to find that it is not real--credit to Doug Wilson, pastor in Moscow, ID)
  - 1. The men of Sodom displayed rampant and unrepentant sin, chiefly **HOMOSEXUALITY**
  - 2. Homosexual desire and activity is included in the **MORAL** Law of God, which is binding for all people, in all place, and at all times
  - 3. Jesus AFFIRMED the testimony of the Old Testament sexual and gender ethics

- **4.** Jesus explains that, through the corruption of sin, some people are rendered **INCAPABLE** of reproducing, either from birth, or by other people, or their own choice
- **5.** The Apostle Paul clearly **REINFORCES** the sexual ethic that was found in the OT and deepened by Christ
- **6.** The Christian *must* approach this issue using Biblical <u>CATEGORIES</u> and <u>TERMS</u> in order to understand these issues in a Godly way
- 7. The **DESIRE** to do that which God says is sin is sinful also
