## **Superintendent of School's Annual Report**

- Dr. Johnson reviewed current enrollment numbers for 2021-2022. The school is on pace to
  meet its ADM requirement. Elementary and Middle School grades are at capacity. 11<sup>th</sup> and 12<sup>th</sup>
  grades are at capacity.
- The student retention rate for 2021-2022 is 84%
- The teacher retention rate for 2021-2022 is 94%. Dr. Johnson reviewed the open positions for which the school is still hiring.
- Dr. Johnson reviewed the available accountability EOG/EOC and NWEA MAP testing data. 99% of CP&LA students took the required state mandated tests.
- Dr. Johnson discussed the High Point University / NC A&T State University Prepare Residents
  Partnership. The school has eight teachers earning their Masters in Elementary Teaching degree
  with STEM emphasis. The grant also allows a Masters degree in High School Math and Special
  Education with full tuition paid (annual tuition is \$22,800 per resident). Teachers must commit
  four years to CP&LA for the tuition to be waived.
- Dr. Johnson reviewed our faculty licensure percentages.
- Dr. Johnson reviewed the status of our EC Audit. The audit is expected to be completed this
  month. This audit is the first one with High School files and with the new ECATS computer
  system.
- Dr. Johnson shared the college acceptance status of the High School Class of 2021 and their scholarship awards.
- Dr. Johnson shared the list of new hires for 2021-2022 and notable changes in staff assignments.
- The school will continue to follow the protocols of the Safe Schools Kit from NCDPI and continue to work in conjunction with the Guilford County Health Department. All persons on campus will wear a mask until further notice.
- Dr. Varnado moved, Dr. Turner seconded the school's COVID policy. Approved.
- Dr. Varnado moved, Dr. Turner seconded to ratify the new hires. Approved.
- Dr. Turner moved. M. Brandon seconded to accept the Superintendent's Annual Report.
