STRENGTHENING OUR MISSION AND VISION

Leadership:

- 1. Council Leadership Conversation "Clarify the Win: 7 Practices of Effective Ministry" Discussion around places to get specific in our "wins" as a church. Next steps include inviting the staff into a conversation about their own specific ministry areas and how that fits into the strategic priorities.

1) Consent Agenda – Jana

Reviewed the minutes of April meeting, staff reports, and no fund approvals. Motion to accept the reports as written made by Mark, seconded by Ann, passes unanimously

2) Treasurer's Report – Bruce

April financials were presented by Bruce Luehmann. We budgeted for 8% increase in worship income and currently about 2.8% increase for the year. Total income is about 2% over budget. Expenses are in line with budget currently. Property expenses (mostly heat and snow removal) are higher than budgeted for the year. We will be watching our income as we transition into summer months. Mark motioned to approve the financials as presented, Ann seconded, passes unanimously.

A new Calvary Preschool Director has been selected after an 18 month search. Katie Rentschler presented some salary options for consideration in the offer. Jeff motions to negotiate salary, Ann seconds, passes unanimously.

3) Old Business

Mark & Jeff share that the building on the steps at Luther Crest begins this week, and the new canopy will get put up this week also. These items will greatly improve our experience at Calvary at the Lake.

A candidate has surfaced for the position of Worship Experience Director and we are having conversations with that person for this budgeted position.
