The Columbarium at the Prayer Garden of St. Dominic Niche Purchase CONTRACT

This Niche Purchase CONTRACT (CONTRACT) by and between St. Dominic's Congregation d.b.a St. Dominic Catholic Parish in Brookfield, WI (SELLER) and the purchaser named below (BUYER) is made to be effective as of the acceptance by SELLER on the date specified below. SELLER agrees to sell and BUYER agrees to purchase interment rights in a niche at the Columbarium of SELLER. These rights are assigned to the niche(s) as defined below. The BUYER further agrees to terms and conditions below. This CONTRACT is also governed by the Rules and Regulations of St. Dominic Cemetery (RULES), as may be amended from time to time, and which are incorporated by reference into this CONTRACT. The RULES may be found at the SELLER's web site.

BUYER hereby agrees to the following terms and conditions

- BUYER acquires no property rights to the niche(s), only the right to interment.
- Purchase price includes: (i) interment rights; (ii) one complete engraving of faceplate; and (iii) perpetual care. Payment shall be due in full from BUYER at the time of acceptance of this CONTRACT by SELLER.
- All engraving will be standardized with respect to content, font, and font sizes.
- All other costs of interment (such as urn, funeral director, and church services) are at BUYER's sole expense.
- BUYER cannot resell a niche. A niche may not be otherwise assigned or transferred, without the advance written approval of the SELLER at its discretion. Transfers by BUYER to a member of BUYER's family shall not be unreasonably withheld. All transfers shall be in accordance with the RULES.



- Except as otherwise permitted by the RULES, each niche shall contain only the remains of a single human person.
- Except for the placement of a single approved emblem, no additional enhancements or modifications are permitted on a niche.
- 8. All costs owed by the BUYER to the SELLER must be fully paid prior to any interment.
- Niche ownership and rights to internment in the SELLER's Columbarium shall at all times be subject to the limitations, restrictions and conditions of all Canons, rules, regulations, laws and discipline of the Roman Catholic Church and the Archdiocese of Milwaukee, now in force or hereafter enacted (the "CANONS").
- This CONTRACT, the RULES, and the CANONS, constitute the entire agreement of the parties.
- This CONTRACT shall be interpreted in accordance with the internal laws of the State of Wisconsin.
- Any action by or between the BUYER and SELLER concerning the interpretation or performance of this CONTRACT shall be commenced in Circuit Court of Waukesha County Wisconsin.
- 13. NEITHER THE SELLER NOR ANYONE ACTING ON BEHALF OF THE SELLER SHALL BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES. BUYER'S SOLE AND EXCLUSIVE REMEDY AGAINST THE SELLER OR ANYONE ACTING ON BEHALF OF THE SELLER FOR ALL CLAIMS IN TORT, CONTRACT OR OTHERWISE RELATED IN ANY WAT TO THIS CONTRACT OR THE USE OF A NICHE IN THE COLUMBARIUM SHALL BE LIMITED TO RETURN OF THE ORIGINAL PURCHASE PRICE PAID BY THE BUYER.
- 14. The CONTRACT includes this contract, addendum A (application for inurnment rights) and Addendum B (engraving form).
