TREASURER

The name of the organization amended to **United Methodist Women of the Baltimore Washington Conference (UMWBWC).** The DBA (Tradename) is **BWC United Women in Faith (BWCUWFaith).** This is the name registered in the IRS, Maryland and General Council on Finance and Administration (GCFA) databases. Use these names on all documents, flyers, correspondence, and bank accounts.

Hats off to Mary Jo Grimm, district treasurer for Cumberland-Hagerstown. Mary Jo has served almost 10 years as treasurer. Prior to serving as the district treasurer, she served approximately 20 years. We wish her well as she transitions from an officer to a member. Until a new treasurer is elected, local units may submit to the conference treasurer, Dorothy Medley. The district treasurer for Cumberland-Hagerstown retired effective January 1, 2024.

Procedure for inactive units **United Women in Faith (UWFaith)** (new Form IGRC UWF v11). The form is an attachment to this document and are available from your district treasurer.

Sale Use Tax Exemption Certificate (SUTEC) update. Need a dissolution clause for Articles of Incorporation. On hold pending approval of dissolution clause by Leadership team. After approval email to State of Maryland, Department of Assessment and Taxation.

DBA update. On hold pending approval of a Resolution authorizing the president and treasurer as signatories on the checking account. Once the document is signed, each district treasurer and president should take the documents to the bank and have the bank update your account with the dba information and add the new signatories The payee may be either **United Methodist Women of the Baltimore Washington Conference (UMWBWC)** or **BWC United Women in Faith**.

Leadership Team to approve a resolution to use the same rate as the Baltimore-Washington Mission Center uses for mileage. The current rate is 65.5.

SOCIAL ACTION COORDINATOR

Greetings Sisters!

I am happy to report we had successful Advocacy Days in Annapolis with Maryland Legislature and DC for Federal Advocacy (our first ever at that site!). I even participated in the Pen-Del Advocacy Day in Dover, DE (their first ever!) to support the work they are doing there. In the midst of all of that, some of us also participated in the National Day of Action organized by ThirdAct in March.

We were part of the "Rocking Chair Rebellion" that set up outside four banks urging them to stop supporting Fossil Fuel Infrastructure projects. Thank you to all who participated in our various Advocacy ventures in March and April!

Legislative Advocacy is one of the ways United Women in Faith stand up for the rights of women, children, and youth. It doesn't always mean you have to travel and show up at a rally, or travel to the State Capitol to meet with elected officials or go to City/County Council meetings to speak up about something they are considering, although all of those are important. It can mean contacting decision makers through phone calls to their offices, emails, handwritten notes, or signing on to a group letter.

As your Social Action Coordinator, I serve on the Leadership Committee for the Conference Legislative Team. I encourage all UWFaith members across the BWC to sign up to receive Action Alerts from our Conference Legislative Team at

https://bwcaction.org/action-alerts/ (part way down the page on the right). These Alerts are sent via email when there is an urgent need for people to contact decision makers about an issue. Background information is included. The "ask" from our Team includes statements from the United Methodist Social Principles to show why we are, or are not, in favor of a particular piece of legislation. There is frequently a sample script you can use to make calls, an email you can sign on to or sample language for a letter you can write. It's your decision to follow through, or not, and/or to modify the suggested language to make it your own. You may not know a lot about the issue, but as a woman of faith, you can trust us to have done the research on these issues before we contact

you. Please sign up. Help us build our network by asking others (your spouse, your clergy, the people in your small groups at church, etc.) to sign up as well. If you would like me, or a member of our Legislative Team to speak to your unit, or congregation, about the place of Legislative Advocacy in the life of the church, please let me know.




TOGETHER: THE HEALING POWER OF HUMAN CONNECTION IN A SOMETIMES LONELY WORLD

VIVEK H. MURTHY HARPER WAVE (2020)

In this groundbreaking book, the 19th surgeon general of the United States Dr. Vivek Murthy makes a case for loneliness as a public health concern: a root cause and contributor to many of the epidemics sweeping the world today–from alcohol and drug addiction to violence to depression and anxiety. Loneliness, he argues, is affecting not only our health, but also how our children experience school, how we perform in the workplace, and the sense of division and polarization in our society. BRITTANY K. BARNETT CROWN (2021)

Brittany K. Barnett was a law student when she came across the case that would change her life forever—that of Sharanda Jones, single mother, businessowner, and, like her, Black daughter of the rural South. A victim of America's war on drugs, Sharanda had been separated from her young daughter and was serving a life sentence without parole for a first-time drug offense. As Barnett studied this case, a system came into focus with widespread racial injustice at the core of America's addiction to incarceration. Moved, Barnett set to work to gain Sharanda's freedom. The memoir is at once Barnett's coming-of-age story and a powerful evocation of what it takes to bring hope and justice to a system built to resist them.



COMMITTEE ON CHARTER FOR RACIAL JUSTICE (CFRJ)

In light of all the racism concerns happening around the country, we feel it is necessary to reconstitute this committee.

The Committee on the Charter for Racial Justice Policies is a committee that has a membership of seven members, one-third of whom shall be of color if possible.

The seven members shall include the President of the Conference UMW Leadership Team, who will serve as the Chairperson, the Mission Coordinator for Social Action, and the Chairperson of the Committee on Nominations.

Four additional members shall be nominated by the Committee on Nominations. They shall be one district president, one member of the Executive Committee and two members selected to ensure inclusiveness and/or special expertise in the skills necessary to accomplish the task.

The committee shall:

- 12) develop and recommend to the Executive Committee plans for the implementation of the Charter.
- 2) monitor conference-approved action plans to implement the Charter
 - 3) regularly evaluate progress made on conference, district, and local implementation plans.

The Office of Economic and Environmental Justice invites United Women in Faith groups to apply for grants to help support local organizing campaigns to advance just energy for all. Funding is available for work happening at the circle, unit, district, conference, and jurisdiction level. United Women in Faith groups are strongly encouraged to apply for a grant to support work that is happening collaboratively, in coalition/partnership with other organizations or groups, so long as such work involves substantial participation from local United Women in Faith members and is focused on supporting energy infrastructure projects.

About the Just Energy for All Campaign

Our Just Energy for All Campaign works for energy that is cleaner and more just for all of God's people and creation. This means advocating for 100% renewable energy (RE) – such as solar, wind, small-scale hydro and geothermal – that is centered on justice and equity.

Goal of UWFaith Grant Support

To advance United Women in Faith's efforts to promote just energy for all by providing small-scale grants to augment existing campaigns and/or develop new campaigns.

Available Grant Support

Consideration will be given to funding requests of \$100 – \$3,000. We invite each applicant to carefully consider the amount of funding needed and to document in detail the budget and the rationale in the application.

Funding is limited, so please budget responsibly and request only the amount that you will need. The funds may be allocated for the purchase of materials, services, direct work involved, or for grant writing purposes. For now, we are not able to accommodate requests for more than \$3,000.

UMCOR Partnerships and Programming in the Horn of Africa

Since 2021, UMCOR has implemented three relief projects in Ethiopia through local UMC partners. Accessible areas are limited but we are slowly making progress in increasing the local capacity to reach more displaced families affected by political unrest and natural disasters.

In 2022, partnerships were formed with professional implementors in Kenya and Somalia, in response to the drought.

In Kenya, <u>IsraAid</u> is working on a 12-months project in Turkana Sud County, to address water access and nutrition, through building WASH infrastructures and local capacity development to deliver essential services and promote community resilience.

In Somalia, our partner <u>Kaalmo Relief & Development</u> implemented two projects in the Gedo region in 2022, where 1,200 families were assisted with food youchers and unconditional cash over 6 months.

We are currently preparing for a new intervention to address the impact of recent flash floods affecting IDP camps in Dolow district. The focus will be on restoring WASH infrastructures, increasing access to clean water for people and livestock.

Regarding South Sudan, partnerships are being formed with professional partners to address the needs of Sudanese refugees and South Sudanese returnees. A grant was recently approved for partner <u>Water Is Basic</u> to address urgent needs at the border.

We are also preparing a proposal with <u>Help a Child SSD</u> to address Food, Hygiene and Shelter in the longer term.

Funding for these programs come from the International Disaster Response Advance #982450.



Susanna Wesley House, Inc

The Susanna Wesley House serving the Mount Vernon Community since 1919, in Baltimore City have a rich history. The Women's Home Missionary Society of the Methodist Episcopal Church opened a home to accommodate 12 working girls in a rental home on West Fayette Street called, Wo-Ho Mis Lodge. In 1921 this organization purchased the property at 607/609 two Townhouses as a boarding house for working women. These facilities served the needs of women for over a century with a variety of opportunities. In 1993 these properties were restored after a fire damaged 607 and 609 was consecrated as a transitional home for homeless women with dependable children. This model included having two bedrooms, with a bathroom and closet space. And a shared kitchen. Additionally, three self-contained suites for larger families are available. In 2017 the house was reopened under the name Susanna Wesley House in honor of the founding mother of Methodism, because of the example of faith and religious reverence she set for her children that inspired John and Charles to become spiritual leaders and lunch the Methodist

movement.

By 1919 SWH, accepted 15 women with children, and all meals were served by a cooking staff in a dining setting room where before and after school/care was provided to mothers who were working or job hunting.

Due to administrative challenges in 2003, the Board agreed in 2018 that SWH needs to be reconfigured by proving nine units, with each mother having two bedrooms, a private bathroom, as well and a shared kitchen.

A key element to remember is that before the re-opening of SWH for new residents, living arrangements for visiting missionaries from around the World were housed at 609 Park Ave, Baltimore, City. Currently, 609 has gone through a historic transformation and continues to provide service for homeless women with dependable children. Professional staff and a supportive devoted Board of Directors serve them.

Currently, SWH is operating in a program pause phase which includes, rebranding, revitalizing, and creating opportunities, for moving forward with

bold strategic planning. The Previous residents are located to new housing opportunities in the community, new flooring throughout the building, a brighter and welcoming atmosphere,

The **new mission** for Susanna Wesley House is to provide transitional housing for homeless women and their dependent children by offering programs and resources that promote independence as they move toward self-sufficiency.

Goals:

- 1. To promote a safe and stable environment.
- 2. To move families to permanent housing within 24 months of arriving at SWH.
- 3. To provide programs and services that assist families with independent living.

Objectives:

- 1. Provide trauma-informed case management regularly to
 - a. assess families' barriers and causes of homelessness.
 - b. Create a family plan to address needs.
- 2. Partner with community organizations to connect families to educational programming, permanent housing options, employment, and healthcare services.
 - 3. Conduct feedback and evaluation processes.
 - a. during intake as families arrive.
 - b. during the exit as families leave for permanent housing.
- c. as a part of outreach to connect with families who once participated in the program.
