Position Title: Caretaker

Location: Camp Harmison, 507 Harmison Lane, Berkeley Springs, WV 25411

Supervisor: RCM Director

FLSA Status: Non-Exempt – Part-time, Hourly

Position Summary: The caretaker is responsible for maintaining the grounds and facilities to provide a safe and welcoming environment for guests, arranging contracted work when needed, and greeting guests and accommodating their needs during their stay.

Key Accountabilities

- 1. Provide for the maintenance of the grounds including any grounds work, carpentry work, plumbing, electrical or mechanical work needed to maintain a safe and welcoming facility for guests. This includes the complete cleaning of facilities after each group.
- 2. Within the confines of the budget for the site, arrange for any needed contractors to provide services beyond the capabilities of the employee and serve as the BWC representative in these transactions.
- 3. Purchase supplies and materials as needed within the limitations of the budget providing for good economy and use of materials.
- 4. Greet guest groups, providing for their needs and requests. Collect the information required to create an invoice for their stay.
- 5. Forward any monies collected and any bills for services to the Office of Retreat and Camping Ministries in a timely manner for payment or deposit.
- 6. Anticipate needs and prepare estimates of costs for improvements and upgrades for the site in a timely manner for the next budget cycle.
- 7. Other duties as assigned by the Director of Retreat and Camping Ministries.

Special Aspects of the Role: Camp Harmison is a Christian organization that is focused on promoting the teachings and values of Christ. It is not required that the jobholder be of the Christian faith, but they must be supportive of our mission and may be expected to attend events with Christian worship elements (e.g. a devotion at the start of a meeting or prayer before meals).

This position has a direct impact on several of the <u>seven foundations</u> of United Methodist Camp and Retreat ministries, specifically: extending Christian hospitality, created sacred spaces set apart, and care of creation.

This position requires a criminal background check per state requirements for Youth Camp Certification, pre-employment drug testing, and CPS Adam Walsh background check.
