Old Business:

Review and approve minutes from previous meeting, April 18, 2023: correction to item 5. Diane motioned to approve the minutes as amended. Shannon seconded. Motion passed.

New Business:

1. Trustees – Updated Maintenance Reserve Plan – Jessica, Robyn and Laurie: Trustees report sent by email & hard copies available. Robyn addressed the 30-year plan revised down to 5 years. Yearly reserves are noted at the bottom with a 10% increase each year. Laurie talked about the auditor's suggestions and how they are working in to things. Trustees are requesting \$30,000 from the Cash Reserve to put into the Maintenance Reserve Plan. Jason explained the "Check-Out" and the formula for apportionments. Repairs and Capital Improvements are weighted differently.

Action: Shannon motioned finance allocate \$30,657.00 from the Cash Reserve (Unrestricted Assets) to the Trustees Reserve Fund. Edward seconded. Motion passed.

2. Review and approve April financials

Action: Dave motioned to approve the April financials. Leslie seconded. Motion passed.

3. Cash report: We are within the floor and ceiling. We will still be in the floor and ceiling with the Trustees requested transfer.

Action: No action needed at this time.

4. Debt reduction fund payment: \$3,666.00

Action: Jimmy motioned to send \$3,666.00 to TMF. Jessica seconded. Motion passed.

5. Possibility of moving some money to another bank – Dan: Some bank options- Sweep Account (securities owned in the bank) secures our money (IntraFi) up to 100 million dollars; Money Market Account is another option to safe guard funds as well as have liquidity and make some money. Cindy questioned what other churches our size do? Cindy recommends a high yield savings account. Guidance requested as to what we prefer. Continue research.
