#### **FINANCIAL REPORT** – JAMES CARPENTER

#### 2022 Financials YTD

- Highlighting Interest rate increased Jan 1st and July 1st the recent increase raised our mortgage payment by \$10,000/month
- » Did not received the Open Bible Society grant that we had expected
- » Jericho Faith Society projecting positive revenue streams
- » Jericho Ridge's application to the CRA for incorporation as a society is complete. We are in the process of moving our charitable status under the umbrella of this society. This needs to be finalized before we

- can seek alternate mortgage lenders.
- Current 2022 YTD presented: Total Revenue \$388,713 and Total Operational Expenses \$496,074 so currently Net \$-107,361 as of Oct 31/22.
- » Projected end of the year will come in on budget with giving and expenses

#### 2023 Proposd Budget

- Working with lender to stabilize interest rate and payments
- » Submitted 2023 Budget projects a \$-55,918 deficit; this will utilize most of the current cash reserves.

The adjusting journal entries and trial balance for the year are provided in your package. The adjusting journal entries must be posted to your general ledger at December 31, 2022. Once these entries have been posted, the balance in the retained earnings account (i.e., net assets) should be \$138,001 at December 31, 2022. To verify this amount please run a balance sheet dated January 1, 2023 and ensure the retained earnings amount agrees. If you require any assistance, please call. We would appreciate receiving an electronic copy of your trial balance once these entries have been posted.

#### 1. BASIS OF ACCOUNTING

The basis of accounting applied in the preparation of the statement of financial position of Jericho Ridge Community Church as at December 31, 2022, and the statements of revenues and expenses and changes in net assets for the year then ended is on the historical cost basis and reflects cash transactions with the addition of:

- · prepaid expenses
- goods and services tax recoverable as at the reporting date
- equipment recorded at cost and amortized on a systematic basis over useful lives
- · accounts payable and accrued liabilities
