

DUMC Preschool Scholarship Guidelines

DUMC Preschool maintains and operates a tuition assistance fund to provide needs-based partial tuition scholarships to families enrolled in the preschool program. These funds are made available by fundraising efforts and church, preschool, and community members who care about children and believe that DUMC Preschool provides a strong Christian and academic preschool experience.

Families currently enrolled at DUMC Preschool who experience job loss or other financial difficulties after the registration deadline or during the school year may request financial assistance at any time. Extenuating circumstances are considered on a case by case basis.

Program Details

1. The ability to offer tuition scholarships is dependent upon the following criteria.
 - The availability of scholarship funds and the number of applicants.
 - The circumstances for assistance such as job loss, health issues, and annual household income.
 - The age of the prospective student. (First priority goes to students closest to entering kindergarten.)
 - Currently enrolled students or alumni siblings receive priority.
2. Scholarship funds are available for 3-year-old, 4-year-old, and TK classes based on the minimum number of days offered for the age group.
3. The student's registration packet must be submitted, including the registration fee, to be considered for a scholarship. **The registration fee will be refunded if the scholarship is not accepted or a scholarship is unavailable.**
4. Scholarships are awarded for the current school year only.
5. Eligibility will be reviewed in December. A Review Form is due by December 1st.
6. The family's portion of tuition after the scholarship has been applied is due the 1st of each month.

Application Process

1. Scholarship applications must be submitted with registration paperwork by the enrollment deadline.
2. Applicants must submit a copy of their most recent federal tax return (first page only) and paycheck stub(s). Scholarship requests will not be considered without documentation. If

appropriate documentation can not be provided, please include a letter of explanation with the application. If necessary, additional information may be requested.

3. All applicants will be notified by email at the end of February.
4. Scholarship applications are processed confidentially by the DUMC Preschool Scholarship Committee and all decisions are based in good faith.
5. Applicants approved for a scholarship will be asked to sign a scholarship contract and return it to the Director within two weeks of receiving the scholarship letter.
6. The scholarship fund is limited, and while all applications will be reviewed, there is no guarantee that all applicants will receive assistance.
