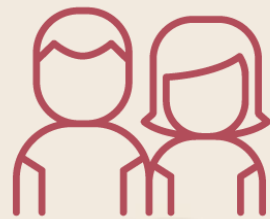
- 1 in 8 pregnancies in Ohio end in abortion.

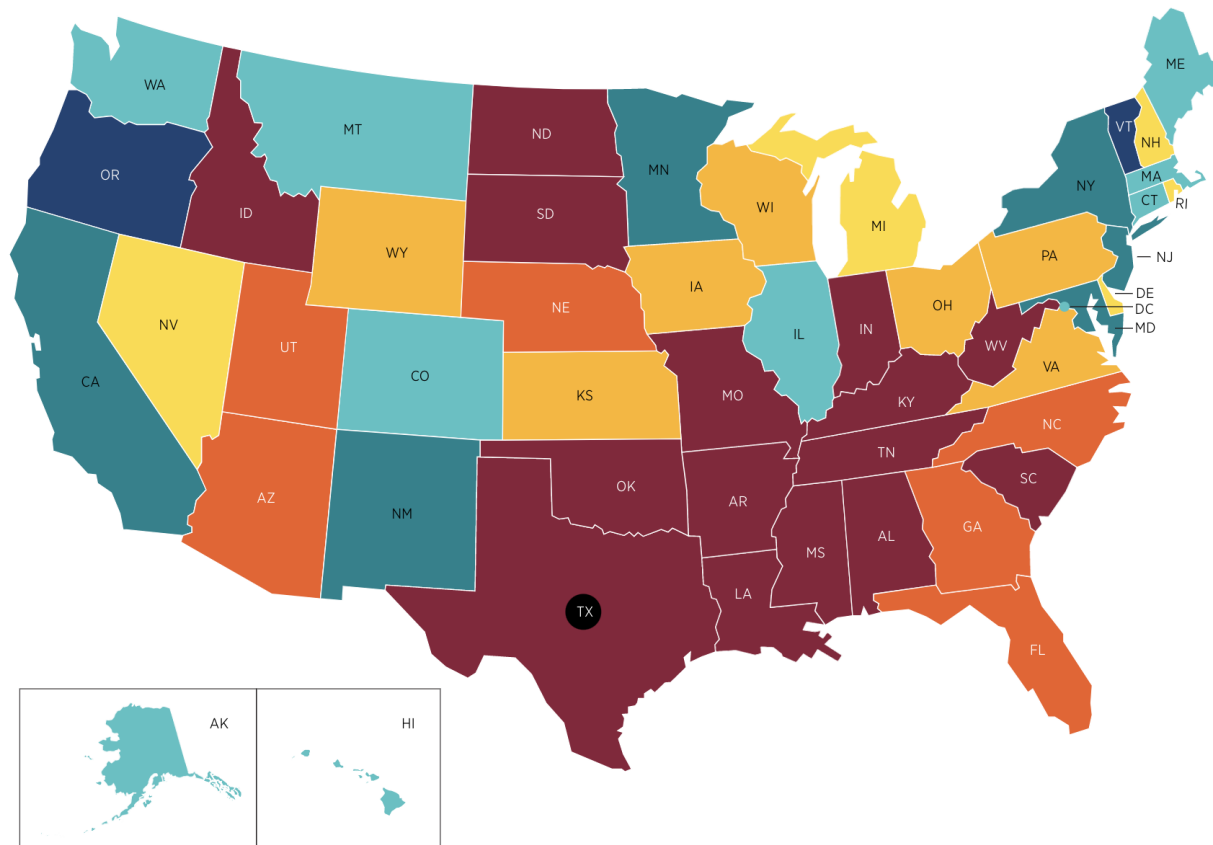

Status of Abortion in America

June 24, 2022:

The *Dobbs* Supreme Court decision reversed the 1973 *Roe v. Wade* decision



Gave each state the authority to regulate or ban abortions



Status of Abortion in Ohio (a timeline)

Jun 24, 2022 – Dobbs US Supreme Court Decision

- OH Heartbeat Bill became law;
- Abortions became illegal after 6 weeks
- Abortion clinics referred patients out of state
- Surgical abortions in Ohio significantly dropped... to almost zero...for 84 days.

Sept 14, 2022 – Heartbeat Law suspended

- Ohio Supreme Court never took up the pro-life appeal
- Abortion clinics open, performing abortions up to 22 weeks gestational age

Abortion Laws in Ohio

- Abortion is prohibited either post–viability (Ohio Rev. Code § 2919.17(E) (2011)) or after twenty weeks embryonic age (§ 2919.201(A) (2017)), whichever comes earlier.
- Abortion after viability is a fourth–degree felony. Ohio Rev. Code § 2919.17(F) (2021).
- Abortion is prohibited if the mother is seeking to abort due to a diagnosis of Down syndrome in the unborn child. Ohio Rev. Code § 2919.10(B) (2018).

Status of Abortion in Ohio (a timeline)

Nov 7, 2023 – Issue 1 passes

- Abortion rights enshrined in OH Constitution
- Promised to remove all restrictions to abortion, to include
 - Parental Notification and Consent requirements
 - Down Syndrome Protection Act
 - Heartbeat Law
 - 24-hour waiting period
 - Restrictions on abortions past point of viability

Dec 7, 2023 – "Enactment Day"

Status of Abortion in Ohio

Dec 8, 2023 – post Enactment Day

- For now, every pro-life Ohio law remains in place until legislative or judicial action
- Judicial challenges have started (and will be coming)
- We expect most pro-life laws to fall in time..."unconstitutional"

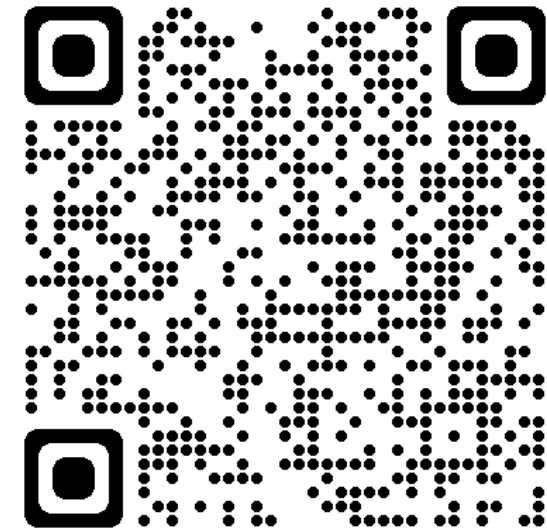

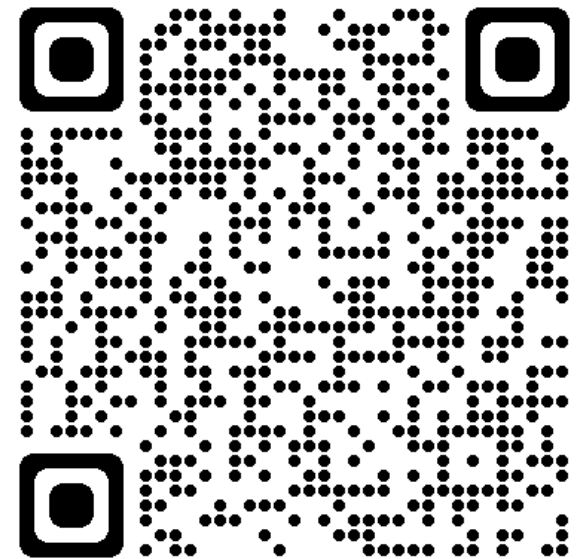
