



Dear Parent,

Thank you for considering Trinity Lutheran Church Early Childhood Center for your child's Preschool Education! We love to serve families and are looking forward to having you become part of our Trinity family. You have indicated that you would like to apply for enrollment in the Great Start Readiness Program (GSRP). You may begin the enrollment process now, but we cannot finalize enrollment until the State School Bill has been signed and allocations have been announced. This means that you will be placed on a waiting list until the middle to end of August. We will contact you at that time to finish the enrollment process.

GSRP is provided free of charge to families who are income eligible. For this reason, you must provide income verification documentation. We must receive documentation for everyone in your household or residing in the family home with the child enrolling. We are required to consider the income of the last 12 months or of the previous tax year. We can also consider income at the time of enrollment for those whose income may have changed from the last tax year. You must provide written proof of income. For parents who have joint custody, we need income verification from both parent's households.

Income means total cash receipts before taxes from all sources. It can include:

- Money: wages or salary before deductions,
- Net income from self-employment,
- · Regular payments from Social Security or Railroad Retirement,
- Payments from unemployment compensation, strike benefits from union funds,
- Workers' compensation,
- Some veterans' benefits,
- Public assistance including Temporary Assistance for Needy Families,
- Supplemental Security Income (SSI),
- Emergency assistance money payments and General Assistance or General Relief money payments,
- Training stipends,
- Alimony and child support,
- Military family allotments or other regular support from an absent family member or someone not living in the household,
- Private pensions, government employee pensions (including military retirement pay) and regular insurance or annuity payments,
- · College or university scholarships, grants, fellowships and assistantships,
- Dividends, interest, net rental income, net royalties, and periodic receipts from estates or trusts,
- Net gambling or lottery winnings.

Examples of written verification of income could be some of the following:

- Income Tax Form 1040
- W-2
- TANF Documentation
- Pay Stub or Pay Envelope
- Unemployment
- Written Statement from Employers

- Foster Care Reimbursement
- SSI Documentation
- Child Support
- Alimony
- Pension(s)
- Other Income

Your child must be 4 years old by September 1 of the school year you are enrolling in. Sometimes GSRP allows us to enroll children who are 4 by December 1 but we can do that only if space is available after September 1. We will need a copy of your child's birth certificate. We will also need a copy of your child's immunization record. If you are not up to date on immunizations or want to request a waiver, you will need to contact the Macomb County Health Department (see attached notice from the Health Department).

We have attached some forms and additional information that you will need:

- Registration Form
- Health Appraisal Form
- Parent Booklet with additional information about GSRP
- Immunization notice from the Health Department

To begin the enrollment process:

- 1. Fill out the Registration From
- 2. Call the center to set up an enrollment meeting with Jessica Platte at 586-463-8803
- 3. Gather your income verification information and forms
- 4. Meet with Jessica Platte, bringing the enrollment form and verification documents.

To finalize enrollment (in August)

- 1. Wait for contact from TLC that you are on the roster for the GSRP classroom
- 2. Attend an Open House during the first week of September
- 3. Bring completed Health Appraisal Form with Immunization Record and Birth Certificate to Open House
- 4. Update any Income Information at Open House

Great Start Readiness Program (GSRP)

- GSRP is funded by the State of Michigan and is free to those who qualify by income. It is aimed at middle income families. We must verify income to enroll.
- Children must turn 4 by September 1 to be eligible for GSRP. Ages in this room range from 4 5 years. After September 1 we can allow children who are 5 by December 1 to enroll.
- Sessions meet Monday through Friday from 8-3.
- Maximum class size is 18 with a teacher, an associate teacher, and an assistant.
- Teachers plan preschool activities using Creative Curriculum. We use GOLD Assessment from Creative Curriculum to assess children's learning and use this information to fine tune activities to better enhance each child's learning. We invite you to meet for parent teacher conferences to share the information from Gold several times each school year.
- We cannot provide religious instruction during GSRP hours, but we offer a Jesus Time immediately following GSRP class time at no charge. We teach age-appropriate Bible accounts, songs, and lessons and most importantly they learn that Jesus loves them! We share information weekly about what the children are learning.
- The schedule is consistent. This provides consistency and predictability, a vital aspect in a learning environment. Large and small group times, literacy and math teaching are provided daily. Plenty of time is allowed for child-directed play, an important format for learning. Outdoor play or gym time is provided daily.
- A short rest time is provided on cots daily. Parents need to furnish a *small* blanket and a *small* pillow if desired.
- A morning snack, hot lunch, and afternoon snack are included. Menus are provided monthly and available on our website.
- The room is set up for preschool learning. Different learning centers are evident. They include block, dramatic play, toys and games, discovery or science, sand, and water or sensory, art, literacy, music, and large motor or climber centers. Materials are rotated for interest. We cook with children weekly.
- Outdoor area includes swing sets, climber, trikes, trike track, a spacious sand area and gardens. We also use the church property outside of the playground for games and exploration. Children go outdoors daily, year-round, weather permitting. Please provide appropriate clothing such as boots, snow pants, mittens, hats and warm coat or a bathing suit for summer. We would be happy to apply sunscreen if provided.
- Children are being taught to take care of their own belongings and clean up after themselves throughout the day. They are given a cubbie for clothing, a bag for bedding, and a mailbox to put important papers and projects in. Please check it daily.
- Please remember to dress your child in play type clothing so they can participate in all activities without concern.
- The preschool does not provide daily written communication but would be happy to answer any questions you may have about your child's day.
- As part of the GSRP program, Trinity invites you to attend Parent Advisory Meetings several times each school year.



Childcare and Biblical Instruction

Dear GSRP Applicant,

Trinity Lutheran Church Early Childhood Center is happy to offer childcare after the GSRP classroom hours. Childcare is available 3:20 PM – 6 PM, Monday through Thursday in the GSRP classroom. There will be no childcare on Fridays and during scheduled breaks such as, spring break, parent-teacher conferences, holiday breaks, etc.

Childcare is offered at an hourly rate of \$4.75 per hour. Minutes from morning and afternoon are combined into one charge per day. We bill on Monday for the previous week, and you are given a statement of charges. Payment is due by Wednesday of that week. You may qualify for childcare subsidy from the State of Michigan. If this is the case, we will bill accordingly and let you know your copay on Monday for the week previous.

We are happy to provide care at <u>no charge</u> from 3:05 – 3:20 PM. During this time, we will provide Biblical teaching in the form of age appropriate Jesus Time activities which will include telling of the Bible accounts, songs, finger-plays, etc. We welcome all children to participate at no charge during those times. Childcare charges will be assessed after 3:20 PM. We hope you will choose to allow your child to participate. Trinity's mission is to make fully devoted followers of Jesus through Christ-centered care and education of children. While we cannot share the good news during GSRP classroom hours, we wanted to offer your family this opportunity after GSRP hours.

If you would like to take advantage of the childcare program, please fill out the attached contract and indicate the days and hours that you will use the program so that we can plan for staffing and activities. You will not be charged for that time.

^{1.} Families at or below 100% of poverty must be referred to Head Start. Enrollment in GSRP is deferred until the referral process is complete.

^{2.} Head Start grantees that demonstrate all children at 100% are being served may receive approval to serve up to 35% of their enrolled children from families with incomes up to 130% of the federal poverty level.

^{3.} Up to 15% of children may be enrolled at or above 301%. Sliding-fee scale tuition applies.
