Baptisms are up too as are students engaged in Youth ministries. 46 children received their First Communion on Maundy Thursday - that is an increase over the prior couple of years as well. 56 students will be participating in summer mission trips. March Pizza with the Pastor gatherings saw large jumps in attendance as well with 37 adults plus children attending across all campuses.
