- Disciple Life goal was likely too big and should be adjusted downward in order to facilitate healthy, missionfocused replication. Also, determining a next steps for moving new potential DL participates forward should be addressed/planned for

- Connect/Contribute intentional time during worship a success with 400 electronic responses and several paper forms completed.

- "Rocks" for WLC overall were not reached/likely too dependent on single individuals to move things forward/might be a need to identify roadblocks sooner

- A Big "Rock" for Q4 is hiring Brad Miller's replacement. Need a strong leader/not necessarily ministry trained.

- Marketing goals: improve we presence, optimize for SEO, increase public affairs visibility

Include marketing, potentially at least one individual identified as being especially connected to the current name who might help within spheres of influence toward acceptance. Devise a timeline and a communication plan. Explore possibilities that might bridge current usage of WLC (The Well? Wellspring? Waymaker? Witness?, name needs to fit mission and vision, not simply ease or cost savings) Multiplying Disciples, Transforming Lives— Transformation Lutheran Church?
