2024 Planning Pastor Tom Mike Ehnstrom Ann Baumann	 2024 Budget: Pastor Tom and Mike walked Council through nuances of initial budget draft. Several questions addressed. It is still a work in progress but is almost complete. Updated draft will be reviewed with Financial Advisory Team week of November 20 and again with Council during 12/12 meeting. Finalized version will then be prepared for January congregational meeting. EOS Planning Process: Mike walked us through the Accountability Chart draft. Sought and received feedback. Discipleship is the core theme throughout the vision and long-term plan. Goal is to finalize by 12/11.
