#### **2023 CONGREGATIONAL ANNUAL MEETING MINUTES**

November 19, 2023

#### **Determination of Quorum**

- The 2023 Congregational Annual Meeting was held in Fellowship Hall on November 19, 2023, following a potluck lunch.
- Woodlake Lutheran's constitution requires a 5% quorum (29 members) present to vote. Ken Mandl noted that since there were many more members present, a count would not be needed.

#### 1. Call to Order and Adoption of Agenda

• Congregation President Cindy Hanson called the Meeting to order at 11:45am. Ken Mandl moved to adopt the agenda. Shirley Stroud seconded, and the motion passed on a voice vote.

#### 2. Opening Scripture and Prayer

• Pastor Neal Cannon opened the meeting with a scripture reading from Hebrews 10 and a prayer.

#### 3. Reading of the Minutes

- The congregation was given time to read the minutes of the 2022 Congregation Annual Meeting. There were no questions or corrections.
- Ken Mandl moved that the minutes be accepted as is. Bill Bullock seconded, and the motion passed on a voice vote.

#### 4. Nominations and Elections

• There were no additional nominations offered. Cheryl Lundsgaard made a motion to go ahead with the election. Ben Millard seconded, and the following candidates were elected to the Leadership Board and other leadership openings:

#### 5. Reports

- Pastors' Annual Report
  - o Pastors Micah Pearson and Neal Cannon wrote a joint annual report. There were no comments or questions about the Pastors' Annual Report.
- President's Report (Cindy Hanson)
  - o There were no comments or questions about the President's Report.
- Treasurer's Report (Bill Bullock)

- o There were no comments or questions about the Treasurer's Report. Bill moved that the report be accepted. Karen Nilsen seconded, and the motion passed on a voice vote.
- Other Leadership Board Reports
  - o It was noted that the Service and Justice Commission report was not included in the packet, even though it had been submitted. It will be made available to whomever requests it from the church office.
  - o There were no comments or questions about the other Leadership Board reports.
- Audit Committee Report (Bill Bullock)
  - o The Audit has not yet been done, but it will be included and made available after completion to whomever requests it from the church office.

#### 6. Old Business (There was no Old Business.)

#### 7. New Business

- Presentation of the 2023-2024 Budget (Bill Bullock)
  - o Bill presented the 2023-2024 Budget Summary. He noted that there are no raises in the budget. Cheryl Lundsgaard asked why there was an increase in the Personnel budget. Bill said that 2023 Actual was lower due to having no RALY Director for the latter part of the year.
  - o Ken Mandl asked if there was an increase in the budget for heating and electricity. Bill responded that the projected amount was unchanged due to expectations that the recent boiler repair will reduce the heating bill.
  - o Cheryl also asked about the drawing down of funds in the Emergency Reserve to only about \$500. What if there is an emergency? Bill agreed it was a valid concern. However, there is more than \$100,000 in dedicated funds that could be used for an emergency.
  - o Laurel Johnson asked what would happen if MICC discontinues renting space in the church. Bill responded that MICC has renewed its lease since it is falling behind its building timetable.
  - o Bill moved that the report be accepted. Ken Mandl seconded, and the motion passed on a voice vote, with one dissension.
- Approval of Endowment & Memorial Fund Distributions (Orv Holland)
  - The cumulative contributions have reached a total of \$1,166,299.92 as of October 31, 2023. The church mortgage pays \$3,000 monthly into the fund.
  - o The Memorial Fund is from funeral contributions. There are certain restricted funds such as the scholarship fund, the Erin Rappe youth fund, and the camp fund.
  - o Distributions are used for off-budget items, such as Modern Worship, new NRSV Pew Bibles, etc.

#### Capital Campaign Update

- o Pastor Micah reported that \$525,000 has been committed over 3 years. Some of the proposed projects could begin in early 2024.
- o Ken Severson asked if anyone could join the capital campaign committee. Pastor Micah said yes and there will be plans for a Town Hall meeting to encourage participation.
- o Laurel Johnson requested that committee member names be published.
- o Augie Schauer requested that next year's annual report include income and out-go of capital campaign funds.

#### 8. Closing Prayer

• Pastor Micah led the closing prayer.

#### 9. Adjournment

• Ben Millard made a motion to adjourn the meeting at 12:45. Jess Godfrey seconded, and the motion to adjourn passed on a voice vote.

Members of the group often offer additional prayers for our local communities along with worldly needs. Our co-pastors alternate in leading these sessions.

One week, Pastor Micah reminded us that we need to remember ourselves in our prayers. People were offering up prayers. I was in the kitchen, finishing cleanup, having my own thoughts when Pastor Micah called out to me and asked if I needed a prayer. I confidently came to the door and said that I did – my prayer was of gratitude for being allowed to be president of this special congregation. Our new system provides excellent sound in the sanctuary, although fine tuning will continue to occur. Our new live streaming equipment provides a new method of outreach, both to current members and those who want to "check us out" online.

With the departure of Any Pokel, our previous Director of Worship and Music, an opportunity arose to try a shared position with House of Prayer by sharing the time and talents of Dr. Roselyn Hanson Weber. This arrangement will be evaluated in the spring of 2025 to see if it is agreeable to all concerned.

The act of worship is both an individual and group experience, many opportunities exist for members to participate in worship by the reading of scripture and prayers, preparing and serving communion, and operating our sound and video system.

We currently employ the sign-up genius application for worship volunteers, which can be accessed through the church website. From the home page click on the serve tab, then to the volunteer tab, then to the worship tab, and then to worship sign up, which will take you to our sign-up genius. You can also call the office or reach out to me for help in signing up for a spot.

I have found participating in these activities as a way to strengthen and develop my faith, and I urge all members to find a way to participate as you are able.

#### Service & Justice Commissioner

Woodlake's Service and Justice (S&J) Commission aims to create opportunities for our congregation to participate in the life of our local, regional, national and global communities while growing our understanding of the root causes of injustice. We seek to listen to the needs of the community, form connections grounded in empathy, and provide ways to act on specific needs or advocate for justice.

During the past church year, the Service and Justice commission worked to:

- create connections within and beyond the community of WLC;
- We maintained the bulletin board located by the Fellowship Hall for updates, opportunities and information about service and justice opportunities.
- We sent regular updates via the Messenger and bulletin, including information about Isaiah,
   Venezuelan immigrants, and what we've been reading (such as Love The Neighbor: A Muslim Doctor's Struggle for Home in Rural America by Ayaz Virji M.D.)
- learn and advocate together;
- We held an adult forum series on "The Color of Compromise" by Jemar Tisby.
- We provided the curriculum for this fall's Civic Life and Faith life groups
- We continued publishing a "term of the week" in the Sunday bulletin.
- listen to and act on the needs of our neighbors.
- With support from Tapestry, we sponsored 4 immigrants from Venezuela through the federal government's Humanitarian Parole program, one of whom also qualified for the Welcome Corps federal program for Refugees. Despite a slow process, we eagerly await his arrival.
- We highlighted and continue to encourage congregational members to support VEAP, Meals on Wheels, Loaves and Fishes, Every Meal and Beacon.

As we look ahead to the coming year, we will continue our commitments to form connections, learn, listen and act together. We anticipate ongoing support for the community organizations named above and the opportunity to explore new pathways. Based on our reading of "Braiding Sweetgrass" by Robin Wall Kimmerer and considering further involvement in the ELCA Truth and Healing Movement, we are planning an upcoming training and adult forums during lent about developing a land acknowledgment. We appreciate your prayers, support and collaborative actions and always welcome new members!

#### CHILDREN YOUTH AND FAMILY REPORT

2024 has been a great year for CYF ministries at Woodlake! We've seen steady participation in our RALY programming, VBS, & Godly Play. This year, 4 RALY youth attended the National Youth Gathering. We also hired a new RALY Director, Rachel Larson. Thanks be to God for the tremendous CYF ministry that is happening at Woodlake!

#### **Sunday Morning Programming**

For 2023-2024 youth in preK-5th grade attended Godly Play. The consistency of the program and leaders boosted family attendance on Sunday mornings as kid's enjoyed the program and each other. The beginning of the program year in 2024 has challenged Godly Play as our Godly Play room is under construction. However leaders have faithfully led the program each week with Bible stories and games shared either outside or in the nursery.

#### **Fun Family Activities**

The CYF team hosted the Christmas Pageant, Easter Egg Hunt, & Senior Recognition this year. All of these events helped increase worship attendance while at the same time blessing our children and families in important ways!

#### **Meaningful Learning**

Shared learning with House of Prayer has been a huge boost to our youth. Confirmation has been a great connection point for youth as well. This Spring 3 youth were confirmed and 7 youth are participating in Confirmation this year. A lot of fun and Christian education has enriched the faith of our young people!

#### **RALY**

This year RALY has seen steady participation in Summer Programs. VBS had 16 participants this year while Summer Stretch, unfortunately was canceled. Wednesday night RALY has remained steady as well as new and regular participants continue to come and invite their friends. The after school program continues to be a vital ministry of Woodlake as we regularly host 7-12 youth from the middle school. This has given us opportunities to invite youth to our upcoming JUSTmove Lock-In and other events. Speaking of, the JUSTmove Lock-In had 75 youth from across the Twin Cities in attendance. Wow! Finally, we've hired Rachel Larson as our new RALY Director. Welcome Rachel!

#### Calvary Legacy Gift – The Gift that Keeps Giving!

In 2023, RALY received a \$100,000 grant for ministries and scholarships. In 2024, quite by surprise, Calvary reached out to RALY and informed us that we have received an additional \$20,000 for continued ministry! What a tremendous blessing!

#### **Youth Wing Renovation**

This year the youth of Richfield received a tremendous boost from the congregation from the Come as You Are Capital Campaign. Woodlake pledged \$600,000 for AV and Youth Wing renovations. The updated youth wing is almost complete! We can't wait to share this gift with RALY youth, Boys and Girls Club, Lock-In participants, VBS, Scouts BSA, and the various ministries and events that happen at Woodlake.

Below are some of the ways through visits, prayer, cards, shawls and more that congregational care groups provide care to the congregation throughout the year.

#### **Woodlake Ink**

This group creates cards for birthdays, baptism, confirmation and graduation for our youth. It also makes cards for the Visitation Ministry to send to visitation members for Valentines Day, Easter, Thanksgiving and Christmas. It is important to remind people that God and the church family love them. Woodlake Ink is funded by donations from church members and friends of Woodlake. They meet as needed on a Saturday morning.

#### **Prayer Knitters**

The Thursday morning and Monday evening groups have been busy making prayer shawls and pocket prayers for peace to be given out at the Blue Christmas service. These shawls are available to all to share with someone suffering from illness, someone who needs comforting or has lost a loved one.

#### **Visitation Ministry** (formerly named Homebound Ministry)

Visitation ministers are blessed on the first Sunday of the month by a pastor before going out to visit members. They have two continuing education opportunities each year. In April there was a book discussion of "The Wisdom of Morrie: Living and Aging Creatively and Joyfully" by Morrie Schwartz. In October they watched a PBS documentary about Lakewood Cemetery. Woodlake and House of Prayer members are often invited. A training session was held in July for Woodlake and House of Prayer ministers. There are 20 visitation ministers at Woodlake who visit and/or call 35 visitation members. Six more members wish only to receive cards. There are three people who send cards made by Woodlake Ink to all visitation members at least four times a year. A leadership team of three people meet monthly to discuss the needs and concerns of the visitation ministers and members.

#### **Wednesday Prayer Group**

The first Wednesday of every month after Matins the Wednesday morning prayer group lead by one of the pastors lifts up in prayer the concerns of our congregation members. These prayers are confidential and important to our prayer team. We know that God responds to prayer in ways seen and unseen.

#### **Funeral Lunches**

The funeral lunch program was discussed this year at a meeting in April and some changes have been made. Woodlake will offer meal options to families from Affordable Best Catering (ABC) and Glory Bound Catering. Details will be given to the family after they notify Woodlake of the passing of their loved one.

#### Kitchen

A new schedule for taking care of the laundry has been posted. There are two people who take care of all coffee supplies and organize those willing to make coffee on Sunday mornings. A person is needed to check the kitchen and Fireside Room for general supplies and cleanliness and to organize it periodically.

#### **Grief Ministry**

Woodlake is currently looking for someone to head up this ministry, which involves reaching out to a family who has lost a loved one with a phone call, visiting or supplying them with grief resources. There are resources available for anyone who needs a class or a book to read. Woodlake is a part of the Bloomington-Richfield Grief Coalition, which holds support meetings several times throughout the year. The winter session starts January 2, 2025, Thursdays through February 20<sup>th</sup> at Peace Lutheran Church, 8600 East Bush Lake Road, Bloomington. The spring session will be hosted by Woodlake.

The Woodlake book club is going strong. Books have been selected for the next several months. We will be posting information and an invitation to join us in the announcements at House of Prayer. Thanks to Laurie Nix for leading this committee.

Some of our Congregational Life events include a bike ride and Twins game this past summer, as well as snow tubing this past winter. We will be looking for more fun opportunities to enjoy time together outside of church again this winter and next Spring/Summer.

The RAFT group sponsored a Queer Theology Bible Study this summer that was well attended. Both Woodlake and House of Prayer members were invited to join the conversation. The BBQ and Bible Study met for 4 weeks this summer, discussions will be held to potentially have a similar study again next year.

One area where we could use some continued support are volunteers to serve coffee and treats between the services. Ideally, we would have 2 groups each Sunday, one to start the coffee and treats before the first service and a second to clean up after the second service. There is a sign up booklet in the Narthex and I encourage you to sign up for a Sunday or two to help keep the refreshments available for both services.

#### INTERIM WORSHIP AND MUSIC DIRECTOR

I have been privileged to begin as Interim Worship and Music Director at Woodlake Lutheran this fall, while I continue to serve as Director of Liturgical Worship at House of Prayer Lutheran. Since we began our music collaboration in the spring of 2022, we have been blessed by a special relationship between our two congregations that allows us to alternate between our beautiful church buildings on a regular basis. Together with Andy Pokel during his tenure at Woodlake, I have enjoyed planning for and coordinating our choirs as we join forces to lead worship in greater numbers and strength.

The Combined Woodlake & House of Prayer Choir greatly enhances our weekly worship services. The singers provide strong leadership of the hymns and liturgy comprising our worship music, as well as offer special music reflecting the themes of the liturgical year and related scriptures. The Choir plays an essential role throughout the year and contributes immensely to festival Sundays and seasons such as Reformation, Advent/Christmas and Lent/Easter.

Since I joined the Woodlake staff in September, the Combined Woodlake & House of Prayer Handbell Choir has begun an exciting new collaboration. We now rehearse together on a weekly basis and offer special music during worship frequently, alternating between the two churches. The Handbell Choir plays a variety of special music to enhance our worship, and brings a beautiful instrumental element to our hymnody, liturgy, and choral music.

In addition to the above collaborations, my new role as Interim Music and Worship Director includes the responsibilities of worship planning, bulletin preparation, scheduling musicians to lead worship, oversight of instrument maintenance, communications, and licensing requirements.

The Woodlake congregation has a long tradition of engaging worship that is rich in Word and song. As at House of Prayer, the congregation at Woodlake strives to create a welcoming and inclusive environment, and to create worship that reflects these qualities. The staff, Leadership Board, and countless volunteers help to make our goals possible with constant support, demonstrating the strong commitment to the worship life and community at Woodlake Lutheran. #### 2024 Highlights

#### • Event and Worship Support

Throughout the year, I've coordinated materials for major church services, including Christmas Eve, Advent, Easter, Lent, and Holy Week. This included creating graphics, social media promotion, weekly emails, and bulletins, with the goal being to create each event such that they are communicated with clarity and impact. Additionally, I assisted with the Advent music series and the annual RALY Christmas pageant, helping celebrate Woodlake's cherished traditions.

#### Streamlining and Efficiency Improvements

I helped lead projects to improve our processes, including shifting Woodlake's mailing to the required USPS online integration system. This was essential for our messenger mailings. The team and I were able to streamline floral and plant orders through updating order forms and internal templates for Easter and other seasonal events. Additionally, I collaborated with staff to simplify processes for events, rentals, and internal communication tools, like new building use packets.

#### Community and Volunteer Engagement

By working closely with congregants, I've helped document church events, like Christmas preparations, Rally Sunday, and youth activities, capturing memories and promoting fellowship. Additionally, I've organized congregational efforts for volunteer photography and continued event coordination.

#### • Digital Content Creation and Social Media

From seasonal graphics to video editing, I managed our social media and digital outreach. Notable projects included the "Flat Jesus" summer initiative, youth events, and monthly engagement posts that keep our congregation informed and connected. Working with our Adobe suite and Canva programs and learning advanced editing, I crafted impactful visual content for Easter, Rally Sunday, and other key moments.

#### • Website and CMS Updates

I worked alongside our web team to enhance our website, ensuring timely updates, accurate content, and easy navigation for both visitors and members. This year, we also completed a project to update membership records, which will simplify future communications and enhance our database accuracy.

#### Support for Special Initiatives

I supported projects that reflect Woodlake's mission, including organizing materials for the RAFT Queer Affirming Bible Study, building resources for grief support, and preparing communications for a variety of

our collaborative ministry services. These initiatives continue to promote inclusivity and reach within our church and wider community.

#### Collaboration and Training

This year, I collaborated with church staff from House of Prayer (HoP) and our internal ministry teams to create joint communication strategies. Upon welcoming our new RALY Youth Director, Rachel Larson, I was able to help train her into our graphic design program, Canva and using our established RALY branding.

#### • Facility and Office Coordination

From updating confirmation photos for our hallway displays to coordinating with external vendors during construction, I worked to ensure that Woodlake's facilities and resources remain functional and accessible. Additionally, I was able to take on more responsibility in office coordination from staying on top of our office supply items along with organization and consistent upkeep of forms and other crucial documents.

In 2025, I look forward to building on this work by further enhancing our digital outreach, strengthening congregational connections, and promoting our mission-driven events and ministries. As we venture into continued collaboration through a shared Communications Director role, I am excited to help aid that transition in whatever means I am able. Thank you to the staff, volunteers, and congregation members who supported these efforts, making them a success for Woodlake Lutheran Church.

This past year has been incredible for RALY. We've seen tremendous growth in the program, in more ways than one! Here's an update on everything that's happened in the past year.

Calvary Legacy Gift - This past year, RALY received a legacy gift from Calvary Lutheran Church for \$100,000! This money has been designated for RALY scholarships and ministry. What's more, just recently RALY received an additional \$20,000 additional to the original gift from Calvary! We are grateful for the ways that God is enabling RALY to share the love of Jesus to the Richfield community. JUSTmove Lock-In - This year we held the first ever JUSTmove Lock-In at Woodlake. 75 youth attended for an evening of Justice and fun! This event welcomed youth from the community (specifically, the Boys and Girls Club), churches from around the Twin Cities, and Woodlake and HoP youth!

**Youth Wing** - Through the generosity of this congregation, Woodlake pledged over \$500,000 to renovate our Youth Wing and AV systems. That space is currently being transformed and should be done by January 2025.

**RALY Wednesday (Middle School)** - During the school year youth met every Wednesday for activities such as Feed My Starving Children, Dude Perfect Night, Real Life Clue, etc. These events welcomed youth and their friends for faith filled fellowship!

**RALY Second Sunday (High School)** - We are starting a joint High School ministry with Christ the King Lutheran Church, Amazing Grace Lutheran Church, and Diamond Lake Lutheran Church (partnering with the same churches that attended the ELCA Youth Gathering and formed great connections). Every second Sunday, high school students and friends are invited to one of our churches for various activities.

**Contact Ministry** - Rachel, Pastor Eric, and Pastor Neal all attend various games, meets, concerts, and shows with our youth. It's a great way to show up for our youth and show we care! **RALY VBS** - This year 16 youth participated in RALY VBS at HoP. Luther Park staff came and led the event while many volunteers helped lead!

**ELCA Youth Gathering** - This year, four of our high school youth attended the ELCA Youth Gathering in New Orleans. We traveled down with Christ the King Lutheran Church, Amazing Grace Lutheran Church, and Diamond Lake Lutheran Church. It was a great experience for all who were able to attend!

**Luther Park** - Elementary to Middle School youth from Woodlake and House of Prayer attended Luther Park in Danbury, Wisconsin for a week in God's great northwoods. This year, Luther Park saw a dramatic increase in attendance and hope to grow the program for next year!

**Boys and Girls Club** - After dreaming for years about partnering with the Boys and Girls Club, last year that dream finally came true! Every week, volunteers hosted activities for 5-12 youth from the middle school. These activities included baking, card games, basic car maintenance, gaga ball and more! The Boys and Girls are excitedly participating with us again this year.

**Confirmation** - Another year of Confirmation is in the books! 7 youth participated this past year in learning about the new testament. 3 youth affirmed their baptisms this past year.

**RALY Director Rachel Larson** - House of Prayer and Woodlake have hired Rachel Larson to be our new RALY Director. Rachel began in September and has already been a tremendous addition to the ministry here. Welcome Rachel!

#### **ENDOWMENT & MEMORIAL FUND YEARLY SUMMARY**

Proposed amendment to the authorizing resolution establishing the Woodlake Lutheran Church Heritage Endowment Fund:

WHERAS, Woodlake Lutheran Church ("the church") in the year 1987 created the Woodlake Lutheran Church Heritage Endowment Fund ("fund") to establish a fund that would provide long-term support for the church in perpetuity, and

WHEREAS, the Fund is overseen by the Woodlake Lutheran Heritage Endowment Committee ("committee") which is comprised of three (3) voting members of the church elected by the congregation as well as the current President and Treasurer of the church, and

WHEREAS, the committee invites groups and individuals to request grants from earnings in the current fiscal year,

THEREFORE, in accordance with paragraph 8 of Section I establishing the powers of the committee, be it resolved that the committee be empowered to revise the distributions limit as follows:

The limit the total of these distributions to the lesser of the annual net earnings of the fund, or five percent (5%) of the total fund value as computed on the last day of the Congregation's fiscal year, and

Be it further resolved that the committee will make no distributions from the fund in a fiscal year (November 1 through October 31) where the fund has not generated any net earnings, and

Be it further resolved that this change in computing the limit on total distributions shall be effective with distributions made from the fiscal year ending October 31, 2025, and

Be it further resolved that any distribution(s) from the fund must be approved by congregational vote at the annual meeting of the church held in November following the close of the respective congregational fiscal year.

This amendment requires 2/3 approval by a quorum of eligible voters at a scheduled congregational meeting.
