Minutes of the 2022 Annual Parish Meeting January 30, 2022

The rector, the Rev. Dr. Chuck Treadwell, called the meeting to order at 10:10 a.m. The order of business was adopted by unanimous consent.

Father Chuck led the congregation in prayer.

Father Chuck appointed Lowell Keig as parliamentarian and Martha Newton as clerk. The minutes of the 2021 annual meeting were adopted by unanimous consent.

Lowell Keig read the election procedures for 2022. The congregation approved a slate of five vestry members and two Diocesan Council representatives by unanimous consent.

Father Chuck recognized the new vestry members: Sandi Boone, Bess Carsner, Gay Gillen, Jim Norman, and Anne Claire Woods. He then recognized the new Diocesan Council representatives: Kristine Devine and Sarah Kapostasy.

Father Chuck recognized the returning and retiring vestry members. He then recognized the clergy and staff, including the contributions of departing Stewardship Director April Kerwin. Father Chuck announced that Eric Malnassy has been appointed as interim stewardship director.

Father Chuck played a video introducing the Warm Heart International and International Outreach Endowment Fund.

Father Chuck pointed the congregation to the 2021 parish annual report, which is posted online. Senior Warden Sarah Kapostasy and Junior Warden Rex Hunt presented their annual reports. Treasurer Lee Parker presented the 2021 financial report.

Eric Leibrock gave a presentation on behalf of the Building Committee.

Father Chuck gave the Rector's Report and announced the appointment of Rex Hunt as the next senior warden. Father Chuck gave the necrology report and invited the parish to pray for the deceased.

Father Chuck led the parish in the Doxology and the closing prayer.

The meeting adjourned at 11 a.m.

Election Procedures for St. David's Church

Lowell Keig, Parliamentarian

The Canons of the Diocese of Texas provide that "Men and women at least 16 years of age, who are enrolled confirmed communicants in good standing of the Parish, are entitled to vote for members of the Vestry and upon all questions requiring the action of the Congregation, but none shall be admitted to serve as members of the Vestry except those who are at least 18 years of age."

Under the Canon, St. David's has decided that 15 qualified persons shall serve three-year terms on the Vestry, five of whom shall be elected each year and by written ballot. A member of the Vestry having served a three-year term shall not be eligible to re-election until one year has passed after the end of the member's term. Only those present at the Annual Parish Meeting are entitled to cast a ballot. Voting by absentee ballot has not been authorized. All elections, by Parish tradition, are determined by those receiving the highest number of votes within the field of eligible nominees. A majority of those voting is not required to elect. In this Parish, tellers appointed by the Rector are designated,

under the Canon, as the election managers charged with reporting the results of elections to the Rector unless the meeting, by a two-thirds vote, shall determine otherwise. By Canon, members of the Vestry may not be elected to serve more than three consecutive years; however, this restriction does not apply to a person serving an unexpired term. This person is eligible for nomination and election to a full term at the conclusion of service for the unexpired term.

As to Council Delegate elections, the Parish is entitled, under the Canon, to elect four Lay Delegates. Elections may be either by the Vestry or at the Annual Parish Meeting, as the Vestry may determine, unless one of these methods has been stipulated at an Annual Parish Meeting. By Parish tradition, persons elected Lay Delegate serve four-year terms with one position being filled each year. By Canon, the Rector is authorized to fill any vacancy in the Lay Delegation at the time Council meets by appointment from parishioners who meet the qualifications.



JOHN CROW

My name is John Crow, and I am a candidate for Vestry at St. Davids.

I have attended St. David's since I moved home to Texas in 2014 after living in San Francisco for seventeen years. I grew up outside of Houston in a Southern Baptist home, yet it was attending worship services at Grace Cathedral in San Francisco where I found a new spiritual home. I was confirmed in the Episcopal church at Grace Cathedral on Pentecost 2006.



I served on the cathedral's Congregation Council - the cathedral equivalent of a parish vestry - and was a member of the Cathedral Board of Trustees during my service as Council President. I participated in the Hospitality and Lector ministries as well as served on the Stewardship committee.

I usually attend the 11:15a service, either in person or on-line, and have been a member of the Finance Committee since 2020.

I feel called to Vestry service at this time, as a means of further connecting with our St David's community as we share the Gospel with a rapidly changing Austin. With the dynamic growth of our city and redevelopment of our own downtown neighborhoods, as a spiritual community we face many challenges yet also have many opportunities to engage in new ways.

A bit about me professionally, I work at Charles Schwab as a Program Director/
Staffing Leader in the Project Management office. Prior to this role, I held various human resources leadership positions in Healthcare, Tech, and Consumer Products. My undergraduate degree is in Liberal Arts from UT Austin and I received an MBA from UT Dallas.

In the past, I have served on several non-

profit boards, most notably, an organization that provided mental health services to unhoused and low income individuals. I am currently serving a three year term on the Long Center Board of Trustees.

I met my husband, Marcus, forty years ago when we were students at The University of Texas. Fr Bob Gribble officiated our wedding in April, 2016. We live in NW Austin with our two cat-children.

PENI ELLIS

My name is Peni Ellis, and I am submitting my nomination for Vestry. My husband and our 4 children have regularly attended the weekly family service in Bethell Hall since 2014, the year our daughter started pre-school at SDDS. I have regularly attended, and enjoy the Crail C lectures while our children are in Youth Formation.



I have a degree in Psychology from the University of Incarnate word in San Antonio. I moved to Austin in 1997 and worked 2 years at a local non-profit, Austin Family House. During my time at Austin Family house I helped women in recovery, and their children. After working at Austin Family House, I took a job with Apple. After more than 10 years working at Apple in sales operations and supply chain management, I left to focus on family and start my own business. I currently run our family real estate and development company, Ellis Real Estate and Development, LLC. I believe my background will help me contribute to planning and organizational needs of the church. I also think that having four children ages 6 to 17 helps give me additional perspective.

My community involvement has been with my children's schools, and support of Austin Parks Foundation, and Austin Habitat for Humanity. Over the past couple of years, I have been looking for ways to get more involved with the community and our church. When Rex Hunt asked if I would be interested in serving on the Vestry, I felt called to say yes. I felt Rex's phone call was a little nudge from God calling me to get involved at St. David's in a meaningful way.

ALLISON MARSHALL

My name is Allison Marshall, and I am submitting my nomination for the vestry of St. David's Episcopal Church. I have been a member of St. David's since 2014 when I moved from Houston after retiring from ExxonMobil. I transferred my membership from St. John the Divine Episcopal Church in Houston where I had served as a member of the flower guild. At St. David's, I regularly worship at the Sunday 8:00 a.m. service.

I currently serve on the executive building committee for the renovation of the Historic Church and Bethell Hall. In this capacity I have helped produce St. David's phased preservation master plan and have met biweekly for several years helping to plan and administer this \$6 million renovation project.



RICK PATRICK

My name is Rick Patrick and I am seeking to be elected to the 2023 vestry of St. David's Episcopal Church. I am married to Phyllis and have two grown children, Ginny and Daniel. St. David's has been my church home since 1989, when then-Rector Jim Bethell baptised my children and introduced me and my family to the life of this wonderful parish.



During those 34 years I've participated in many different areas of the vibrant life of St. David's. I have been a teacher in children's and youth formation, and have been an adult sponsor for youth group, including leading youth pilgrimages and ski trips. I helped form and manage the St. David's jam band, Songfest, with my good friend Chef Ray Trono. I've served as a volunteer in Ray's kitchen, and in the homeless food ministry we hosted during the pandemic. I have played in bell choir, and have been a reader in Evening Prayer for many years, in person and online. I serve regularly as a lector in the 9 and 11:15 am services. I am a regular volunteer with the ramp project run by Chef Ray and Rex Hunt. With Melanie Moore I help facilitate the new Wednesday night Pickleball ministry in Eden's Gym. And I have been the unofficial parish photographer for many years.

In 2003 I served a term on the vestry with our new Rector David Boyd. After nearly 20 years I feel I'm ready to serve again on vestry, to support the life and mission of St. David's. St. David's has blessed me in so many ways I only hope to give back some of that blessing with service on the vestry.

JOE SANCHEZ

My name is Joe Sanchez, and I am a candidate for the Vestry. My husband and I have been active members of the Parish since 2013. In my time at St. David's, I have participated in Open Table, Altar Guild, the Hispanic Outreach Ministry and Education (HOMiEs), Foyers, and the Arbor Terrace Supper Club. I also currently serve as a Eucharistic Minister and have previously served as an usher. One of my most rewarding experiences was assisting a group of parishioners who traveled to Brownsville and Matamoros to assist those seeking asylum. Professionally, I am currently the Director of Assisted Living at Westminster. My work



in this position has given me experience working with budgets, working with families in transition, and experiencing the unique gifts of a special segment of the population. In my community, I have numerous years of experience assisting various fundraising organizations in the Queer Community, raising money to support those living with HIV/AIDS. I feel called to serve on the Vestry because I feel it is a gift of service of my faith to the Parish. St. David's is my home where I feel both welcomed and affirmed in who I am as a Queer Person of Color; that combination is hard to find in a faith community.

GEORGE ZWICKER

My name is George H Zwicker and I'm submitting my nomination for the two-year term for Vestry. I regularly attend church services, the Sunday 10 o'clock education hour, and currently the Soul of Aging Seminar

led by Dr Mona West, and monthly Men's Group Dinners.

I have chaired both the Stewardship Committee and Men's Dinner Group Committee. I'm a past member of the Finance Committee and a current member of the Building Committee. I've served on the first Capital Campaign Committee and cochaired the recent second phase of the Capital Campaign Committee. I have served on the Cold Weather Shelter ministry and delivered flowers as a member of the Flower Guild. I have been a greeter as well. I currently serve on the Diocesan Commission of Ministry and have facilitated or been a member of several Regional Discernment Committees for Holy Orders.



I retired from office furniture sales, sales management and general management. I have a BA in History from Sam Houston State University. At the Episcopal Church of the Epiphany, Houston, I served as operations manager, vestry member, junior warden, senior warden and Diocesan Council delegate. 
